## INDEPENDENT AUDITORS' REPORT

To the Trustees of and Participants in the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of VA Claims Pros, LLC Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended January 1, 2023 to June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2023 and December 31, 2022 and for the period January 1, 2023 to June 30, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**1. DESCRIPTION OF PLAN**

The following description of the VA Claims Pros, LLC Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the official Plan document for complete information.

**General**

Effective January 1, 2021, VA Claims Pros, LLC (the Company or Plan Sponsor) established the Plan. The Plan is a defined contribution plan covering substantially all employees of the Company except for union employees, nonresident alien employees, or leased employees, as defined, and all non-Puerto Rico residents, are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Termination**

In 2022, the governing body of the Plan approved the termination of the Plan effective December 31, 2022. As a result of the termination, Plan participants became 100% vested in Plan assets. There were no employee contributions or Company contributions made for the period January 1, 2023 to June 30, 2023.

In June 2023, the Plan received a letter from the Government of Puerto Rico approving the termination of the Plan in accordance with the Puerto Rico Internal Revenue Code (IRC) of 2011, as amended. The Plan began distributing participant balances in early 2023.

The following key provisions are reflective prior to the Plan termination.

**Eligibility and Participant Contributions**

Employees of the Company are eligible for participation in the Plan if they have attained age 18 and have completed three months of service, as defined. Participants may enter the Plan the first day of the month coinciding with or next following the date the eligibility requirements are satisfied. Participants may direct their contributions as well as their allocable Company contributions into any investment option offered by the Plan.

Participants may elect to defer up to 100% of compensation, before taxes, subject to certain IRC limitations. An employee may terminate his or her election to participate at any time. Participants may also elect to make supplemental catch-up contributions, subject to IRC limitations. Employees may roll over into the Plan amounts that represent a “qualified total distribution” or a complete distribution from an individual retirement account or individual retirement annuity, as defined by the IRC and the Plan.

The Plan also includes an automatic deferral feature. In the event a participant does not elect an alternative salary reduction rate or elects not to defer under the Plan, the Company will automatically withhold 3% of the participant’s eligible compensation and increase 1% to a maximum of 6%. The increase in the amount automatically withheld from a participant’s pay will be effective on the first day of the Plan Year, beginning with the first Plan year following the date deferrals were first automatically withheld from the participant’s pay.

**1. DESCRIPTION OF PLAN – CONTINUED**

**Company Contributions**

Based upon plan termination, all safe harbor matching contributions were ceased.

The Company may also make a discretionary profit-sharing contribution to the Plan. The contribution will be allocated in the ratio of the eligible participant's compensation for the allocation period bears to the total compensation of all participants eligible to receive an allocation for the allocation period. For the period January 1, 2023 to June 30, 2023, there were no discretionary contributions made to the Plan.

**Participant Accounts**

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, allocation of the Company's contributions and Plan earnings and is charged with withdrawals, recordkeeping fees and administrative fees and an allocation of Plan losses. Allocations are based on participant earnings (losses) or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants will be 100% vested in the Company's safe harbor contributions after two years of service and will be 100% vested in the Company's discretionary profit-sharing contributions ratably at 20% per year with full vesting after six years of service. Upon attainment of normal retirement age, as defined, death or disability, the participants will become 100% vested in their accounts.

**Withdrawals and Distributions**

Generally, a participant's vested account balance is payable by lump-sum distribution, between ages 59½ and 72, upon his or her retirement or disability. Upon termination of employment, the vested portion of the participant's account may be withdrawn in a lump sum or left in the Plan. If the vested amount is \$5,000 or less, a lump-sum distribution is required.

**Plan Administration**

The Plan is administered by the Company. Empower Annuity Insurance Company of America and Empower Trust Company, LLC. (collectively the custodians) are custodians of the Plan.

**Forfeitures**

The Plan will use forfeitures to reduce future Company contributions. For the period January 1, 2023 to June 30, 2023 and December 31, 2022, forfeited balances were approximately \$0 and \$7,215, respectively. In 2023, approximately \$6,400 in forfeitures were used to reduce Plan expenses.

**Administrative Expenses**

The Company pays substantially all administrative costs of the Plan, except for recordkeeping fees and various fees associated with recordkeeping and investment advisor fees which are paid by the Plan.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the liquidation basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan's investments include mutual funds and a fixed annuity contract as of December 31, 2022. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fixed annuity contract which is valued at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

**Payment of Benefits**

Benefits are recorded when paid.

**3. FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2022:

*Mutual Funds:* Mutual funds are valued based upon quoted market prices.

As of December 31, 2022, the Plan’s investments at fair value represent investments in mutual funds.

**4. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2021, the Plan entered into an investment contract with Great-West Life & Annuity Insurance Company (Great West). Under this contract, Great-West maintains the contributions in a general account. The accounts are credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Great-West announces in advance the prevailing interest rates it will credit to participant account balances. When establishing interest crediting rates, Great-West considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. The rates are established without use of a specific formula. These rates are reviewed on a semiannual basis for resetting.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value paid overtime. There are no events that allow the issuer to terminate the contract and which require the Company to settle at an amount different than contract value paid either within 90 days or over time.

**5. INFORMATION CERTIFIED BY PLAN CUSTODIANS**

Certain information related to investments disclosed in the accompanying financial statements, including investments at June 30, 2023 and December 31, 2022 and net appreciation in fair value of investments, interest and dividends for the period January 1, 2023 to June 30, 2023, was obtained by management and agreed to, or derived from information certified as complete and accurate by the custodians.

**6. PARTY-IN-INTEREST TRANSACTIONS**

For the period January 1, 2023 to June 30, 2023, certain fees to administer the Plan have been paid to custodians, the recordkeeper for the Plan; and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to investment advisory as well as recordkeeping fees were approximately \$11,000. These fees also qualify as an exempt party-in-interest transactions.

**7. PLAN TERMINATION**

As described in Note 1, the Plan was terminated on December 31, 2022 and Plan participants became 100% vested in their accounts.

**8. TAX STATUS**

The Plan has received a determination letter from the Treasury dated April 8, 2022, stating that the Plan is qualified under Section 1081.01 of the Puerto Rico IRC; and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Puerto Rico IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Puerto Rico IRC; and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions. The Plan is not currently being audited by any taxing jurisdictions.

**9. SUBSEQUENT EVENT**

Management has evaluated subsequent events through February 19, 2024, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under the subsequent events topic of FASB ASC 855, *Subsequent Events*.
