As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 1, 2022 and December 31, 2021, and for the period from January 1, 2022 through December 1, 2022, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kanawha HR LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 4 to the financial statements, Trustees of the Kanawha HR LLC 401(k) Profit Sharing Plan amended the Plan's governing documents to merge the Plan into the American Equipment HR, LLC 401(k) Plan effective December 1, 2022. All plan assets were transferred to the control of American Equipment HR, LLC 401(k) Plan on December 1, 2022. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kanawha HR LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Kanawha HR LLC 401(k) Profit Sharing Plan (formerly Kanawha Scales & Systems, Inc. 401(k) Profit Sharing Plan) (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established effective December 31, 1976, as restated January 1, 2016, and amended as of March 7, 2022, to change the name of the Plan from Kanawha Scales & Systems, Inc. 401(k) Profit Sharing Plan to Kanawha HR LLC 401(k) Profit Sharing Plan, and amended again effective December 1, 2022, to merge the Plan with the American Equipment HR, LLC 401(k) Plan effective on December 1, 2022 (Note 4). The Plan covered all employees, excluding part-time, temporary, union members, and seasonal employees, of Kanawha HR LLC (formerly Kanawha Scales & Systems, Inc.) (the Company) who had completed six months and 500 hours of service and were age 21 or older. The Plan required a participant to be employed as of year end to be eligible to receive employer contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The 401(k) Committee was responsible for oversight of the Plan. The Plan's management under the direction of the plan administrator determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's 401(k) Committee.

Contributions

Each year, participants could contribute up to 25% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also could designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. Additional profit sharing amounts could have been contributed at the option of the 401(k) committee. For the period from January 1, 2022 through December 1, 2022, there were no profit sharing contributions to the Plan. Additional discretionary amounts could have been contributed by the Company at the option of the 401(k) committee. For the period from January 1, 2022, through December 1, 2022, the Company approved a matching contribution equal to 25% of an employee's deferral as a discretionary contribution to the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 20% vested after two years of credited service and continued to vest in increments of 20% until 100% vested after six years of credited service. The Plan's participants became fully vested in the Company's contribution portion of their accounts effective with the Plan's merger into the American Equipment HR, LLC 401(k) Plan.

Notes Receivable From Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined annually, was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through monthly payroll deductions. Terms ranged up to five years or greater for the purchase of a primary residence.

Payment of Benefits

Upon retirement, death, disability or other termination of employment, as defined in the plan document, participants or their spouses and/or beneficiaries could elect to receive their account under one of the various annuity or installment payout options permitted by the Plan or as a lump sum cash payment. Further, upon termination of employment, the participant could elect to transfer his or her account balances to another qualified plan or individual retirement account. A participant who had not separated from employment was not allowed to withdraw amounts from his or her 401(k) account prior to attaining age 59½. The Plan required mandatory distributions of amounts for terminated participants with account balances less than \$1,000 in the form of a lump-sum payment.

The payment of benefits under the Plan to participants was to begin as soon as administratively practical after (1) the participant attained age 65, or (2) the participant terminated his service with the employer. Participants could elect early retirement when the participant attained age 62 and had completed five years of service.

Forfeited Accounts

At December 1, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$296, respectively. These accounts would be used to reduce future employer contributions or to pay plan administrative expenses. During 2022, employer contributions were reduced by \$14,756, from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments as of December 31, 2021, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management under the direction of the plan administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the financial reporting period.

Notes Receivable From Participants

Notes receivable from participants as of December 31, 2021, were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees was recorded as administrative expenses and was expensed as incurred.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2021.

Pooled separate accounts: The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Restrictions may be imposed at the request of the fund company of an underlying fund as outlined in their prospectus.

Included in the pooled separate accounts, is a stable value fund which represents participation units of a collective investment trust for which the net asset value is based on the market value of the underlying investments. The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the collective trust.

The underlying securities in other pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted net asset value under agreements with the insurance company.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the net asset value of the pooled separate accounts and, consequently, the fair value of the Plan's investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date

4. Transfers Out of the Plan

Effective December 1, 2022, the Plan was merged with the American Equipment HR, LLC 401(k) Plan (American Equipment Plan). As a result, control of the Plan's assets was transferred to the management of the American Equipment Plan. Net assets of \$16,339,448 were transferred to the American Equipment Plan's custodian, The Standard, on December 21, 2022. The amount of this transfer is included in the Plan's statement of changes in net assets available for benefits. The merger did not impact participant benefits as the Plan's benefit provisions were incorporated in the American Equipment Plan.

5. Related-Party and Party in Interest Transactions

Certain plan investments were managed by the Custodian, and therefore, these transactions qualified as party in interest transactions.

Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

6. Tax Status

The Plan adopted a volume submitter plan offered by John Hancock Life Insurance Company. The volume submitter plan received an IRS Opinion Letter dated March 31, 2014, that the Plan and related trust were designed in accordance with the applicable sections of the IRC. Although the Plan had been amended since receiving the IRS Opinion Letter, the plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC through December 1, 2022, and, therefore believed that the Plan was qualified, and the related trust was tax exempt through December 1, 2022.

Plan management was required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress through December 1, 2022.

7. Information Certified by Custodian

The plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the period January 1 through December 1, 2022 and for the year ended December 31, 2021. Accordingly, John Hancock Life Insurance Company (U.S.A.), the Custodian of the Plan, certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2021, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2022, through December 1, 2022.


