Note 1 - Description of the Plan

General

The Plan was a defined contribution plan that was established on March 1, 1984 by Beene Garter LLP. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

Plan Termination

Effective December 30, 2022, a resolution to terminate the Plan was adopted. As a result of the Plan's termination, all participants balances were distributed in full between January 1, 2023 and May 31, 2023.

Administration

The Plan Sponsor and named Administrator is Shamrock Leasing LLP, formerly known as Beene Garter LLP (the "Company" and "Employer"). The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed an Administrative Committee made up of Company officers and management. The Administrative Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees. The Plan's Trustees are officers of the Plan Sponsor and the Plan's Investment Custodian is Nationwide Trust Company, FSB ("Nationwide"). The Investment Custodian held all of the Plan's assets and executes all of the Plan's transactions. The Company has also retained Nationwide to provide participant recordkeeping and administration services.

Eligibility

The Plan covered all employees of the Employer who attained age 21 and completed six consecutive months of service with at least 500 hours worked. The Plan excluded those employees who are nonresident aliens, leased employees and union employees subjected to a collective bargaining agreement. All eligible employees were able to begin participating in the Plan with the entry date on the first day of the Plan year or the first day of the seventh month of the Plan year coincident with or immediately following completion of eligibility requirements.

Contributions to the Plan

Each year, participants were able to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan document, through payroll withholdings. The Plan also allowed participants to make after-tax Roth contributions. Participants who attained age 50 before the end of the year were eligible to make 'catch-up' contributions.

Participants were also able to contribute amounts representing distributions from other defined benefit or defined contribution plans (rollovers).

The Plan allowed for discretionary employer nonelective contributions. Discretionary employer contributions of \$175,183 were made for the plan year ended May 31, 2023.

Participants were able to direct the investment of their individual contributions into various investment options offered by the Plan.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and employer contributions as well as Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance, subject to certain Department of Labor and IRS requirements. The loans were secured by the balance in the participant's account. The loan interest rate was set at the prime rate plus 1%, as defined in the plan document. Principal and interest is paid ratably through payroll deductions each pay period.

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of May 31, 2023 and 2022. If a participant ceased to make repayments on a note receivable and the Plan Administrator deemed the note receivable to be uncollectible, the balance on the note receivable from the participant was reclassified to benefits paid to participants.

Upon Plan termination, outstanding loans were either distributed or rolled over to a new Plan or paid in full prior to the termination of the Plan.

Note 1 - Description of the Plan (Continued)

Distribution of Benefits

On termination of service, participants were able to elect to receive a lump sum distribution or a rollover of their account balance to another qualified account. Those participants whose account balances exceed \$5,000 may also elect to defer the distribution of their plan balance. Participants who elected to have their benefit payments deferred continue to share in allocations of investment income and losses. Special rules apply to distributions due to death, disability, and retirement. Participants should refer to the full plan document for details.

On termination of service, participants with account balances of \$5,000 or less had their account balance automatically rolled over into an individual retirement plan determined by the Company unless the participant affirmatively elected otherwise.

The Plan allowed for in-service distributions upon attainment of age 59 1/2.

Vesting and Forfeitures

Participants were immediately 100% vested in their account balances upon entry into the Plan. As a result, there were no forfeitures.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting. Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Fees and Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Investment related expenses were included in net depreciation in the fair value of investments.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 27, 2024, which is the date the financial statements were available to be issued.

Note 3 - Unaudited Investment Information Certified by the Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Nationwide Trust Company, FSB as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for benefits as of May 31, 2023 and 2022;
2. All investment activity reflected in the statement of changes in net assets available for benefits for the year ended May 31, 2023;

Participant notes receivable and related income are not covered by the certification provided by Nationwide.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used as of May 31, 2023 and 2022.

Mutual Funds: Valued at daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Party-in-Interest Transactions

Certain plan investments are managed by Nationwide, who is the Plan's Investment Custodian. During the year ended May 31, 2023, the Plan paid direct compensation to the Investment Custodian for services rendered. Indirect compensation (that is netted against net depreciation in fair value of investments on the statement of changes in net assets available for benefits) is paid to the Investment Custodian from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions involving these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Note 6 - Plan Amendment and Tax Status

The Plan is utilizing a non-standardized pre-approved plan, which has been filed with the IRS and has received a favorable opinion letter dated April 29, 2022 from the IRS. The Plan Sponsor believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and that the related trust is tax-exempt as of May 31, 2023.

The Plan document was restated in its entirety effective June 1, 2022 pursuant to the IRS Cycle 3 requirement for pre-approved employee benefit plans. In December 2022, both the SECURE ACT and the CARES ACT provisions were formally adopted. Effective December 30, 2022, a resolution to terminate the Plan was adopted.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
