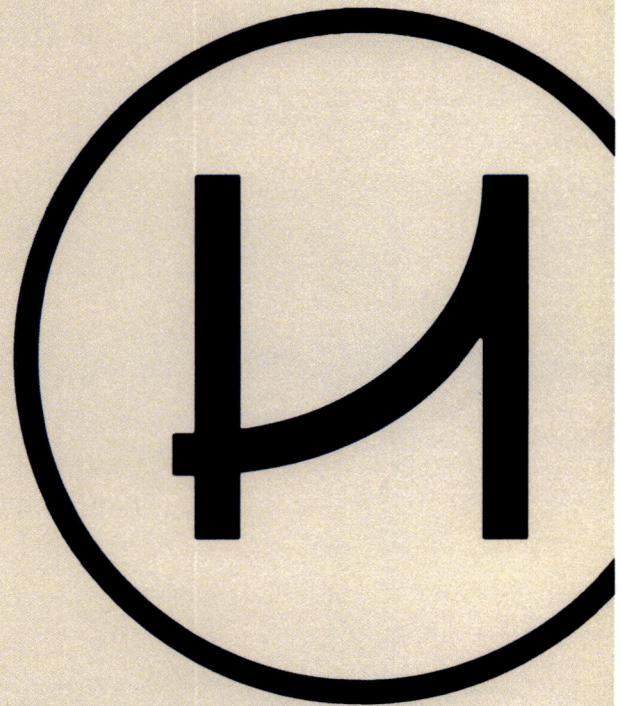

INDEPENDENT AUDITORS' REPORT

Opinion

We have audited the financial statements of Dickinson Frozen Foods, Inc. Employees' 401k PSP, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets in liquidation as of May 01, 2023, and the related statement of changes in net assets in liquidation for the period ended May 01, 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets in liquidation of Dickinson Frozen Foods, Inc. Employees' 401k PSP as of May 01, 2023, and the changes in net assets in liquidation for the period then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2023 Financial Statements section of our report. We are required to be independent of Dickinson Frozen Foods, Inc. Employees' 401k PSP and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the 2023 financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

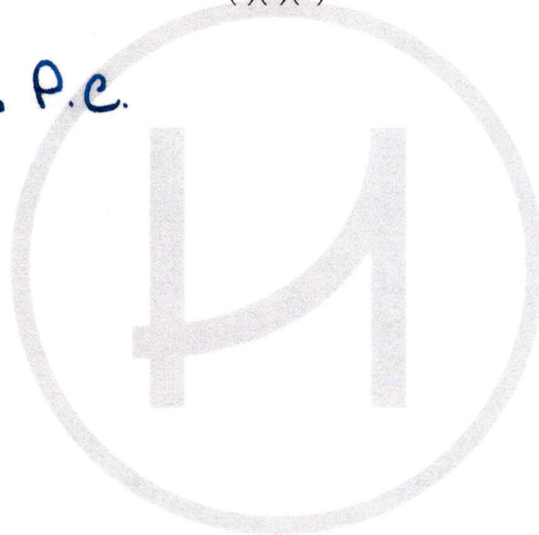


Other Matter – Auditor’s Report on the 2022 Financial Statements

Note A – Description of Plan

The following description of Dickinson Frozen Foods, Inc. Employees' 401k Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Prior to termination (Note E), the plan was a defined contribution plan that covered all full-time employees of Dickinson Frozen Foods, Inc. (the Company) who had completed 1 year of service and were age 18 or older. It was subject to the provisions of the Employee Retirement Income Security Act (ERISA). Employee deferrals and the employer match contributions were for covered employees under the plan. Employees who had completed 1 year of service and a minimum of 1,000 hours were eligible for the employer discretionary contribution.

Plan Amendments

The Plan has adopted the standard provisions of the Secure 2.0 Act that are effective for plan years beginning after December 29, 2022. The adoption of these provisions did not have any effect on the amount of net assets in liquidation as of and for the period ended May 01, 2023.

Contributions

Participants could elect to defer up to the maximum allowable under the Internal Revenue Code of eligible compensation and contribute these amounts to the Plan. In addition, participants over age 50 before the close of the calendar year were eligible to defer an additional catch-up contribution. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds as investment options for participants. The Company, at its sole discretion, could make a profit sharing contribution to the Plan on the behalf of participants. Participants were eligible to receive profit sharing contributions if they had completed at least 1,000 hours of service during the Plan year and were employed by the Company on the last day of the Plan year. Profit sharing contributions were allocated to participant accounts on a pro rata basis. No profit sharing contributions were made for the four months ended May 01, 2023.

Vesting

Prior to termination, participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution of their accounts was based on years of continuous service. A participant was 100 percent vested after three years of credited service.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest. Participants were limited to one outstanding loan in accordance with the Plan document. The loans were secured by the balance in the participant's account and bore interest rates between 3.25% and 7.00%, which was commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest was paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, termination of employment or retirement, a participant could elect to receive either a lump-sum benefit payment equal to the value of the participant's vested interest in their account or installments. For termination of service for other reasons, a participant could receive the value of the vested interest their account as a lump-sum distribution.

Administrative Expenses

All expenses of maintaining the Plan were paid by the Plan and the Plan sponsor.

Forfeited Accounts

Forfeitures may be used to reduce future employer contributions or pay plan administrative expenses. There were no forfeited account balances or forfeited amounts used for the four months ended May 01, 2023.

Note B – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Capital gain distributions are included in the dividend income. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through March 7, 2024, which is the date the financial statements were available to be issued.

Note C – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets in liquidation. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's investments are held in pooled separate account funds.

All pooled separate accounts are valued based on the unit values to perform daily account valuation. The unit value is John Hancock Life Insurance Company's method for valuing accounts and is not the same as the net asset value report by the fund house, although the financial trend should be the same. After the close of the stock market, John Hancock receives a daily price from each fund house.

John Hancock Life Insurance Company, the Trustee of the Plan, has certified the completeness and accuracy of the investment balances presented on the schedule of assets in liquidation as of December 31, 2022.

The figure includes the NAV and any dividends and capital gains declared. These inputs are used to arrive at the unit value of the investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All investments held by the Plan as of May 01, 2023 and December 31, 2022 were valued at net asset value, which is excluded from the ASC 820 Fair Value Hierarchy. As of May 01, 2023 and December 31, 2022, the Plan's total investments measured at NAV was \$0 and \$1,433,923, respectively.

Note D – Related Party Transactions

The Plan invests in shares of mutual funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company acts as trustee for those investments as defined in the plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. During 2023 and 2022 fees paid to John Hancock Life Insurance Company were \$7,056 and \$24,866, respectively. AmeriBen Solutions is the third party administrator of the Plan and qualifies as a party-in-interest. Fees paid to AmeriBen Solutions totaled \$743 and \$3,433 during 2023 and 2022, respectively.

Note E – Plan Termination

In December 2022, the plan sponsor announced the decision to terminate the plan and distribute the Plan assets as soon as administratively feasible. Upon termination, all participants became 100% vested in their account balances. Participants had the right to receive either a lump-sum distribution or roll over their account balance into another qualified plan. All Plan assets were distributed by May 1, 2023, and all remaining net assets in liquidation were rolled over into another qualified plan.

Note F – Income Tax Status

The Plan was intended to be a qualified plan under Section 401(a) of the Internal Revenue Code, and the Plan was interpreted, applied and administered consistent with the intent to qualify. The Plan was established through a prototype plan of AmeriBen/IEC Group., who had received a letter from the Internal Revenue Service indicating the Plan is acceptable. The Plan has been subsequently amended, however, the Plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of May 01, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
