

1. DESCRIPTION OF PLAN:

The following description of the KTM Industries 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees, as defined, of KTM Industries (the Company and Employer) who have three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustee is responsible for oversight of the Plan.

In August 2022, the Employer was acquired by TemperPack Technologies, Inc. Effective December 1, 2022, a plan amendment was executed to terminate the Plan (see Note 5). The following provisions were in effect prior to the Plan's termination:

Contributions

Each year, participants may contribute up to 92% of pretax annual compensation, as defined in the Plan. Additionally, participants may make Roth contributions up to 92% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes safe harbor matching contributions of 100% of the first 3% of eligible compensation, and 50% of the eligible compensation in excess of 3%, not to exceed 5% of compensation. The Plan also provides for discretionary profit sharing contributions which is determined annually by the Company's board of directors and is allocated to participants who have attained one year of credited service, as defined. During the five months ended May 31, 2023 (in liquidation) and year ended December 31, 2022 (in liquidation), the Company did not elect to make a profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Employer's profit sharing contributions is based on years of continuous service and a participant is 100% vested after six years of credited service (see Note 5)

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined as defined in the Plan document. Principal and interest are paid ratably through weekly payroll deductions.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as defined in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. At age 59 1/2, participants are permitted to take in-service distributions.

Forfeited accounts

Forfeited non-used accounts may be used to pay Plan administrative expenses, restore participant accounts or reduce Employer contributions. At May 31, 2023 (in liquidation) and December 31, 2022 (in liquidation), there were no forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

As a result of the decision to terminate the Plan (See Note 1), the Plan changed its basis of accounting from the ongoing basis of accounting to the liquidation basis of accounting in 2022 and continued using the liquidation basis of accounting in 2023.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 31, 2023 (in liquidation) or December 31, 2022 (in liquidation).

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants or other participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through March 13, 2024, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Interest bearing cash: Cost approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022 (in liquidation). Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

4. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

The Plan Sponsor pays directly any other fees related to the plan's operations.

5. PLAN TERMINATION:

The Company elected to terminate the Plan effective December 1, 2022. As of the effective date of the termination, participants became fully vested in their account and no additional benefits are provided by the Plan.

Assets of the Plan were distributed to participants by May 31, 2023.

6. TAX STATUS:

The Company adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the IRS dated August 31, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
