Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of Haggard Electrical Contractors, Inc. 401(k) Profit Sharing Plan and Trust (“the Plan”) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan and trust covering substantially all employees of Haggard Electrical Contractors, Inc. (the plan sponsor) who have six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Custodian and Administration of the Plan - The administrator of the Plan is the Plan sponsor.

Reliance Trust (the custodian) held the assets of the Plan and acted as the custodian. Pentegra Services, Inc. is the trustee and record-keeper for the Plan. The custodian holds all assets of the Plan in accordance with the provisions of the service provider contract with the plan sponsor.

Contributions - Each year, participants may elect to contribute a portion of their eligible compensation up to the maximum amounts and percentages not to exceed the limits established by the Internal Revenue Code (IRC), either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 26 mutual funds and a self-directed brokerage account.

Employer matching contributions will take into account elective deferrals up to 6% of compensation with a maximum discretionary matching contribution of 4% of the participant’s annual compensation. The employer matching contribution is made annually.

Participant Accounts - Each participant's account is credited with the participant's elective deferral and allocations of (a) employer contributions and, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in the portion of their accounts attributable to the elective deferrals, including catch-up contributions and rollover contributions. Vesting in the plan sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, 20% each year for years two through six.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at 4.25%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through weekly payroll deductions. The Coronavirus Aid, Relief and Economic Security (CARES) Act adjusted 401(k) loan limits up to \$100,000 or 100% of the participant's vested account balance, whichever is lower, for loans issued between March 27, 2020 and September 22, 2020.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits - Upon termination of employment, participants with vested account balances in excess of \$5,000 may elect to receive a distribution of the vested portion of the account balance in a lump sum distribution or other distribution elected. If the vested account balance exceeds \$5,000, no distribution will be made from the Plan without the participant's consent. Participants with vested account balances of \$5,000 or less may elect to receive a distribution in cash or elect to rollover the distribution to an IRA or to another qualified plan. If the total vested account balance is between \$1,000 and \$5,000 as of the distribution date and the participant does not consent to a distribution, the vested benefit automatically will be rolled over to an IRA selected by the plan administrator. Participants with vested account balances of \$1,000 or less will receive a distribution in a lump sum, even if they do not consent to a distribution. If the participant dies, the employers' match is vested 100% and the account balance will be paid to the designated beneficiary or beneficiaries.

Forfeitures - If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures are allocated as follows: 1) Forfeitures may first be used to pay any administrative expenses; 2) any remaining forfeitures will be used to reduce any matching contribution. As of December 31, 2022, forfeited non-vested accounts totaled \$2.

Administration Expenses - The plan sponsor and the participants share in maintenance fees. All other costs of administering the Plan are paid by the plan sponsor. The Plan will pay some or all Plan related expenses except for a limited category of expenses which the law requires the plan sponsor to pay. The category of expenses which the plan sponsor must pay is known as "settlor expenses." Generally, settlor expenses relate to the design, establishment or termination of the Plan. The expenses charged to the Plan may be charged pro rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant. In addition, some types of expenses may be charged only to some participants based upon their use of a plan feature or receipt of a plan distribution. Finally, the Plan may charge expenses in a different manner as to participants who have terminated employment with the plan sponsor versus those participants who remain employed with the plan sponsor. During 2022 administrative expenses paid by the Plan totaled \$10,306. Plan administrative expenses paid by the plan sponsor totaled approximately \$29,000 in 2022. These expenses will not be reimbursed by the Plan.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates and assumptions.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit Payments - Benefits paid to participants and beneficiaries are recorded when paid.

Significant concentration of credit risk - The Plan maintains cash balances with various financial institutions that may at times exceed insured limits.

NOTE 3. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 2 or Level 3 inputs for the Plan in 2022.

Level 1 Fair Value Measurements - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

NOTE 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. The plan administrator will facilitate distribution of account balances in single lump sum payments in accordance with Plan provisions.

NOTE 5. TAX STATUS

The IRS has determined and informed the plan sponsor by letter dated January 1, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the IRS determination letter, the plan administrator and the plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
