Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Marine Bank, ETAL Employees' 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 31, 2023 (liquidation basis) and December 31, 2022 (ongoing basis), and the related statement of changes in net assets available for benefits (liquidation basis) for the period from January 1, 2023 to October 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (a qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2023 and December 31, 2022, and for the period from January 1, 2023 to October 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan was terminated effective June 8, 2023. As a result of this amendment, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis as of that date. In addition, all assets of the Plan were distributed by October 31, 2023 and, therefore, the Plan ceased to exist as of that date. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. 1. Description of Plan

The following description of the Marine Bank, ETAL Employees' 401(k) Profit Sharing Plan & Trust (the "Plan") is provided for general purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all employees of Marine Bank and its affiliates (the collective "Employer"). Participating employers included Prairie Land Title Company, Inc., Richardson Bancservices, Inc., Richardson Group, and Red Door Title, LLC. An employee was eligible to make salary deferrals to the Plan upon attainment of 18 years of age and completion of six months of service. An employee was eligible to receive all applicable Employer contributions upon attainment of 18 years of age and completion of one year of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was terminated effective June 8, 2023. As a result of this amendment, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis as of that date. In addition, all assets of the Plan were distributed by October 31, 2023 and, therefore, the Plan ceased to exist as of that date.

Contributions

Each year, eligible employees could elect to contribute on a pre-tax basis up to 100% of eligible compensation, as defined in the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. There was an annual limit as to the amount that can be deducted from the compensation that is determined by the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

The Employer made an employer matching contribution for eligible participants equal to 7.5% of the participant's elective deferrals. The Employer also made a safe harbor contribution for eligible participants equal to 3% of the participant's eligible compensation. The Employer could also make a discretionary profit sharing contribution to the Plan. Eligible employees who were employed on the last day of the Plan year were eligible for any discretionary contribution. The Plan allowed the Employer to annually determine a discretionary amount that was not limited to its current or accumulated net profit. For the 2023 plan year, no discretionary contribution was made to the Plan.

Vesting

A participant was 100% vested in their accounts including allocated earnings thereon at all times.

1. Description of Plan (continued)

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Employer's contributions and (b) Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. All investments were participant directed.

Payment of Benefits

Retiring participants, participants leaving the employment of the Employer due to disabling illness or injury and participants whose employment was terminated prior to retirement, or death received the balance in their individual account in a lump-sum payout, IRA rollover, or conversion to another qualified plan. In the event a participant's accounts have never exceeded \$5,000, the balance shall be automatically distributed in a lump sum. Upon death, a participant's account was paid in a lump sum to the designated beneficiary. Under certain circumstances, participants could request and receive a hardship distribution.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Employer and were excluded from these financial statements. Also, certain administrative expenses of the Plan were paid by the Plan. Investment related expenses were included in net appreciation in fair value of investments.

As a result of the Plan termination (see Note 1), the Plan changed its basis of accounting from the ongoing basis to the liquidation basis. The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan followed U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2022, all of the Plan's investments were valued using level 1 inputs. As a result of the distributions of all Plan assets, no investments were held by the Plan as of October 31, 2023.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. The mutual funds and money market fund were valued at the daily closing price as reported by the fund. The mutual funds and money market fund held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds and money market fund held by the Plan were deemed to be actively traded.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the plan year.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is March 4, 2024.

3. Information Certified (Unaudited)

Certain information related to investments from participants disclosed in the accompanying financial statements, including investments held at December 31, 2022, and net appreciation in fair value of investments and interest and dividends for the period from January 1, 2023 to October 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. Tax Status

The Plan was formed using a prototype plan which the Internal Revenue Service ("IRS") has determined and informed the applicant by letter dated June 30, 2020 that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan was terminated after receiving the letter. Plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
