1. DESCRIPTION OF PLAN

The following description of the Moulton Logistics Management 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established for the purpose of providing eligible employees of Moulton Logistics Management Inc., (the “Company”) and their beneficiaries, funds for retirement. The Plan administrator is responsible for the oversight of the Plan.

Eligibility

Employees of the Company, other than leased employees, who have completed one year of service and are aged twenty-one or older are eligible to participate in the Plan.

Contributions

Participants may elect to contribute up to 86% of pretax annual compensation, as defined in the Plan, up to a maximum contribution per employee allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants may also contribute amounts to the Plan on an after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may make a discretionary profit-sharing contribution to the Plan. To be eligible for the discretionary profit-sharing contribution, an employee must be twenty-one or older, completed at least one year and 1000 hours of service and must be employed as of the last day of the Plan year. The Company did not make a discretionary profit-sharing contribution during 2020.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution, (b) Plan earnings or losses, and (c) administrative expenses. Allocations are based on participant account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant’s account.

Investment Options

Participants direct the investment of their contributions into various investment options as offered and determined by the plan administrator, which are more fully described in the Plan literature. Plan management determines funds to be included in the Plan’s investment portfolio and monitors its investment performance.

Vesting

Participants are immediately vested in their voluntary contributions, including rollover contributions plus actual earnings thereon. Vesting in the Company’s discretionary profit-sharing contributions is based on years of continuous service. A participant is 20% vested after two years of service and vests an additional 20% per year of service until they are 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their account an amount up to the lesser of \$50,000 or 50% of their vested account balance, subject to a minimum of \$1,000. Loans must be repaid over a period not to extend five years unless the loan proceeds are used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates as determined monthly by the plan administrator. Interest rates ranged from 4.25% to 6.50% at December 31, 2020. Principal and interest is repaid ratably through bi-weekly payroll deductions.

Participant loans are recorded at their unpaid principal balance plus accrued interest.

Payment of Benefits

Upon retirement, termination, death, disability or attainment of age 59 1/2, vested plan benefits are allowed to be distributed to a participant in a lump-sum.

In addition, the Plan provides for participant withdrawals in the event of serious financial hardship. Upon qualification, a participant is entitled to the distribution equal to the amount of accumulated deferrals and the vested portion of the Company's discretionary profit-sharing contributions, determined as of the valuation date, which is payable immediately in a lump-sum distribution.

If at the time of termination, a participant's vested account balance is \$5,000 or less, the Plan administrator is allowed to distribute the vested account balance to the participant without their consent. The vested account balance is rolled over to an Individual Retirement Account established by the Plan administrator.

Forfeitures

Forfeitures of terminated participants' nonvested accounts are retained in the Plan and used to reinstate previously forfeited account balances, reduce future employer discretionary profit-sharing contributions or to pay for future Plan expenses. During the year ended 2020, no forfeited account balances were used to pay Plan expenses or reduce employer discretionary profit-sharing contributions. At December 31, 2020 and 2019, there were no forfeited non-vested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value based on closing market quoted prices at year-end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments represents both realized and unrealized gains and losses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make note repayments and the Plan administrator determines the loan is in default, the participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2020 and 2019.

Administrative Expenses

Certain administrative expenses incurred in the operation of the Plan are paid by the Company and are not reflected in the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses also include certain investment management fees. Other investment related expenses are included in net appreciation of fair value of investments and are not readily determinable.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

On February 28, 2021, all assets of the Plan were merged into the Amware Fulfillment LLC ("the Acquirer") retirement plan and the Plan was effectively terminated. The merger and plan termination had not yet been completed as of December 31, 2020.

Management has evaluated the activity of the Plan through February 14, 2024, the date the financial statements were available to be issued. Based upon this evaluation, management has determined no other subsequent events have occurred which require adjustment to or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value that utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted market prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan has no assets or liabilities valued using level two inputs as of December 31, 2020 and 2019.

Level 3 - Inputs to the valuation methodology are unobservable supported by little or no market activity and significant to the fair value measurement. Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The Plan has no assets or liabilities valued using level three inputs as of December 31, 2020 and 2019.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020 and 2019.

Mutual funds: Shares of mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

This valuation methodology may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. For the year ended December 31, 2020, the Plan's transactions with parties in interest were as follows:

Investments

The Plan's invested in shares of mutual funds managed by the Plan's trustee, Reliance Trust Company. A portion of the income or loss of the Plan was derived from these investments. Fees paid by the Plan to Reliance Trust Company for certain investment management fees were deducted from the net asset values of the funds held by the Plan.

Expenses

All administrative expenses were to be paid by the Plan unless paid by the plan sponsor. Also, certain employees of the Company, who were also plan participants, performed administrative services on behalf of the Plan at no cost to the Plan. The plan sponsor paid substantially all costs related to the administration of the Plan during the year ended December 31, 2020. Fees related to the administration of notes receivables for participants or to processing of distributions were charged directly to the participant accounts and were included in administrative expenses.

Notes Receivable from Participants

Notes receivable from participants were also party in interest transactions. These party in interest transactions were exempt from the prohibited transactions rules of ERISA.

5. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. During 2020, the Company was acquired by the Acquirer. On December 7, 2020, the Company resolved to merge the Plan into the Acquirer's retirement plan and terminate the Plan. As discussed in Note 2, on February 28, 2021, all assets of the Plan were merged into the Acquirer's retirement plan and the Plan was effectively terminated. The merger and plan termination had not yet been completed as of December 31, 2020.

6. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the sponsor of the prototype plan adopted by the Company, by a letter dated July 16, 2014, that the Plan and the related trust are designed in accordance with applicable sections of the IRC. Per Revenue Procedure 2005-16, a Company adopting such a plan may rely on the prototype plan's letter if the terms of the Plan are followed in operation. Although the Plan has been amended since the date of the IRS letter, the Plan administrator believes that the Plan is currently being operated in compliance with the qualified prototype plan. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt as of the date of the independent auditor's report and no provision for income taxes has been included in the Plan's financial statements.

Accounting standards require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2020 and 2019 there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. INFORMATION CERTIFIED BY THE PLAN TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from Reliance Trust Company, the trustee of the Plan, that all the information provided by them is complete and accurate. Information included in the accompanying financial statements as to investments administered by the trustee, net investment income, interest income on notes receivable, and all information in the supplementary schedule is presented in reliance solely upon such certifications.

8. RISKS AND UNCERTAINTIES

The Plan utilizes mutual fund investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
