1. DESCRIPTION OF PLAN

The following description of RNDC Shared Services, LLC Savings and Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan was a qualified defined contribution plan established on December 24, 1966. The Plan covered all employees of RNDC Shared Services, LLC formerly White Mountain Beverage, LLC (the Company) who were not in an ineligible class of employees, as defined in the Plan. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). The Company was also the plan sponsor and plan administrator.

Effective April 7, 2022, the Plan was amended and restated to comply with current regulations and to remain qualified as a tax-exempt entity Plan. General operating provisions of the Plan were not modified with respect to this amendment.

On December 30, 2021, the Company was purchased by Republic National Distribution Company (RNDC). Effective August 30, 2022, the Plan was amended to add RNDC Shared Services, LLC as a participating employer.

Effective January 9, 2023, the Plan was amended to change the name of the Plan to RNDC Shared Services, LLC Savings and Profit Sharing Plan.

Effective July 1, 2023, the Plan merged with and into the Republic National 401(k) Plan (RNDC Plan). All plan assets were transferred into the RNDC Plan effective June 30, 2023. After the transfer of assets to the RNDC Plan was complete, the Plan was terminated.

b. Eligibility

Employees were eligible to participate after six months of service and could elect to enter the Plan as a participant on the first day of the month which coincides with, or next follows, the date on which the employee satisfies the service requirement.

c. Contributions

Each year, participants could contribute up to 50% of their eligible compensation, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover).

Upon meeting the eligibility requirements, employees were automatically enrolled into the Plan at a pretax deferral rate of 6% of their gross compensation each pay period. The deferral percentage was automatically increased by 1% per year to a maximum of 10% unless changed by the participant. Employees could choose between pre-tax and Roth contributions in their elective deferrals. Employees could elect to opt-out of participating in the Plan.

c. Contributions, (Continued)

The Company could make a discretionary match in an amount that is determined by the Company. During 2023, the employer's discretionary matching contributions were \$0.70 for each \$1 contributed each pay period, up to a maximum of 10% of the participants' eligible compensation for that pay period.

The Company could also make non-elective employer contributions to the Plan. For 2023, no non-elective employer contributions were made.

Participants directed the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants could change their investment options as often as permitted under the investment vehicles they chose.

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

d. Participant accounts

Each participant's account was credited with the participant's contributions and the employer's matching contribution, and an allocation of plan earnings or losses, and charged with an allocation of administrative expenses. Allocations were based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

e. Vesting

Participants were immediately vested in their voluntary contributions plus actual earnings or losses thereon. Vesting in all matching contributions and non-elective employer contributions was based on years of service, as follows:

Upon death, disability, or reaching normal retirement age (age 65), participants became fully vested in all account balances.

f. Notes receivable from participants

Participants could borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less. Loan terms could be up to five years except loans used to purchase a primary residence could be for up to ten years. The loans bore interest at rates that ranged from 3.25% to 7.25%. Principal and interest were paid ratably through payroll deductions.

g. Payment of benefits

On termination of service, a participant could only receive a lump-sum amount equal to the value of the participant's account. Upon retirement, disability, termination or death, a participant or the stated beneficiary could elect distribution by payment in a lump sum.

If the participant's vested benefit was over \$5,000, then participant consent to the distribution was required before it was made. The participants could elect to receive a distribution either through a rollover or receive the distribution directly.

If the participant's vested benefit was under \$5,000 but over \$1,000, then the distribution was made, either as a lump sum or as a direct rollover, as soon as administratively practicable after the participant has left the Company. If the participant did not respond regarding method of distribution, then the distribution was rolled into an Individual Retirement Account in the name of the participant.

If the participant's account balance was under \$1,000, then the distribution was automatically made in a lump sum cash payment regardless of whether the participant consented to receive it.

Participants could also withdraw funds from their account in the event of financial hardship as defined in the Plan document.

h. Forfeited accounts

Forfeited nonvested account balances at June 30, 2023 and December 31, 2022 were \$0 and \$20,340, respectively. These amounts could be used to pay administrative expenses or be used to reduce future employer contributions. Employer contributions were reduced by \$10,690 from forfeited nonvested accounts for the six months ended June 30, 2023. The remaining forfeited nonvested accounts were transferred out in conjunction with the Plan termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment valuation and income recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

d. Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in the administrative expenses. No allowance for credit losses was recorded as of June 30, 2023 or December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

e. Payment of benefits

Benefits were recorded when paid.

f. Administrative expenses

Certain expenses incurred by the Plan were paid by the Company and were excluded from these financial statements. Investment and record-keeping fees were either paid out of the participant accounts on a per capita basis or paid by the Company on behalf of the Plan. Transaction based fees were charged directly to the participant accounts.

g. Date of the Plan's review

The Plan has evaluated subsequent events through March 18, 2024, the date the financial statements were available to be issued.

3. TRUSTEE CERTIFICATION UNDER ERISA SECTION 103(a)(3)(C)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the auditors' examination did not extend to the following information certified by Fidelity Management Trust Company (Fidelity), the trustee, as complete and accurate:

- Investments
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1 Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that were observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability;
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that were unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS, (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Money market fund: Valued at cost plus accrued interest which approximated fair value.

Collective trust: Valued at the NAV of units of the collective trust. The NAV, as provided by the fund's trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell an investment for an amount different than the reported NAV. Participant transactions (purchases and sales) could occur daily. If the Plan initiated a full redemption of the collective trust, the investment trustee reserved the right to temporarily delay withdrawal from the trust for twelve months.

5. PARTY-IN-INTEREST TRANSACTIONS

During 2023 and 2022, the Plan held investments in fund options managed by Fidelity. Fidelity was the trustee as defined by the Plan and, therefore, these transactions were recognized as exempt party-in-interest transactions under ERISA.

For the period ended June 30, 2023, the Plan paid \$4,478 for certain expenses related to the plan operations to various service providers. These expenses were recognized as exempt party-in-interest transactions under ERISA.

6. TAX STATUS

The Plan utilized a Volume Submitter Defined Contribution Plan document administered by Fidelity and it obtained a determination letter dated June 30, 2020 from the IRS, which stated that the Plan, as designed, complied with applicable requirements of the Internal Revenue Code (IRC) and, accordingly, was exempt from federal income tax.

Although the Plan had been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan was designed and operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
