Please submit this letter for the 2022 Plan year along with the 5500 filing for Shape, Inc Plan # 715581.

Shape was purchased by United Flow Technologies HoldCo in 2022. The ADP 401k plan was terminated on December 31, 2022 and the assets were wired to the AON Pooled Employer Plan (Aon PEP) with Voya Institutional Plan Services, LLC.

The former Owner of Shape, Inc subsequently retired and the 5500 for the 2022 Plan Year was not filed prior to his departure. We were notified this week that the 5500 wasn't filed. We respectfully request that you accept this as reasonable cause for the late filing of the 2022 5500 for Shape, Inc.
