## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Stonerise Healthcare LLC 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Stonerise Healthcare LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of November 17, 2023 and December 31, 2022 and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2023 through November 17, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Stonerise Healthcare LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 17, 2023 and December 31, 2022, and for the period from January 1, 2023 through November 17, 2023, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stonerise Healthcare LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 6 to the financial statements, the Board of Directors of Stonerise Healthcare LLC 401(k) Profit Sharing Plan, the plan's sponsor, voted on June 28, 2022 to terminate the plan and management determined liquidation is imminent. As a result, Stonerise Healthcare LLC 401(k) Profit Sharing Plan changed its basis of accounting from the on-going basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the November 17, 2023 and December 31, 2022 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**Note 1 - Description of the Plan:**

The following description of the Stonerise Healthcare LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution retirement plan which was formed for the purpose of providing retirement benefits to all non-excluded (excluded includes hourly employees paid in lieu of benefits and nonresident aliens through October 31, 2019 and includes nonresident aliens and employees covered under a collective bargaining agreement who are employed with Rainelle Center, LLC dba Meadow Garden and Keyser Center, LLC dba Piney Valley for all employer contributions beginning November 1, 2019) employees of the controlled group of companies consisting of Stonerise Healthcare LLC, Parkersburg Acquisition LLC dba Eagle Pointe Nursing Home, Eastbrook Center LLC, Morgantown SNF Acquisition LLC dba Mapleshire Nursing and Rehabilitation Center, Springfield Center LLC and Riparian Investments LLC dba Harper Mills (effective 8/1/14); Stonerise Services LLC (effective 4/1/15), Princeton Center LLC dba Glenwood Park (effective 2/1/15), Stonerise Home Health Services LLC (effective 3/1/15), Berkeley Springs Center (effective 4/1/15), Lewisburg Center LLC dba The Brier (effective 4/1/15), Wellsburg Center LLC dba Valley Haven, Clarksburg Center LLC dba River Oaks (effective 8/1/15); Keyser Center LLC dba Piney Valley, Kingwood Center LLC dba Pine Ridge, Martinsburg Center LLC dba Clary Grove, Rainelle Center LLC dba Meadow Garden (effective 12/20/15); Stonerise Integrity Care LLC (effective 1/28/16 and closed in 2019); Stonerise Reliable Healthcare LLC (effective 4/12/16); Thomas Home Health to be a part of the existing Stonerise Home Health entity (effective 6/1/16); Bridgeport Center LLC dba Meadowview Manor (effective 1/1/17); Stonerise Therapy Services (effective 6/1/17); Moundsville Center LLC dba Mound View (effective 8/1/18); WV Senior Advantage, Inc. (effective 11/1/19) (collectively the "Company"). Employees become eligible to participate in the Plan upon completing one year of service (six months beginning November 1, 2019), as defined, and upon reaching the age of twenty-one. The service requirement was waived for employees who had completed the 90-day probationary period and were employed by a participating employer on November 1, 2013; such eligible employees were eligible on November 1, 2013. Participating employers who subsequently adopted the Plan elected to recognize service with the participating employer for purposes of Plan eligibility and vesting for employees who were employed on the date of the resolution to adopt the Plan, provided the employee had attained age 21 and completed a year of service with the participating employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offering, and monitors the investment performance.

**Note 1 - Description of the Plan (Continued):**

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Plan participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, if any, is based on years of continuous service. A participant is 100% vested after three years of credited service. However, effective June 30, 2022 with the Plan's termination, participants became automatically vested in all accounts, for additional information see Note 6 – Plan Termination.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

***Forfeited Accounts***

At November 17, 2023 and December 31, 2022, the forfeited non-vested accounts totaled \$- and \$95, respectively. These accounts can be used to reduce Company contributions, restore participant accounts, or pay administrative expenses. Also, in 2023, \$96 were used towards Plan expenses.

**Note 2 – Summary of Significant Accounting Policies:**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the liquidation basis of accounting.

**Note 2 – Summary of Significant Accounting Policies (Continued):**

***Use of Estimates***

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that may affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

The investment is reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded as when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees related to distributions are charged directly to participant's accounts and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

***Consideration of Subsequent Events***

The Plan has evaluated subsequent events for potential recognition and disclosure through March 19, 2024, the date the financial statements were available to be issued.

**Note 3 – Certified Information:**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2022, and net depreciation in fair value of investments, interest and dividends for the period from January 1, 2023 through November 17, 2023, was obtained or derived from information supplied to the plan administrator. The information was certified as complete and accurate by Empower Annuity Insurance Company of America, an agent of Empower Retirement, the trustee of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**Note 4 – Fair Value Measurements:**

*Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under FASB ASC 820 are described below:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs that are unobservable and significant to the fair value measurement.

**Note 4 – Fair Value Measurements (Continued):**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a brief description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 17, 2023 and December 31, 2022.

*Money Market Funds* – These investments are public investment vehicles using \$1 for the net asset value (NAV). The money market funds are classified within Level 1 of the valuation hierarchy.

**Note 5 – Related Party Transaction and Party In Interest Transactions:**

Certain investments are managed by Empower Retirement. Empower Retirement is the record-keeper as defined by the Plan. These transactions qualify as exempt party-in-interest transactions. Fees for record-keeping services are included with administrative expenses on the statement of changes in net assets available for benefits in liquidation.

**Note 6 – Plan Termination:**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. On June 28, 2022, the board of directors has approved the termination of the Plan. As a result of this termination the Plan participants have become fully vested in their account balances, and no further benefit accruals will be made for the Plan as of June 30, 2022.

**Note 7 – Tax Status:**

The IRS has determined and informed the Company by a letter dated July 13, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation.
