INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of ITC Service Group Acquisition 401(k) Profit Sharing Plan and Trust ("The Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Plan Merger

As discussed in Note 8 to the financial statements, on April 11, 2023, the Plan Administrator of ITC Service Group Acquisition 401(k) Profit Sharing Plan approved to merge into the AFL Telecommunications, LLC Savings, and Incentive Plan as of April 11, 2023. The ITC Service Group Acquisition 401(k) Profit Sharing Plan will transfer its net assets into the AFL Telecommunications, LLC Savings, and Incentive Plan and will cease operations as of that date. Our opinion is not modified with respect to this matter.

NOTE 1 - GENERAL DESCRIPTION OF THE PLAN

The following description of the ITC Service Group Acquisition 401(k) Profit Sharing Plan and Trust (the "Plan") provides only summarized general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established March 22, 2016 to provide benefits for eligible employees of ITC Service Group Acquisition, LLC (the "Plan Sponsor") and their beneficiaries. The Plan is a defined contribution plan covering all eligible employees. There is no age requirement to enter the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective March 1, 2021, the Plan changed service providers and adopted a new volume submitter plan document in conjunction with the change in service providers. In addition, the Plan had a new adoption agreement issued, effective January 1, 2022. As a result, Ascensus Trust Company now serves as the Plan Trustee, custodian of the assets, and third-party administrator.

Plan Year

The Plan year begins January 1st and ends December 31st, except for this plan period which ends April 11. Refer to Note 8 for additional information regarding the merger.

Contributions

The Plan allows for the following types of contributions:

Employee Salary Deferral 401(k) Contributions

The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). Employees may voluntarily contribute from 100% of their regular wages subject to various nondiscrimination tests and limitations prescribed by the Code. Employee salary deferrals include pre-tax elective deferrals and Roth after-tax elective deferrals.

Employer Safe Harbor Matching Contributions

Beginning with the Plan's most recent adoption agreement, effective January 1, 2022, The Plan Sponsor makes matching contributions to the account of each eligible participant in an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 2% of the participants compensation. The safe harbor matching contribution is 100% vested.

Discretionary Employer Profit Sharing Contributions

The Plan Sponsor may contribute an amount, at its discretion, to be allocated as a uniform dollar amount or a percentage of compensation within the allocation group. Participants must have 3 months of service and be employed on the last day of the Plan year to be eligible to receive discretionary employer profit sharing contributions.

Employee Rollover Contributions

Participants may make rollover contributions from another qualified plan.

Participants in the Plan may contribute up to 75% of their total pre-tax compensation ("salary reduction contribution") to the Plan. Effective salary reduction contributions were limited by the Internal Revenue Code to \$22,500 and \$20,500 in 2023 and 2022. Participants who attain age 50 before the end of the year are eligible to make catch-up contributions. Such contributions were limited to \$7,500 and \$6,500 in 2023 and 2022.

NOTE 1 - GENERAL DESCRIPTION OF THE PLAN – CONTINUED

Participant Accounts and Allocations

The Plan provides various investment fund options and allows participants to self-direct their investments. Investment earnings and losses are allocated to participants' accounts based on the earnings or losses of the investments selected.

Forfeitures

Forfeitures are first used to reduce administration fees and then to reduce employer contributions. For the periods ended April 11, 2023 and December 31, 2022, forfeiture balances were \$0 and \$0, respectively. For the periods ending April 11, 2023 and December 31, 2022, forfeitures used to offset employer match contributions were \$0 and \$6,164, respectively.

Vesting

Participants are always 100% vested in their salary deferral contributions. Employer match contributions are 100% vested once the participant has completed one year of service. For vesting purposes, a year of service is equivalent to 1,000 hours of service during the Plan year. Employer profit sharing contributions and gains/losses credited thereon vest over a six-year period as follows:

Less than 2 years credited service	0%
After 2 years credited service	20%
After 3 years credited service	40%
After 4 years credited service	60%
After 5 years credited service	80%
After 6 years credited service	100%

Retirement

Normal retirement under the Plan is age sixty-five (65).

Payment of Benefits

Payment of benefits may be made at the following times under the Plan: 1) normal retirement, 2) termination of employment of the participant, 3) in-service distributions upon attaining age 59 ½, 4) participants who have incurred a disability, or 5) death of the participant. The form of benefit payments may be in a single lump sum or in periodic installments over a period of time.

Notes Receivable from Participants

The Plan allows participants to borrow from their accounts. Loans may not exceed 50% of the vested balance in a participant's account or \$50,000 and are due within five years, or longer if for the purchase of a primary residence, as permitted by the Plan administrator.

The loans are secured by the balance in the participant's account. Participants may have no more than two outstanding loans at a time. Interest was set at the prime rate during 2023 and 2022 and ranges from 3.25% to 7.00% for loans outstanding as of April 11, 2023 and December 31 2022. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

Significant administrative expenses of the Plan were paid for by the Plan Sponsor for the period ended April 11, 2023 and December 31, 2022. Expenses related to specific participant transactions are charged to the respective participant's account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 11, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition Transactions

Investments in securities are stated at fair market value using quoted market prices when available. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded when declared. Interest income is recorded when earned. Capital gains are included in net appreciation. Increases in the unit values of investments are reflected in each participant's self-directed account. Investments are valued daily.

Income Taxes

The Plan adopted a prototype plan which obtained a favorable opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Plan management has determined that as of April 11, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however, there are currently no examinations for any tax periods in progress.

Payment of Benefits

Benefits are recorded when paid.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A fair value hierarchy was established that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of other significant observable inputs either directly or indirectly (including quoted prices for similar securities, interest rates, yield curves, credit risk, etc.), and Level 3 inputs consist of significant unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs, because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements

Investments in registered investment companies consist of mutual funds and corporate stocks which are valued using quoted prices available in active markets for identical instruments.

The following tables are set forth by level, within the fair value hierarchy, the Plan's assets accounted for at fair value on a recurring basis as of April 11, 2023, and December 31, 2022, with the exception of the common/collective trusts measured at fair value using the NAV practical expedient. The fair value for the common/collective trusts are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

NOTE 4 - FAIR VALUE MEASUREMENTS – CONTINUED

The Plan recognizes transfers between levels as of the actual date of the event or change in circumstances that caused the transfer. There were no transfers between levels for the period ended April 11, 2023, 2023 and December 31, 2022.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

Ascensus Trust Company serves as trustee of the Plan. All investment and transaction amounts in the accompanying financial statements were certified by the Trustee as complete and accurate in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

NOTE 6 - TRANSACTIONS WITH RELATED PARTIES AND PARTIES-IN-INTEREST

Certain Plan investments are managed by the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees for certain administrative expenses are paid to the record-keeper of the Plan. Fees paid by the Plan for investment management services are recorded in net appreciation in fair value of investments. Notes receivable from participants are considered party-in-interest transactions. In addition, certain fees with parties-in-interest of \$25,000 and \$0 were paid by the Company during the periods ended April 11, 2023 and December 31, 2022, respectively. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

NOTE 8 – PLAN MERGER

On April 11, 2023 (Plan Merger Date), the Plan was merged with and into the AFL Telecommunications, LLC Savings and Incentive 401k Plan #001 (“AFL”). Prior to the Merger Date, ITC was the Plan Sponsor. Effective on the effective merger date, AFL became the plan sponsor. The value of assets transferred on the Merger Date was \$967,660.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through February 15, 2024, which is the date the financial statements were available to be issued.
