Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Safety Center Incorporated 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023, in liquidation, and June 30 2022, ongoing, and the related statement of changes in net assets available for benefits for the year ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2023 and 2022, and for the year ended June 30, 2023, stating that the certified investment information, as described in Note 5 of the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of June 30, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter

As described in Note 3 to the financial statements, Safety Center Incorporated 401(k) approved to terminate the Plan effective December 31, 2022. In accordance with accounting principles general accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis to the liquidation basis as of and for the year ended June 30, 2023. Our opinion is not modified with respect to that matter.

1. DESCRIPTION OF THE PLAN

The following description of Safety Center Incorporated 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was a defined contribution plan covering employees of Safety Center Incorporated (the Sponsor). The Plan was established on July 1, 1997, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan allowed contributions to be made for all eligible employees of the Sponsor.

In 2022, the Sponsor terminated the Plan (see Note 3).

Administration – The Sponsor was the administrator of the Plan and, as such, carried out the duties imposed under ERISA. The Sponsor delegated certain responsibilities for the operation and administration of the Plan. Administrative and recordkeeping services were provided by Ascensus Trust Company (the Trustee).

Eligibility – Prior to Plan termination, employees of the Sponsor became eligible to participate in the Plan immediately after completing one year of service with a minimum of 1,000 service hours and attaining the age of twenty-one, with the exclusion of employees covered by a collective bargaining agreement, nonresident aliens, or an employee under the transaction described in Code Section 410(b)(6)(C), in which case such employee were able to enter the plan on the next January 1 or July 1 following completion of one year of service.

Contributions – Prior to Plan termination, participants were able to contribute up to the maximum amount allowed by the IRS limitations through salary deferrals. Participants were also permitted to deposit into the Plan distributions received from other plans (rollovers).

Employer contributions – Prior to Plan termination, the Sponsor was able to make discretionary matching contributions and profit-sharing matching contributions. For the year ended June 30, 2023, the Sponsor did not make any discretionary matching contributions to the terminated Plan.

Investment election – Prior to Plan termination, the Plan offered various investment alternatives through the Trustee. Plan participants directed their contribution amount in these investment alternatives.

Vesting – Prior to Plan termination, participants were immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting for employer contributions was based on a six year graded schedule, as follows:

Participant accounts – Prior to Plan termination, individual accounts were maintained for each Plan participant to reflect the participant's contributions, allocation of the Sponsor's discretionary matching contributions and profit-sharing contributions. In addition, participant accounts were credited with the earnings on their investments as earned. The vested balance in a participant's account was the benefit to which the participant would be entitled upon termination or retirement.

Payment of benefits – Prior to Plan termination, benefits were payable upon retirement, termination, disability, hardship, or death. Benefits were paid in either a single lump sum distribution or a rollover to another qualified plan or an individual retirement account.

Administrative expenses – Substantially all of the expenses associated with administering the Plan are paid from the Plan net assets and therefore, are reflected in the Plan's financial statements.

Notes receivable from participants – Prior to Plan termination, under the terms of the Plan, participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans were secured by the balance in the participant's account and bear interest at rates equal to the published Prime rate plus 1% on the date of origination. Principal and interest were paid through payroll deductions.

Forfeitures – Prior to Plan termination, upon termination of employment, the unvested portion of a participant's account was forfeited. Forfeitures were used to reduce employer contributions. The forfeiture balance was \$0 at June 30, 2023 and 2022.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principals generally accepted in the United States of America. The liquidation basis of accounting is used as of June 30, 2023 and the ongoing basis was used as of June 30, 2022.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains (losses) are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments included net unrealized market appreciation and depreciation of investments and net realized gains and losses on the sale of investments during the period.

Notes receivable from participants – Notes receivable are valued at the outstanding note balance, plus accrued unpaid interest, which approximates fair market value. Interest income is recorded on an accrual basis and recognized in the period it was assessed. No allowance for credit losses has been recorded as of June 30, 2023 or June 30, 2022. If a participant ceased to make loan payments and the Plan administrator deemed the loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Contributions – Employee contributions are recorded in the period payroll deductions were made. Matching contributions from the Sponsor are recorded in the period when the related employee contributions were recorded.

Payment of benefits – Benefits are recorded when paid.

Income taxes – The Plan sponsor had adopted the Ascensus LLC Volume Submitter plan. The Volume Submitter plan received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Volume Submitter plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since the opinion letter, the Plan sponsor and Trustee believe that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

Subsequent events – Plan management has evaluated subsequent events for recognition and disclosure through March 12, 2024, the date the financial statements were available to be issued. See Note 3 for discussion of subsequent event.

3. PLAN TERMINATION

In 2022, the Sponsor terminated the Plan as of December 31, 2022, which marks the termination date of the Plan. As a result of the termination, the Plan adopted the liquidation basis of accounting. This basis of accounting is considered appropriate when the liquidation of a Plan is imminent. Under this basis of accounting, assets are valued at the estimated amount of cash the plan expects to collect in settling or disposing of those assets in carrying out its plan for liquidation, and liabilities are stated at their estimated costs expected to be incurred during the liquidation process. The remaining notes receivable to participants was transferred from the Plan in July 2023.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within a fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and 2022.

Mutual funds – The Plan's mutual funds are valued using market quotations or prices obtained from independent pricing service and calculate a share value or net asset value each day.

Money market fund – The Plan's money market fund is valued based on the closing price reported by the fund sponsor in an actively traded exchange.

The Plan's investment balance as of June 30, 2023 was \$0. As noted in Note 1 and Note 3 the Plan was terminated as of December 31, 2022 and the Plan assets were transferred from the Plan in June 2023.
