## INDEPENDENT AUDITOR'S REPORT

Board of Trustees  
Iron Workers Local 401 Vacation Fund  
Philadelphia, PA

### **Opinion**

We have audited the accompanying financial statements of Iron Workers Local 401 Vacation Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of June 30, 2023 and 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the years then ended (in liquidation), and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Iron Workers Local 401 Vacation Fund as of June 30, 2023 and 2022, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America applied on the basis described in the Emphasis of Matter paragraph.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Iron Workers Local 401 Vacation Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter**

As described in Note 9 to the financial statements, the governing body of Iron Workers Local 401 Vacation Fund approved a plan of liquidation in June 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis of accounting. The liquidation basis usually causes little or no change in the values of Fund assets because most, if not all, Fund assets are fair value. Our opinion is not modified with respect to that matter. The Plan was terminated as of June 30, 2023.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF THE PLAN

The following brief description of Iron Workers Local 401 Vacation Fund is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

##### *General*

The Vacation Fund was formed by an Agreement and Declaration of Trust, for the purpose of providing Vacation Fund benefits for all employees covered by the Collective Bargaining Agreement. The Vacation Fund is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

The Vacation Fund was designed for accumulation and distribution of monies to participants based upon contributions received on their behalf in accordance with a collective bargaining agreement. Contributions are made to the Fund by use of a voucher system. Currently, the participant receives a voucher on each payday representing a record of benefits accumulated.

Vacation benefits are paid to participants quarterly based upon the monetary value of vouchers accumulated by the participant in accordance with the agreement.

The Vacation Fund may be terminated only by joint agreement between contractors and union.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

##### *Cash & Equivalents*

Cash and equivalents represent operating checking and money market accounts.

##### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Contributions*

Vacation contributions consist of employee payroll deductions at a rate of \$6.00 per hour from July 1, 2022 to June 30, 2022, \$3.00 per hour from July 1, 2022 to December 31, 2022, and ending contributions beginning January 2023. The Fund agreement provides that contractors of Iron Workers Local 401 remit weekly contributions to the Fund for each hour paid in accordance with their collective bargaining agreement.

Contributions are based on remittances received during the year plus those received during the normal cut-off period. No provision has been made for delinquent contributions based on the uncertainty of collection.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

*Depreciation*

Depreciation on furniture and office equipment is computed over the estimated useful life of seven years using the straight-line depreciation method.

*Income Taxes*

The Internal Revenue Service has determined and informed the Fund that the Fund is qualified and the trust established under the Fund is tax-exempt, under the appropriate sections of the Code. The Plan administrator and outside counsel believe that the Fund is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Fund was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

*Subsequent Events*

Management has evaluated events and transactions occurring subsequent to June 30, 2023 for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue.

3. CONCENTRATION OF CREDIT RISK

The Fund maintains a cash balance in a financial institution located in the Philadelphia, Pennsylvania area. Accounts at this institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At certain times the amount of deposit exceeds the insured amount.

For the years ended June 30, 2023 and 2022, rent of \$6,557 and clerical wages and fringe benefits of \$28,644 and \$31,522 were allocated to the Fund, respectively.

The distribution of benefits was made as soon as legally permissible and administratively predictable. All assets of the Plan were distributed as of June 30, 2023.
