Emphasis of Matter – Basis of Accounting

As discussed in Note F to the financial statements, the employer filed a Voluntary Assignment for the Benefit of Creditors proceeding pursuant to Chapter 128 which forces the owners to sell the employer. On September 23, 2022, the court approved the sale of Saris Cycling Group, Inc.'s assets and on September 30, 2022, the Plan was terminated; therefore, management determined liquidation of the Plan was imminent. As a result, the 2023 and 2022 financial statements are presented under the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

NOTES TO FINANCIAL STATEMENTS

September 30, 2023

NOTE A -- Description of plan and significant accounting policies

The following brief description of the Saris Cycling Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Saris Cycling Group, Inc. (employer) has adopted the AT Retirement Services, LLC Non-Standardized Pre-Approved Profit-Sharing Plan with 401(k) features, under the name, Saris Cycling Group 401(k) Profit Sharing Plan, originally effective January 1, 1991. The employer has subsequently amended and restated the Plan with the most recent restatement effective January 1, 2022.

Effective September 30, 2022, the Plan was terminated. As a result, all participants became fully vested in their account balances and all Plan assets were distributed or transferred by September 30, 2023.

General

The Plan was established to provide retirement benefits to eligible employees of the employer. The Plan is a defined contribution profit-sharing plan with elective deferral 401(k) features covering employees who have attained the age of 21 and have completed 500 hours of service within six months of hire or have completed one year of service. Participants are eligible to receive employer matching contributions if they have completed at least 501 hours during the semi-annual periods ending June 30 or December 31 and are employed on the last day of those semi-annual periods. Employees who have completed at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan year are also eligible for the employer discretionary contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 39-1643952, and the Plan's number is 001.

Contributions

Each year, participants may elect to make pre-tax (regular) or post-tax (Roth) deferral contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. There were no participant contributions in 2023.

The employer may make discretionary matching contributions. There were no employer matching contributions in 2023. Additional amounts may be contributed at the discretion of the employer and are allocated based on the ratio of a participant's compensation to the compensation of all eligible participants. No additional discretionary contributions were made for 2023.

Participants direct the investment of their deferral contributions and employer contributions into various investment options offered by the Plan. Annual contributions from all sources are subject to certain limitations defined by the IRS.

NOTE A -- Description of plan and significant accounting policies (Continued)

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s matching and discretionary contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances and allocations of employer contributions are based on participant compensation, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the rollover of funds from other qualified plans to a participant’s account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the employer’s matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants are 100% vested on this portion of their account ratably after six years of credited service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as 1% over the prime rate (6.25% as of September 30, 2023). Principal and interest is paid ratably through monthly payroll deductions.

Benefits

On termination of service due to death, disability, or retirement (age 59½), a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits hardship distributions if certain criteria are met. The Plan permits in-service distributions at age 59½. A participant with an account valued at less than \$5,000 shall receive an automatic rollover of their vested account balance to an individual retirement account or annuity. For accounts exceeding \$5,000 the participant may elect a lump-sum distribution, installment or partial payment; or the participant may elect to rollover the distribution to another qualified plan.

Forfeited accounts

At September 30, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0. These accounts had been used first to reduce future employer contributions, and then to reduce administrative expenses of the Plan. In 2023, there were no payments from forfeited non-vested accounts used for administrative expenses.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The employer pays some of the administrative expenses of the Plan which are excluded from these financial statements. The major administrative expenses are payroll related fees.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of September 30, 2023 and December 31, 2022, no allowance for credit losses has been recorded.

Subsequent events

These financial statements have not been updated for subsequent events occurring after March 21, 2024, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after that date.

NOTE B -- Information certified by the trustee and asset custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at September 30, 2023 and December 31, 2022, and interest, dividends and net appreciation for the period ended September 30, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Johnson Bank, the asset custodian and trustee of the Plan.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2023 and December 31, 2022.

- Money market fund: Valued based on quoted net asset values of the shares held by the Plan at year-end.

- Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits in Liquidation for the period ended September 30, 2023, are reported in net appreciation in fair value of investments.

NOTE D -- Party-in-interest transactions

Certain Plan investments are managed by Johnson Bank. Johnson Bank is the trustee, asset custodian and recordkeeper of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Johnson Bank provides certain administrative services to the Plan pursuant to an agreement between Saris Cycling Group (Plan Sponsor) and Johnson Bank. Johnson Bank receives revenue from mutual fund service providers for services Johnson Bank provides to the funds. This revenue is used to offset certain amounts owed to Johnson Bank for its administrative services to the Plan.

If the revenue received by Johnson Bank from such mutual fund service providers exceeds the amount owed, Johnson Bank remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Johnson Bank for administrative expenses not covered by revenue sharing.

Fees were also paid by the Plan during the period for auditing services rendered to SVA Certified Public Accountants, S.C. These transactions also qualify as party-in-interest transactions.

NOTE E -- Tax status

The AT Retirement Services, LLC Non-Standardized Profit Sharing Plan, referred to in Note A, that the Plan has adopted effective January 1, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE F -- Plan termination

The employer filed a Voluntary Assignment for the Benefit of Creditors proceeding pursuant to Chapter 128 which forces the owners to sell the employer. On September 23, 2022, the court approved the sale of Saris Cycling Group, Inc.'s assets and on September 30, 2022, the Plan was terminated; therefore, management determined liquidation of the Plan is imminent.

No further contributions or elective deferral contributions to the Plan were made after September 30, 2022. All participants became 100% vested in their allocated employer contributions upon termination of the Plan. All plan assets were either distributed or transferred, as elected by each plan participant, by September 30, 2023. As a result, the 2023 and 2022 financial statements are presented under the liquidation basis of accounting.

NOTE G -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits in Liquidation.

NOTE I -- Plan amendments

Effective January 1, 2022, the Plan was restated to bring the Plan into compliance with the requirements of the 2017 Cumulative List of Changes in Plan Qualification Requirements for Pre-approved Defined Contribution Plans (Notice 2017-37). The Plan contains appropriate retroactive effective dates with respect to provisions for the appropriate laws of the Cycle 3 restatement. In addition, the plan restatement included an amendment to change the employer match contribution from a guaranteed percentage to a discretionary amount determined by management annually.
