

Attached please find the Final Form 5500-SF (Short Form Annual Return/Report of Small Employee Benefit Plan) filed with respect to the May Media Group, LLC 401(K) Profit Sharing Plan (the "Plan"), for the short plan year ending March 13, 2024. May Media Group, LLC, the Plan Sponsor, filed a voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code (the "Bankruptcy Code") on May 20, 2023. On August 30, 2023, the Office of the United States Trustee appointed me to serve as the Successor Chapter 7 trustee in the bankruptcy case (the "Bankruptcy Trustee").

As the Bankruptcy Trustee, and pursuant to section 704(a)(11) of the Bankruptcy Code, I continued to perform the obligations required of the administrator of the Plan. Accordingly, I have overseen the termination and liquidation of the Plan, and I have signed the Final Form 5500-SF for the short plan year ending March 13, 2024, solely in my capacity as the Bankruptcy Trustee. As a result of the Plan Sponsor's bankruptcy, and given my limited role as Bankruptcy Trustee, I cannot confirm the accuracy of all the information contained in the 2024 Final Form 5500-SF (notwithstanding the fact that I have signed the form).
