### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Great Western Bancorp, Inc. 401(k) Contribution Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 18, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 to April 18, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Great Western Bancorp, Inc. 401(k) Contribution Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 18, 2022 and 2021 and for the period January 1, 2022 to April 18, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

## **Note 1 - Description of Plan**

The following brief description of the Great Western Bancorp, Inc. 401(k) Contribution Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan sponsored by Great Western Bancorp, Inc. (the Company) for the benefit of its employees. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA). Effective April 18, 2022, the Plan was merged into the First Interstate BancSystem 401(k) Plan. See Note 7 for further information.

### **Eligibility and Entry Dates**

All employees are eligible for elective deferrals. The matching contribution eligibility date is defined by the Plan as the date after an employee has completed six months of continuous service and attained age 21. For discretionary contributions, the eligibility date is defined by the Plan as the date after an employee has completed one year of continuous service and attained age 21. Employees may enter the Plan the first day of the month after meeting the eligibility requirements for all contributions. Employees must complete 1,000 hours of service for the plan year to receive the employer matching contribution. Employees must complete 1,000 hours of service for the plan year and still be employed on the last day of the plan year to receive the discretionary contribution.

### **Contributions**

The Plan permits eligible employees through a salary deferral election to make annual contributions of up to 100% of eligible compensation. Employees are automatically enrolled into the Plan at a salary deferral rate of 2.5% per pay period if an enrollment form has not been completed. Employee rollover contributions are also permitted. The Plan accepts Roth Elective Deferrals as all or part of a Participant's salary reduction contributions. Company matching and profit-sharing contributions are discretionary as determined by the Company's Board of Directors. For the period January 1, 2022 to April 18, 2022, there was no profit-sharing contributions. The employer made an additional matching contribution which equaled 100% of the first 2.5% of compensation that a participant contributed to the plan. Contributions are subject to certain Internal Revenue Code limitations.

### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing deferrals and employer contributions into any of the separate investment accounts offered by the Plan and may change the allocation daily.

### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company matching contributions, as well as allocations of the Company discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting and Forfeitures

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service.

Vesting is based on years of credited services as set forth in the following table:

<u>Participant's Years of Service</u>	<u>Vested Percentage</u>
Less than 2 Years	0%
2 Years	25%
3 Years	50%
4 Years	75%
5+ years	100%

A participant is fully vested after five years of continuous service, or upon death, disability or normal retirement age. In addition, vesting in the participant's HF Financial Corp. employer contribution accounts are fully vested after three years of credited service. At April 18, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$-0- and \$513,345, respectively.

### Payment of Benefits

Upon reaching retirement age, a deferred retirement date or upon termination of employment or death or disability, a participant or beneficiary may elect to receive either a lump-sum amount equal to the participant's vested interest in the account, or periodic installments over a period not to exceed the joint and last survivor life expectancy of the participant and designated beneficiary as described in the Plan document. Prior to the annuity commencement date, any participant can elect a lump-sum cash settlement. Withdrawals prior to termination of employment or retirement are prohibited unless elected by the participant under the following conditions: attaining age 59 ½, establishing permanent and total disability, demonstrating financial hardship or otherwise allowed by applicable laws and regulations. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account.

Certain participants in the Plan have alternative distribution requirements. A participant's surviving spouse, if any, will automatically receive a preretirement survivor annuity payable from one-half of the balance of the participant's vested interest in the account. The remainder of the participant's vested interest in the account will be payable to beneficiaries as provided above. This alternative distribution may be waived by the participant in the plan year age 35 is attained or at the time employment terminates.

The designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

### **Notes Receivable from Participants**

The Plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years through payroll withholdings. If the loan proceeds were used to acquire the participant's residence the loan repayment period may extend to 30 years. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Investment Valuation**

The Plan's investments are reported at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. See below for discussion of fair value measurements and fully benefit responsive investment contracts, which are reported at contract value.

### **Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported above and in the statement of changes in net assets may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Fully Benefit-Responsive Investment Contract**

During the 2018 Plan year, the Plan entered into a group annuity contract with Great-West Life & Annuity Insurance Company, a related entity of the Plan's custodian. The contract is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participant if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. As a traditional investment contract, the Plan owns only the contract itself.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The credit rating is reviewed on a quarterly basis for resetting. The contract does not have a maturity date. The contract value of the investment contract at April 18, 2022 and December 31, 2021 was \$-0- and \$9,295,052, respectively.

The Plan's ability to receive amounts due in accordance with the fully benefit responsive investment contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plans to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include, but are not limited to the Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under section 501(a) of the IRC; premature termination of the contract; Plan termination; changes to the Plan's prohibition or competing investment options; and bankruptcy of the Plan Sponsor or other events of the Sponsor, such as divestitures, that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contact issuer and that also would limit the ability of the Plan to transact at contact value with the participants.

### **Fair Value Measurements**

Topic ASC 820, "Fair Value Measurements and Disclosures" establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 18, 2022 and December 31, 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at fair value based on the NAV of units held of the collective investment fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying securities based on the present value of the contracts expected cash flows discounted by current market interest rates for similar investments or based on observable market prices. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

#### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through March 1, 2024, which is the date the financial statements were available to be issued.

#### **Note 3 - Tax Status**

The Plan obtained its latest determination letter on August 15, 2013, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. The Plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
