### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Ref-Chem Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period and year then ended, respectively, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ref-Chem Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1: Description of the Plan

##### **General**

The following description of Ref-Chem Retirement Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by Ref-Chem L.P. (the Company) for the benefit of its employees who have at least one year of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Delaware Charter Guarantee & Trust Company, d/b/a Principal Trust Company (“Principal”), is the trustee for the Plan.

Effective January 1, 2022, the Plan was amended to remove the service requirement and employees were immediately eligible to participate in the Plan upon reaching age 21.

Effective January 1, 2023, the Plan was amended to remove safe harbor contributions and implement a matching contribution which allows for a separate discretionary true-up contribution at the end of the year. These contributions are subject to a six-year graded vesting schedule. The amendment also required all employees to be automatically enrolled at 6.5%.

Effective August 1, 2023, the Plan merged with the Burns & McDonnell, Inc. 401(k) Savings Plan sponsored by Burns and McDonnell, Inc. On August 9, 2023, the Plan’s assets were formally transferred into the surviving plan.

##### **Contributions**

The Plan permits eligible employees through a salary deferral election to make annual contributions of up to 50% of their eligible compensation. Elective deferral contributions made by highly compensated employees (HCEs) expected to exceed the maximum permitted compensation for purposes of the Plan are subject to a limitation of the lesser of 6.5% of eligible compensation or the dollar limit set by the Plan for that plan year. The maximum deferral amount for HCEs is limited to \$2,000 less than the maximum deferral dollar limit set by law for the plan year. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company makes matching contributions of 100% of employees’ salary deferral amounts on the first 1% of employees’ compensation and 50% of the next 5% of total eligible compensation. Effective January 1, 2023, this contribution no longer qualifies as a safe harbor contribution as permitted by the internal revenue code. The matching contribution for the year ended December 31, 2022 was a safe harbor matching contribution.

Effective January 1, 2023, the Company makes matching contributions of 50% of the first 6.5% of compensation deferred to the Plan.

The Company may make discretionary profit-sharing contributions to eligible employees employed on the last day of the plan year (December 31) with 1,000 hours of service at the end of the Plan year end. No such contributions were made for the period ended July 31, 2023 and 2022.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature starts at 3% and provides for an annual increase, starting after the second year, in the percentage deferred and is ultimately capped at 6%. Effective January 1, 2023, a participant is treated as electing 6.5% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature no longer provides for an annual increase. Employees previously enrolled at 3% or less will be automatically increased to 6.5% of compensation.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of service. For the Company's matching contribution, a participant is fully vested after two years of service as follows:

Effective January 1, 2023, the Plan was amended so the Company's nonelective, regular matching and discretionary contributions are all vested on a six year graded scale, as presented above.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or termination, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account. The Plan allows participants and their beneficiaries to receive installment and partial distributions. If the participant's vested benefit in the Plan exceeds \$5,000 (excluding amounts attributable to rollovers), the participant must consent to the distribution before it may be made. If a participant's account is greater than \$1,000, but not greater than \$5,000, and the participant makes no election, then payment will be made to an individual retirement account. If a participant's vested account balance is less than \$1,000 and no election is made, distribution of the participant's vested account shall be made in a lump sum.

***In-Service Withdrawals***

Participants may withdraw all or a portion of their salary deferral account balance, safe-harbor contribution, company discretionary matching contribution account balance, ESOP transfer account balance and earnings once they attain age 59½, all or a portion of their rollover contributions account, if any, at any time, or, in the case of financial hardship, a distribution may be made from their salary deferral and company discretionary matching contribution account balance. Financial hardship is defined as an immediate heavy financial need resulting from a qualified list of expenses defined by the Internal Revenue Service (IRS) Code Section 165.

***Forfeited Accounts***

At July 31, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$332,198, respectively. These accounts will be used to reduce Company contributions and pay plan expenses. During the period ended July 31, 2023 and year ended December 31, 2022, employer contributions were reduced by \$205,460 and \$32,049, respectively, from forfeited nonvested accounts. Any remaining forfeitures as of July 31, 2023 were transferred to the new plan.

#### **Note 2: Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end.

Investments in common collective trusts (CCTs) are valued based upon the redemption price of the units held by the Plan, which is based on the current fair value of the underlying assets held by the CCT. Unit values are determined by the financial institution sponsoring the CCT by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds and the CCTs are deducted from income earned on a daily basis and are not separately reflected.

Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### ***Unit Values***

Participants do not have beneficial ownership in specific underlying securities or other assets in the CCTs, but have an interest therein represented by units valued as of the last business day of the period. The funds' earnings are automatically reinvested in additional units. Generally, contributions to and withdrawal payments from each fund are converted to units by dividing the amounts of such transactions by the unit value as last determined and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution. There were no participants who have elected to withdraw from the Plan, but have not yet been paid at July 31, 2023 and December 31, 2022.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

#### **Note 4: Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their Company contributions account.

#### **Note 5: Plan Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype 401(k) retirement plan and trust/custodial document sponsored by Polsinelli PC. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

#### **Note 6: Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of July 31, 2023 and December 31, 2022.
- Investment income (loss) as shown in the statements of changes in net assets available for benefits for the period ended July 31, 2023 and year ended December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 7: Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$38,056 and \$88,308 of administrative fees to the trustee during the period ended July 31, 2023 and year ended December 31, 2022, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 8: Nonexempt Transaction**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$51,019 were not remitted within the required time period for the year ended December 31, 2022. The correction for the related earnings was completed in 2023.

**Note 9: Subsequent Events**

Subsequent events have been evaluated through March 29, 2024, which is the date the financial statements were available to be issued.
