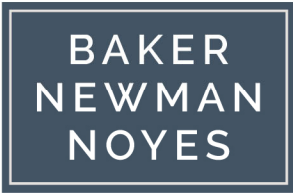

INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lorient Pet Services, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 20, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 to June 20, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 20, 2023 and December 31, 2022, and for the period from January 1, 2023 to June 20, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, in March 2023, Plan management made the decision to merge the Plan into the Rarebreed Veterinary Partners 401(k) Plan. The merger was effective June 1, 2023 and all Plan assets were transferred to the Rarebreed Veterinary Partners 401(k) Plan on June 20, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule, Schedule of Delinquent Participant Contributions for the period ended June 20, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Lorient Pet Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan was established by Lorient Pet Services, LLC (the Company), and became effective on January 1, 2019. The Plan is a defined contribution plan qualified under Section 401(k) of the United States Internal Revenue Code (the Code) covering eligible employees of the Company and its affiliates. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan was amended and restated effective January 1, 2023.

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (collectively, Principal) are the recordkeepers and custodians for the Plan.

In March 2023, Plan management made the decision to merge the Plan into the Rarebreed Veterinary Partners 401(k) Plan. The merger was effective June 1, 2023 and all Plan assets were transferred to the Rarebreed Veterinary Partners 401(k) Plan on June 20, 2023.

Eligibility and Participation

Employees are eligible to participate in the Plan for purposes of both employee deferrals and Company contributions who are age 21 and have completed three months of service. Employees enter the Plan the first day of the calendar month coincident with or next following having reached the eligibility requirements. Effective January 1, 2023, the age and service requirements were changed to allow employees of any age to participate as soon as they have completed one hour of service with the Company.

The Plan has an auto enrollment provision, where any newly eligible employee is deemed to have elected to have 4% of their compensation automatically deferred as a contribution to the Plan unless they elect otherwise. Effective January 1, 2023, the automatic enrollment provision was removed.

Contributions

Contributions to the Plan may be made by both the participants and the Company. Eligible employees may elect to contribute, on a pre-tax or after-tax basis, eligible compensation up to the maximum amount allowable under federal tax regulations.

The Company makes a matching contribution for all participants equal to 50% of the participant's contribution not to exceed 5% of their eligible compensation. Effective January 1, 2023, the Company makes a Safe Harbor matching contribution of 100% of an employee's contribution up to 3% of their eligible compensation, and 50 % of an employee's contribution between 3% and 5% of their eligible compensation. Matching contributions totaled \$300,127 and \$446,719 in 2023 and 2022, respectively.

The Company may also make a discretionary profit sharing contribution to the Plan. There was no discretionary profit sharing contribution in 2023 or 2022.

Participants can direct the allocation of their accounts to any of the stipulated investment fund alternatives offered by the Plan. Participants may change their investment options at any time during the year.

1. Description of the Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeitures of terminated participants' nonvested accounts may be used to pay Plan expenses or reduce future employer contributions to the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollover Accounts

Employees may rollover into the Plan assets distributed as vested interest upon their termination from a qualified defined benefit plan or a qualified defined contribution plan in which they were formerly participants.

Vesting

Employee salary deferrals and rollovers are 100% vested at all times. Company matching and discretionary profit sharing contributions vest as follows:

Forfeitures of Company matching and discretionary profit sharing contributions are used primarily to pay administrative expenses of the Plan or reduce employer contributions to the Plan at the discretion of the Plan Administrator. Forfeitures available as of June 20, 2023 and December 31, 2022 and used for the period from January 1, 2023 to June 20, 2023 and for the year ended December 31, 2022 were not material.

Benefits

The Plan provides benefits to participants upon death, disability, attainment of age 59 ½, retirement or termination of employment. Benefits will be paid to the participant in a lump-sum payment if the balance of the account is less than or equal to \$5,000. If the balance exceeds this amount, the participant may elect to receive the benefit as a lump-sum payment, a partial withdrawal, or by rollover to another qualifying plan.

Participants are permitted to make hardship withdrawals from their account provided they meet certain criteria and the withdrawals are approved by the Plan Administrator.

The Plan does not permit loans.

1. **Description of the Plan (Continued)**

Administrative Expenses

Administrative expenses are paid by the Plan participants to the extent they are not paid by the Company.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts. The merger, as previously described, does not qualify as a plan termination.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The Plan's financial statements are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition

Pooled separate investments are stated at fair value based on net asset value (NAV). NAV is determined based on the fair value of the fund's underlying net assets and the number of units outstanding. The group annuity contract is reported at contract value, as determined by the insurance company, as it is considered fully benefit-responsive.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) in fair value of investments is recorded in the accompanying statements of changes in net assets available for benefits and includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from employees are recorded during the period in which the Company makes payroll deductions. Employer contributions are recorded at the time the Company commits to a specific contribution amount.

Benefit Payments

Benefit payments are recorded when paid.

2. Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment funds which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, liquidity and credit risk, among others. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent Events

Events occurring after the statements of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through March 28, 2024, which is the date the financial statements were available to be issued.

3. Information Certified by the Custodians

The Plan's investments, net appreciation (depreciation) in fair value of investments, interest and dividends, and investment transactions, were certified by Principal as of June 20, 2023 and December 31, 2022 and for the period from January 1, 2023 to June 20, 2023 and for the year ended December 31, 2022. Therefore, in accordance with the request of the Plan's Administrator and as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to auditing procedures generally accepted in the United States of America, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule.

The Plan Administrator has obtained certifications from the custodians stating that the information provided to the Plan Administrator from the custodians is complete and accurate. The Plan Administrator has determined that the custodians meet the definition of qualified institutions defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

As described in note 2, the Plan's investment in the group annuity contract is reported at contract value, as determined by the respective insurance company. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The group annuity contract is a general account product with an insurance company. As such, there are not any specific securities in the general account that back the liabilities of this insurance product. The group annuity contract pays interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Certain events limit the ability of the Plan to transact at contract value. Such events include (1) certain amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

4. **Party-in-Interest Transactions**

A portion of the Plan's assets are invested in pooled separate accounts and a group annuity contract established by the custodians or affiliates of the custodians. Therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Administrative expenses charged to the Plan and paid to the custodians and other service providers qualify as party-in-interest transactions.

5. **Tax Status**

Effective January 1, 2019, the Plan adopted a volume submitter form of a Plan sponsored by CCH Incorporated d/b/a Ftwilliam.com and the Plan was amended and restated effective January 1, 2023. The volume submitter plan has received an opinion letter from the IRS dated June 30, 2020 as to the volume submitter's qualified status, stating that the Plan was designed in accordance with applicable IRS requirements. The volume submitter plan opinion letter has been relied upon by the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 20, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Fair Value Measurements

The Plan has adopted the framework for measuring fair value under generally accepted accounting principles.

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 20, 2023 and December 31, 2022.

Pooled separate accounts: Valued based upon net asset value (NAV) as determined by the trustees using the fair value of the underlying investments held by the fund, less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. The investments measured at NAV have no unfunded commitments as of June 20, 2023 or December 31, 2022.

Mutual funds – valued based upon quoted market prices which represent the net asset values of shares held by the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
