**NOTE A - GENERAL DESCRIPTION OF THE PLAN**

Plan Summary

The CP&Y, INC. 401(k) PLAN (“the Plan”) is a defined contribution plan established for the benefit of the employees of CP&Y, Inc. (“the Company”). All full-time employees who have reached the age of 18 become eligible to participate in the Plan on the first day of the month following their employment. The following is a brief general description of the Plan. For more detailed Plan information, see the Plan document.

Contributions

Participants may elect to make deductible contributions to the Plan up to 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make after-tax ROTH contributions. Rollover contributions from other qualified retirement plans are allowed by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an auto-enrollment feature whereby all new eligible employees are automatically enrolled in the Plan at 8% unless they change their contribution percentage or opt out. The Plan has an employer match feature. In 2022, the Company contributed the lesser of 50% of the employee’s deferral or 4% of eligible compensation.

The Company may, at the discretion of its board of directors, make a lump-sum contribution at the end of each plan year. For the year 2022, the lump-sum discretionary contribution of \$922,301 (\$1,208,991 less forfeitures of \$286,690 to be used) was receivable by the Plan at December 31, 2022. The discretionary employer contribution for 2021 of \$952,780 was receivable by the Plan at December 31, 2021 and contributed in 2022. Total contributions are subject to statutory limitations. Excess contributions must be distributed in accordance with the Plan.

All investment funds of the Plan are participant-directed investment funds.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of Company contributions, if any, and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

The Plan uses the elapsed time method for vesting purposes. Based on their employment date, participants become 25% vested after two years of service, 50% vested after three years of service, 75% vested after four years of service and 100% vested after five years of service. In addition, each employee becomes 100% vested upon death or disability. Participants are always fully vested with respect to their contributions and related earnings.

Participant Loans

Participants may borrow up to 50% of their vested benefits, limited to \$50,000. Notes plus interest are repaid through semi-monthly payroll deductions over a period not exceeding 60 months. If a participant borrows money to purchase their primary residence the notes may have a term of up to 120 months. Payments include interest comparable to current bank lending rates at the time the loan was made which was 4.25% - 8% in 2022. Participant notes receivable are secured by the vested account balance of the corresponding plan participant.

Distributions

On retirement, disability, or other termination of service, a participant may elect to receive a distribution in the amount of the participant's vested account. The participant may elect to receive the distribution in a lump-sum or in monthly, quarterly, or annual installments over a defined life expectancy period.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$274,676 and \$215,077, respectively. These accounts will be used to reduce future employer contributions. Forfeitures in the amount of \$200,000 were used to offset the employer discretionary match for 2021 received by the Plan in 2022.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan. In this event, the accounts of all participants and beneficiaries would become fully vested and all benefits non-forfeitable. See Note H.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

The collective trust, Vanguard Retirement Savings Trust III, is a stable value fund that invests in the Vanguard Retirement Savings Master Trust which primarily invests in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds. The collective trust is presented at Net Asset Value ("NAV"). Participants may ordinarily direct the withdrawal or transfer at NAV. The NAV for the collective trust fund is \$1 per share.

Investment transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Operating expenses of the Plan are absorbed by the plan sponsor and are excluded from these financial statements. Loan origination fees are included in gross loan withdrawals. Investment-related expenses are included in net depreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reported period. Actual results could differ from these estimates.

**NOTE C - TAX STATUS**

The IRS has determined by a letter dated June 30, 2020 that the Plan is designed in accordance with the applicable section of the Internal Revenue Code (the Code). The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Code, and that the Plan is qualified, and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax period in progress.

**NOTE D - INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements, notes and supplemental schedule, including investments held and notes receivable at December 31, 2022 and 2021, net depreciation in fair value of investments, and interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the Plan trustee, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

FASB ASC 820, *Fair Value Measurement & Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and quoted prices for similar assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The fair values of mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Collective Trust: The collective trust fund is measured at net asset value (NAV) as a practical expedient to estimate fair value. NAV as provided by the fund's management is based on the value of the underlying investments in the collective trust less its liabilities.

There are no restrictions on participant redemptions of the collective trust measured at NAV. There were no unfunded commitments at December 31, 2022 or 2021.

**NOTE F – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE G – RELATED PARTY AND PARTY-IN- INTEREST TRANSACTIONS**

The Plan holds investments managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee as defined by the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Fees in the amount of \$12,481 were paid to Vanguard by the Plan in 2022. Of this amount, \$1,000 of loan origination fees are included in the participant loans balance.

The Plan incurred audit fees in the amount of \$13,250 during the year ended December 31, 2022. The audit fee was paid by CP&Y, Inc., the plan sponsor.

**NOTE H– SUBSEQUENT EVENTS**

In September 2022, the decision was made by the entity that owns the plan sponsor, STV, to merge this Plan into its employee benefit plan in early 2023. The assets of the Plan were transferred to the STV 401k Retirement Plan on January 31, 2023.

Subsequent events were evaluated through November 28, 2023 which is the date the financial statements were available to be issued.
