Management has obtained certifications from a qualified institution as of and for the period from April 1, 2022 through March 10, 2023 and as of and for the year ended March 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. ### **Basis of Accounting**

As described in Note 2 to the financial statements, the Plan administrator approved a resolution to terminate the Plan, at which time management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going concern basis to the liquidation basis effective April 1, 2022. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. ## **1. Description of Plan**

The following description of the Superior Machine Company of SC, Inc. Savings Incentive Plan (the “Plan”) provides only general information. Participants may refer to the Plan’s documents for a more complete description of the Plan’s provisions.

Effective January 1, 2023, the Plan administrator elected to join a separate pooled employer plan. As such, the Plan terminated subject to the provisions of ERISA. Contributions were discontinued and participants became fully vested in all contributions. Participants were provided 2 months to elect how to distribute their account balances. All Plan assets were either distributed directly to participants or rolled over into an individual retirement account or to the pooled employer plan, as elected. For participants who did not make an election, depending on their account balance at the time of transfer, their entire balance was either automatically rolled over to an individual retirement account paid directly to them.

On March 10, 2023, plan assets totaling approximately \$5,756,000 were transferred to another qualified plan. No contributions were made to the Plan after March 10, 2023.

### **General**

The Plan is a defined contribution plan covering employees of Superior Machine Company of SC, Inc. (the “Company”). There are no age or service requirements to make employee elective deferrals or receive employer contributions. Leased employees are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### **Contributions**

The Plan allows contribution of any portion of a participant’s pre-tax compensation, subject to contribution limitations specified by law. The Plan has an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

The Company may make discretionary matching and/or profit-sharing contributions. The Company made discretionary matching contributions of approximately \$109,000 and \$93,000 for the period from April 1, 2022 to March 10, 2023 and the year ended March 31, 2022, respectively.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary contributions (if any), allocations of the Plan's earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Participants direct their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures of the non-vested portion of terminated participant's account balances remain in the Plan. These forfeitures may be used to pay Plan expenses or reduce employer contributions.

**Vesting**

Participants are immediately vested in their salary deferrals plus actual earnings or losses thereon. Vesting in the remainder of their account balance is based on years of continuous service. Participants are 50% vested in the Company's discretionary contributions at the end of two years of continuous service, with additional vesting of 50% after three years, resulting in 100% vesting, after the third year.

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are required to be repaid within one to five years, unless borrowed for the purchase of a primary residence, which requires the note to be paid within one to ten years. A participant may have no more than one note due to the Plan at any time. The notes are collateralized by the balance in the participants' accounts and bear interest at the prime rate plus 1% (determined at the time of issuance of each note). Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon retirement, permanent total disability, death, or termination of employment, participants or their beneficiaries may elect to receive their vested portion of Plan assets under several payout options specified in the Plan. Participants who have attained fifty-nine and a half years of age are permitted to withdraw all or part of their vested accounts as in-service distributions. Subject to certain conditions, participants may make hardship withdrawals from their balances in the Plan while employed.

**1. Description of Plan (continued)**

**Forfeited Accounts**

During the period from April 1, 2022 to March 10, 2023 and the year ended March 31, 2022, non-fully vested participants forfeited approximately \$28,000 and \$14,000, respectively. At March 10, 2023 and March 31, 2022, there were forfeited non-vested account balances of \$0 and approximately \$16,000, respectively. During the period from April 1, 2022 to March 10, 2023 and March 31, 2022, forfeitures used to reduce employer contributions totaled approximately \$23,000 and \$47,000, respectively. During the period from April 1, 2022 to March 10, 2023, forfeitures of approximately \$21,000 were transferred to another plan.

**Administrative Expenses**

The Plan pays all trustee, custodial, investment advisory, and recordkeeping fees. The Company pays other administrative and professional fees.

**2. Basis of Presentation and Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States (“US GAAP”). Effective April 1, 2022, the Plan changed its basis of accounting from the going concern basis to the liquidation basis.

**Estimates**

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reported period. Actual results could differ from those estimates.

**Participant Notes Receivable**

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as participant distributions.

**Investment Valuation and Income Recognition**

Investments are stated at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invested in a fully benefit-responsive fixed interest contract with Principal Trust Company ("Principal"). The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed interest investment contract issuer is contractually obligated to repay the principal and specific interest rate that is guaranteed to the Plan. The contract may be subject to a market value adjustment upon contract termination. Crediting interest rates on the fixed fund portion of the insurance investment contracts are determined quarterly by the issuers with a minimum rate of 1%, subject to limitations relating to Plan termination, early retirements, etc. There are no reserves against contract values for credit risk or otherwise.

As the fixed interest investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed interest investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Payment of Benefits**

Benefits are recorded when paid.

**3. Custodian Certifications**

Information disclosed in the accompanying financial statements, related to investments, participant notes receivable, net appreciation (depreciation) in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's custodian, Principal.

**4. Fair Value Measurements**

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. All of the Plan's mutual fund investments were valued using Level 1 inputs, based on quoted market prices.

The Plan invests in collective trusts where the underlying investments primarily consist of investment contracts and security-backed contracts. The collective trusts are valued at the net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV of each account is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the trust, the trust provider reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

Although Plan management believes the valuation methods used are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Income Tax Status**

The Plan operates under a prototype non-standardized profit sharing plan designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service ("IRS") determined that the pre-approved Plan document and related trust are designed in accordance with applicable sections of the RIC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of March 10, 2023 and March 31, 2022. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress.

**6. Party-in-Interest Transactions**

Fees paid by the Plan for trustee, custodial, recordkeeping, and investment advisory services amounted to approximately \$28,000 for both the period from April 1, 2022 to March 31, 2023 and March 31, 2022. These transactions, as well as participant notes receivable, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

**7. Subsequent Events**

Management has evaluated events and transactions after March 10, 2023 through February 14, 2024, the date on which the financial statements were available to be issued, for subsequent events, and determined that there were no subsequent events to report.
