### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Commonwealth Anesthesia Associates, P.C. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets in liquidation available for benefits as of November 5, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation available for benefits for the period from January 1, 2023 to November 5, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 5, 2023 and December 31, 2022, and for the period from January 1, 2023 to November 5, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Basis of Accounting**

As discussed in Note 4 to the financial statements, the Board of Directors of the Plan sponsor approved a plan of liquidation on November 15, 2022. Employees were terminated as of December 1, 2022, and all contributions to the Plan were ceased. Management determined liquidation of the Plan was imminent. Plan assets were effectively liquidated on November 5, 2023. As a result, the liquidation basis is used in presenting the financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1. Plan Description**

The following description of the Commonwealth Anesthesia Associates, P.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of Commonwealth Anesthesia Associates, P.C. (the "Company"). The Company controlled and managed the operation and administration of the Plan. State Street Bank & Trust Company served as the trustee of the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 31, 2022, the Plan was effectively terminated. Participants who were actively employed as of December 1, 2022, became 100% vested in their entire account balance. See Note 4.

Contributions

Prior to December 31, 2022, the Plan allowed participants to make voluntary deferral contributions up to 100% of their pre-tax annual base compensation, as defined in the Plan document, subject to Internal Revenue Code (IRC) limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation and their contributions invested in a designated growth fund until changed by the participant. The Company could provide a discretionary profit-sharing contribution. All participants were categorized into one of eleven groups. The Company could contribute a different amount on behalf of each group. The amount contributed would be allocated proportionately based on each participant's compensation compared to the total compensation of all participants in the group. Contributions were subject to certain limitations.

Participant accounts

Prior to December 31, 2022, each participant's account was credited with the participant's contribution and allocations of the Company's contributions and Plan earnings, and charged with benefit payments, and allocations of administration expenses and Plan losses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in all accounts plus actual earnings thereon. Prior to December 1, 2022, a participant vested in employer contributions and earnings thereon according to the following vesting schedule.

3 years	100

Prior to December 1, 2022, any participant who reached normal retirement age, was permanently disabled, or died was 100% vested interest regardless of years of service.

Participants who were actively employed on December 1, 2022, became immediately vested in all accounts plus actual earnings thereon.

Notes receivable from participants

Prior to Plan termination, participants could borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at prime plus 1% based on the prime interest rate published in the Wall Street Journal.

Payment of benefits

Prior to Plan termination, upon termination of service, a participant could elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. In-service distributions were available after the participant reached age 59 ½. Upon Plan termination, the participants could elect to have their distribution paid as a lump sum, direct rollover to another eligible retirement plan, or direct rollover to an IRA.

Administrative expenses

Plan fees and administrative expenses were paid by the Company or the Plan on a discretionary basis.

Forfeitures

At December 31, 2022, forfeited non-vested accounts totaled \$11,226. These accounts were used to reduce future Company contributions or pay administrative expenses. During 2023, forfeitures of \$11,226 were used to reduce Company contributions from the 2022 employer receivable.

**Note 2. Summary of Significant Accounting Policies**

Basis of accounting

In accordance with accounting principles generally accepted in the United States of America, the financial statements of the Plan are prepared under the liquidation basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements. Such estimates also affect the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

Cash and cash equivalents

The Plan included all cash accounts, which were not subject to withdrawal or penalties, as cash and cash equivalents on the accompanying statements of net assets in liquidation available for benefits.

Investment valuation and income recognition

The Plan's investments were recorded at fair value, which was the price that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

Prior to Plan termination, the Plan provided for various investment fund options. Investments were exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation available for benefits and the statement of changes in net assets in liquidation available for benefits.

Notes receivable from participants

**Note 3. Information Certified by State Street Bank & Trust Company**

Certain information was certified as complete and accurate by State Street Bank & Trust Company, the Plan's Trustee. That information is as follows:

- Cash and cash equivalents
- Investment assets
- Investment transactions
- Investment income
- Notes receivable from participants
- Interest income on notes receivable from participants

**Note 4. Plan Termination**

On November 15, 2022, the Board of the Company consented to a plan of liquidation and dissolution and terminated all employees as of December 1, 2022. All employee deferrals and employer profit-sharing contributions ceased with the December 31, 2022 payroll period and the Plan was effectively terminated. All assets were effectively distributed to participants as of November 5, 2023.

**Note 5. Party-in-Interest Transactions**

Prior to Plan termination, certain Plan assets were invested in funds managed by Transamerica. State Street Bank & Trust Company was the trustee as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions. However, these transactions were not considered prohibited transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the service providers by the Plan for administrative services including fees paid for audit services were \$67,030 for the period from January 1, 2023 to November 5, 2023.

Transamerica provided certain administrative services to the Plan pursuant to a Pension Service Agreement (PSA) between the Company and Transamerica. Transamerica received revenue (annual fees) from mutual fund and collective trust fund service providers for services Transamerica provided to the funds. This revenue was used to offset certain amounts owed to Transamerica for its administrative services to the Plan.

If the revenue received by Transamerica from such mutual fund or collective trust fund service providers exceeded the amount owed under the PSA, Transamerica remitted the excess to the Plan's trust on a quarterly basis. Such amounts could have been applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2023, revenue sharing of \$19,123 was received by the Plan and \$58,137 was used to pay Plan expenses. Administrative expenses are presented net of revenue credits used.

**Note 6. Fair Value Measurements**

The Plan's investments were reported at fair value in the accompanying statements of net assets in liquidation available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. Due to Plan liquidation, there are no investments held by the Plan at November 5, 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

*Level 1 Fair Value Measurements*

The fair values of the mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

*Level 2 Fair Value Measurements*

The fair value of the stable pooled fund is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include the quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The stable value fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are publicly quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

**Note 7. Investment Contract**

The Plan was invested in the Transamerica Stable Pooled Fund (the “Fund”). The Fund is a common collective trust and maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There is no set interest rate for the Fund, because it owns several investment contracts with varying rates and maturity dates.

The guaranteed investment contract is benefit-responsive and presented at fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The average yields for the Transamerica Collective Trust Stable Pooled Fund for the period from January 1, 2023 to November 5, 2023, and year ended December 31, 2022, are as follows:

**Note 8. Tax Status**

The Plan had adopted a non-standardized plan sponsored by Transamerica Retirement Solutions, LLC and had not requested a determination letter but rather had relied upon the Internal Revenue Service opinion letter dated June 30, 2020, issued on the non-standardized plan stating the Plan and related trust were designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan had been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan was designed and was operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 5, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
