INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed the audit of the financial statements of the SemiTorr Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of March 31, 2022 and the related Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2022 to March 31, 2022, and the related notes to the financial statements.

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that



are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect Management's responsibility for the financial statements.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the SemiTorr Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the *Plan Document* for a more complete description of the Plan's provisions.

General

SemiTorr Group, Inc. (the Company, or the Plan Sponsor, or the Plan Administrator) established the Plan effective January 1, 1991, and restated effective January 1, 2022. The Plan covers all employees of the Company except employees covered by a collective bargaining agreement, nonresident aliens with no U.S. source income, and leased employees. Employees are eligible to participate in the Plan at age 21 or older and have completed at least 1 hour of service within the first three months of service or work at least 1,000 hours during the 12-month period immediately following the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

During 2021, the Company merged with FloWorks International LLC. As a result, the Plan's assets amounting to \$ 10,285,484 were liquidated and transferred to the Floworks 401(k) Plan on April 1, 2022.

Contributions

Participants may elect to make pre-tax or post-tax Roth salary deferral contributions to the Plan up to the maximum allowed by law. Rollover contributions are allowed subject to conditions set forth in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. New or re-hired participants are automatically enrolled in the Plan at a 5% salary deferral rate.

The Company may make a discretionary matching contribution, to be determined annually, equal to a uniform percentage or dollar amount for each participant's elective deferrals, including catch-up deferrals. Participant must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the Plan year to be eligible for the Company's discretionary matching contribution. The Company did not make any discretionary matching contributions during the period from January 1, 2022 to March 31, 2022.

Participant Accounts

Each participant account is credited with the participant's contribution and allocations of the Company's discretionary matching contribution, Plan earnings or debited with losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of vesting service in accordance with the following schedule:

Forfeitures

Forfeitures represent the excess employer match contributions participants received for the plan year. Forfeitures may be used to pay Plan expenses or reduce future Company contributions. The forfeiture balance on December 31, 2022 and 2021 was \$0 and \$5,203, respectively. Forfeitures used to pay Plan expenses during 2022 and 2021 were \$5,203 and \$9,407, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance in the Plan. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate. Principal and interest are paid ratably through payroll deductions for periods ranging up to five years, or up to 10 years for the purchase of a primary residence. Participants may only have four loans outstanding at any time.

Payment of Benefits

Normal retirement age under the Plan is 65. Upon separation of service due to death, disability, retirement, or termination of employment, participants can receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a rollover contribution may receive a distribution at any time, limited to the total of their rollover contribution and related earnings. The Plan also allows for hardship distributions from a participant's vested account and in-service distributions at age 59½.

Fees and Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan Document. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, and other participant directed expenses, are charged directly to the participant's account and are included in expenses of the Plan. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of March 31, 2022 and December 31, 2021. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits paid directly to participants, or their beneficiaries are recorded when paid.

NOTE 3: INVESTMENT INFORMATION

Information related to investments as of March 31, 2022 and December 31, 2021, and the related investment income or loss for the period from January 1, 2022 through March 31, 2022 was certified by John Hancock Life Insurance Company (U.S.A.), the Plan custodian and recordkeeper, as permitted by Regulation 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4: FAIR VALUE MEASUREMENT

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* (FASB ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

John Hancock Stable Value Fund: This Fund is a separate account group annuity contract offered by John Hancock that guarantees principal and credited interest for eligible participant-initiated withdrawals and transfers. The guarantee associated with this product is backed by the general assets of the insurer. The strength of the guarantee is dependent on the financial strength of the insurance

company issuing the contract. Guaranteed separate account products have interest rate, inflation and credit risks associated with the underlying assets owned by the fund. Depending on the terms of the contract, there are also investment risks associated with certain plan sponsor actions, including, but not limited to, termination of the contract, mass layoffs or plan termination, which could result in payment of proceeds to the plan sponsor of the lesser of the fund's market value and principal plus credited interest. The Stable Value Fund is valued based on the participants account balance which increases with participant contributions and guaranteed interest earned, and decreases with distributions, loans, charges and fees. Distributions are calculated at the book value of the Stable Value Fund, subject to the terms of the contract. Hence, the book value is the fair value for this fund. This fund invests in securities issued by the U.S. Government or one of its agencies, as well as high-grade corporate bonds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: PARTY-IN-INTEREST TRANSACTIONS

During 2022 and 2021, certain Plan investments in mutual funds, and common/collective trust funds were managed by entities related to John Hancock Life Insurance Company (U.S.A.), and, therefore, these transactions qualified as party-in-interest transactions. However, they were exempt from the prohibited transaction provisions under ERISA.

NOTE 6: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating.

NOTE 7: PLAN TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing plan, which obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of March 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8: SUBSEQUENT EVENTS

Plan Management's Review of Subsequent Events

In preparing the accompanying financial statements, Plan management has reviewed all known events that have occurred after March 31, 2022, and through March 21, 2024, which is the date the financial statements were available to be issued, for inclusion in the financial statements and footnotes.
