#### **Note 1 - Description of Plan**

As described in Note 3, effective as of December 31, 2022 the Softworld, Inc. 401(K) Plan merged into the Kelly Retirement Plus and Kelly Retirement Savings Plan. The following notes describe the Plan while it was in operation.

The following description of Softworld, Inc. 401(K) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *a) General*

The Plan is a defined contribution plan for employees of Softworld, Inc. ("Company") who are age 21 and older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *b) Contributions*

The Plan provides for both pre-tax and Roth deferral contributions. Each year, participants may contribute a fixed amount of eligible compensation, as defined in the Plan document, subject to Internal Revenue Service limitations. Entry date to the Plan is the month subsequent to the employee's date of hire. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan includes an auto-enrollment provision whereby all new eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. Employer contributions are discretionary and will be contributed at such time as the Plan Sponsor deems appropriate. If the Plan Sponsor decides to make an employer contribution, it is determined as a uniform percentage of compensation for all eligible participants. Employees are eligible to receive employer contributions after having completed one year of service. For the year ended December 31, 2022, the employer match was the lesser of 25% of the participant's deferral or 25% of 6% of the participant's compensation.

#### *c) Participant Accounts*

Each participant's account is credited with participant and employer contributions, as applicable, and the earnings thereon. Allocations of contributions are based on investment allocations as selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d) Vesting

Participants are immediately vested in their contributions plus earnings thereon. Participants are vested in Company discretionary profit sharing contributions according to the following schedule:

Forfeited balances of terminated participants are used to reduce Company profit-sharing contributions.

e) Notes Receivable from Participants

Participant loans are available for those who can demonstrate the existence of a hardship event. Participants may have one outstanding loan at a time. Loans are limited to 50% of a participant's vested account balance or \$50,000. Loans must be a minimum of \$1,000. Loans are secured by the participant's account and bear interest at a reasonable rate. Loans are repaid through payroll deductions. The term of the loan generally may not extend for more than five years. Loans used to purchase a primary residence must be repaid within thirty years. The principal balance of participant loans was \$0 and \$195,072 at December 31, 2022 and 2021, respectively. Loans outstanding bear interest between 4.25% and 6.25% at December 31, 2021.

f) Payment of Benefits

Upon termination of employment, participants are entitled to distribution from the Plan. In service distributions are permitted if a participant is 59 1/2, incurs a hardship, reaches the Plan's normal retirement age, or become disabled. Benefit payments are recorded when paid.

g) Plan Expenses

The Plan is sponsored by Softworld, Inc. Administrative expenses are paid by the sponsor.

**Note 2 - Summary of Significant Accounting Policies**

*Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, except for distributions paid to participants which are prepared on the cash basis of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

*Risks and Uncertainties*

The Plan invests in various investments, all of which are participant directed. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. The net appreciation/depreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Investments in mutual funds are valued at the closing market value for the funds on the last day of the Plan year. Investments in the Fixed Account are reported at contract value which equals the accumulated cash contributions and interest credited to the plan's contracts, less any withdrawals and fees.

Purchases and sales of securities are recorded on the settlement date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Note 2 - Summary of Significant Accounting Policies** (Continued)

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction (increase) of net appreciation (depreciation) in fair value of investments.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the plan year to the end of the plan year is included with realized gains/losses as net investment income reported in the accompanying statement of changes in net assets available for benefits.

#### **Uncertain Tax Positions**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

Plan management along with the plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for three years prior.

#### **Note 3 - Plan Termination and Merger**

Effective as of December 31, 2022, the Softworld, Inc. 401(K) Plan merged into the Kelly Retirement Plus (KRP) and Kelly Retirement Savings Plan (KRSP). Effective January 1, 2023, the employees of Softworld, Inc. will be eligible under and commence participation in the retirement plans sponsored by Kelly Services Inc., which include the KRP and KRSP, based on their employment status and eligibility under such plans. Accordingly, effective December 31, 2022, the Softworld employees will cease to participate in the Softworld, Inc. 401(K) Plan. Effective as of December 31, 2022 the Softworld, Inc. 401(K) Plan will be divided and merged into the KRP and KRSP, with the individual employee accounts under the Softworld, Inc. 401(K) Plan transferred to the KRP or KRSP based on the employment status of the Softworld employee. In connection with the merger, the trustees of the Softworld, Inc. 401(K) Plan will liquidate to cash the plan accounts of all participants of the Softworld, Inc. 401(K) Plan before the transfer of assets thereof. The trustee of the KRP and KRSP, Bank of America, N.A., will accept the plan accounts of all participants of the Softworld, Inc. 401(K) Plan on the date of the transfer of assets thereof into the KRP and KRSP. As of December 31, 2022 all assets were effectively transferred to the new plan.

**Note 4 - Information Prepared and Certified by Trustee (Unaudited)**

At December 31, 2022 and 2021, the Plan's investments were held and administered by the trustee, Principal Financial Group, a qualified certifying institution. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Principal Financial Group. **Note 5 - Fully Benefit Responsive Investment Contracts**

The Plan has a Fixed Account investment option provided through a Group Annuity Contract or Group Funding Agreement. Under the terms of the Group Annuity Contract or Group Funding Agreement, a crediting rate is established for amounts invested in the Fixed Account. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at Contract Value. Contract Value represents contributions plus credited interest less participant withdrawals and fees. This investment option is a fully benefit responsive not withstanding the liquidation value events under the Group Annuity Contract or Group Funding Agreement that limit the ability of the Plan to transact at Contract Value. Occurrence of events that would limit the ability to transact at contract value are not considered probable. The contract value of the fixed account was \$- and \$272,457 at December 31, 2022 and 2021, respectively.

#### **Note 6 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Inputs to the valuation methodology include:
- ◆ quoted prices for similar assets or liabilities in active markets;
  - ◆ quoted prices for identical or similar assets or liabilities in inactive markets;
  - ◆ inputs other than quoted prices that are observable for the asset or liability;
  - ◆ inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Registered Investment Company Funds:* Valued at quoted market prices of shares held by the plan at year end.

*Pooled Separate Accounts:* Valued at the market value of the underlying holdings of the Fund.

*Common Collective Trusts:* Valued at Fair Value. The investments in the common collective trust consist of the target date retirement funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 7 - Transactions with Related Parties**

The Plan pays transaction fees to the trustee in connection with the management of investments that have been included with the appreciation (depreciation) of fair value of investments.

The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

The Plan invests in allocated insurance contracts sponsored by Principal Financial Group, trustee and administrator of the Plan.

The above transactions qualify as exempt party-in-interest transactions.

#### **Note 8 - Income Tax Status**

The Plan is an adoption of a prototype plan. The prototype plan received a favorable determination letter, dated March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

#### **Note 9 - Subsequent Event**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through February 27, 2024 the date the financial statements were available to be issued.

The Plan Filed with the Delinquent Filer Voluntary Compliance program (DFVCP) for the late filing of its 5500 and attached audited financial statement for the year ended December 31, 2022.


