To Whom It May Concern:

Please take this letter as a Sworn Statement of Reasonable Cause for the failure to file the above-mentioned return. The following statement is made under penalties of perjury, as required under Section 2560.502c-2(e).

Cumberland Plastic Systems, LLC (Company) engaged TASC, a third-party administrator to file its Form 5500 for its Cumberland Plastic Systems Health and Welfare for the Plan's Plan Year 2020. In January 2021, the Company engaged a new third-party administrator, MMI, Consultants. The Company's Human Resources Director at that time failed to notice that Form 5500 processing was not included in the processing engagement. Kimberly Edge took over this Human Resources Directors position on December 5, 2022, and was not aware of the engagement shortcoming nor was she informed by her predecessor that Form 5500 was not completed for year-ended December 31, 2021.

To my knowledge, the Company did not receive any late notices until we received your March 11, 2024, letter. The Company has updated its engagement with MMI, Consultants, to include the 2021 Form 5500, and all future Forms. We have the data collected and will process the 2021 and 2022 Form 5500's as soon as possible. The 2023 Form 5500 will also be filed within the allowed required date.

Please accept this failure to file occurrence as a one-time mistake resulting from two key organizational changes. The Company's has never had an issue filing Form 5500's prior to this incident and has made appropriate changes to its internal control environment to ensure this mistake is not repeated in the future. Based on the changes made to the Company's internal control environment to prevent this error from recurring, the Company's past filing history, and based on the Company's prompt response to this notice we request all penalties to be abated
