Independent Auditors' Report

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed an audit of the financial statements of ExamSoft Worldwide Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022, and the related notes to the financial statements.

1. Description of the Plan

The following description of the ExamSoft Worldwide Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on January 1, 2016, for the benefit of eligible employees of ExamSoft Worldwide Inc. (the Company or Plan Administrator). Reliance Trust Company (Reliance or Trustee) served as the Trustee, and ADP Retirement Services (ADP) served as the record-keeper of the Plan. The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective January 1, 2023, the ExamSoft Worldwide Inc. 401(k) Plan merged into the Advance 401(k) Plan. All assets from ExamSoft Worldwide Inc. 401(k) Plan totaling \$8,704,051 were transferred out of the Plan effective as of December 31, 2022.

Contributions

Each year, participants were able to contribute up to 90% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). The Plan also allowed for after-tax, Roth contributions, subject to the same IRC limitations. Employees who were eligible to make elective deferrals under the Plan and who attained the age of 50 before the close of the plan year were also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC. Rollover contributions representing distributions from other qualified defined benefit or defined contribution plans were also permitted into the Plan. The Plan provided for Company safe-harbor matching contributions in an amount equal to 100% of participant contributions up to the first 4% of the participant's eligible compensation. The Company was also able to make discretionary contributions in amounts to be determined by the Company. No discretionary contributions were made for the year ended December 31, 2022.

Eligibility and Participant Accounts

Employees became eligible for participation immediately upon hire, as defined by the plan document. Subject to certain limitations on annual additions, each participant's account was credited with employee elective deferrals, Company safe-harbor matching and discretionary contributions and an allocation of plan earnings and charged with certain administrative expenses, if applicable. The allocations were based on participant account balances, as defined in the plan document. Participants were able to modify investment elections, transfer existing account balances and obtain information regarding the investments on a daily basis.

Investment Options

The Plan provided for contributions to be invested by participants into a variety of mutual registered investment companies and common collective trusts in accordance with participant investment elections and the provisions of the trust agreement. Participants should refer to the plan website for additional fund information.

Benefits Paid to Participants

Upon normal retirement age, death, disability or termination, a participant's benefits were payable in either installment payments or a lump-sum amount equal to 100% of the participant's vested account balance. Employees were also able to make hardship withdrawals on the balance of their account related to their elective deferral contributions. Participant account balances greater than \$5,000 were able to defer their distribution to a later date. Participant account balances of \$5,000 or less, at the time of distribution were "cashed out" as either a lump sum payment or by direct rollover into an individual retirement account or other eligible retirement plan. Account balances of \$1,000 or less were cashed out as an involuntary lump sum payment.

Vesting

Participants were immediately vested in participant elective deferrals, rollover contributions and Company safe-harbor matching contributions plus actual earnings thereon. Discretionary contributions made by the Company were based on three years of continuous service. Participants were 100% vested after three years of qualified service. Participants were automatically fully vested upon death, disability or upon reaching normal retirement age in their account balance, as defined by the plan document.

Forfeitures

Forfeitures were available to reduce future Company contributions or pay plan expenses. At December 31, 2022 there were no forfeited nonvested amounts available for use. At December 31 2021, forfeited nonvested accounts available for use totaled \$293 available. The amounts are reported as a component of net assets available for benefits. During 2022, no forfeitures were utilized.

Notes Receivable From Participants

Borrowings were available for all participants. Notes receivable from participants were limited to a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of the vested account balance, subject to certain restrictions as defined by the Internal Revenue Service (IRS). Participants were able to have up to two notes outstanding at a given time. The notes receivable from participants were secured by the balance in the participant's account and bear interest based on the prime rate reported in the Wall Street Journal, plus two percentage points. Note terms range from one to five years, unless the note is for the purchase of a principal residence, in which case the term was not allowed to exceed thirty years. Repayments were made through payroll deductions and were reinvested in the participant accounts according to individual investment elections. Notes receivable from participants totaling \$103,355 transferred out, had interest rates ranging from 5.25% to 9.00% and maturities ranging from January 2023 to July 2028.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with United States generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon terms of the plan document or note policy of the Plan. Notes receivables are valued at amortized cost, which approximates fair value. No allowances for credit losses have been recorded as of December 31, 2022 or 2021.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee, as applicable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The income earned on participant accounts is allocated on a daily basis using the previous day's ending account balance. Net depreciation in fair value of investments includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Subsequent events were evaluated through February 9, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Significant observable inputs other than quoted prices in active markets for which inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds of registered investment companies are valued at the net asset value (NAV) or quoted market prices of shares held by the Plan at year-end.

Common collective trusts are valued at the NAV of units of bank collective trusts as provided by the Trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment manager reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants; even so, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Concentrations

The Plan held certain investments that represented 10% or more of the Plan's net assets available for benefits. As of December 31, 2021, the Plan had investments totaling \$4,945,812 that were concentrated in four funds.

5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

The Plan issued notes receivable to participants, which were secured by the participant's account balances. These transactions also qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by an officer or employees of the Company. No such officer or employee received compensation from the Plan.

6. Tax Status

The Plan was based on the prototype nonstandardized profit sharing plan with CODA developed by ADP, LLC, which received a favorable opinion letter dated October 6, 2020 stating that the prototype plan constituted a qualified plan under Section 401 of the IRC. The plan administrator believed that the prototype plan, as adopted and amended, was operating within the guidelines of the IRC and continued to be tax-exempt. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

Plan management was required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities occurred and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021. Accordingly, Reliance Trust Company, the Trustee of the Plan, as of December 31, 2022 and 2021, and for the year ended December 31, 2022, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021, and the related investment activity and interest on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.

9. Delinquent Participant Contributions

For the year ended December 31, 2021, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Delinquent Participant Contributions Disclosure under ERISA. Untimely remittances identified on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions totaled \$137,631 for the year ended December 31, 2021.
