Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of 401K Plan for Employees of Elsner Engineering Works Inc (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2023 and December 31, 2022 and for the period January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Board of Directors of Elsner Engineering Works, Inc., the Plan Sponsor, voted on March 16, 2023 to merge the Plan into the GSP Navigator Pooled Employer Plan effective June 1, 2023. All plan assets were transferred to the GSP Navigator Pooled Employer Plan on June 1, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

June 30, 2023 and December 31, 2022

Note 1 - Description of Plan

The following description of the 401k Plan for Employees of Elsner Engineering Works Inc (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

The Board of Directors of the Company approved a resolution to merge the Plan into the GSP Navigator Pooled Employer Plan. All plan assets were liquidated and transferred to the GSP Navigator Pooled Employer Plan on June 1, 2023. The net assets transferred on June 1, 2023 represent investments at fair value of \$8,524,891.

General

The Plan was a defined contribution retirement plan covering all employees of Elsner Engineering Works, Inc. In order to participate in the Plan and to be eligible for employer matching and profit sharing contributions, employees must have reached age 18 and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Financial Statement Presentation

These financial statements include the period January 1, 2023 through June 30, 2023 and the year ended December 31, 2022. The Plan elected to defer the filing of its financial statements with its Form 5500 for the year ended December 31, 2022, as permitted by 29 CFR 2520.104-50, since the following plan year of January 1, 2023 through June 30, 2023 was a short year of seven months or less. Accordingly, the Plan has included a statement of net assets available for benefits as of June 30, 2023 and December 31, 2022, along with a statement of changes in net assets available for benefits for the period January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, as required by Department of Labor regulations when such election is made.

Contributions

Each year participants were able to contribute up to 80% of pre-tax annual compensation, as defined in the Plan document as a traditional pre-tax contribution, as an after-tax Roth contribution, or combination of the two, up to the maximum allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants were able to also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of all contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision, whereby all employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan within 30 days after the employee first becomes eligible for the plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The automatic deferral amount increased by 1% up to a maximum of 4% of the participants' eligible compensation. During the period January 1, 2022 through May 1, 2022, the Plan matched up to 50% of the participants' contributions, with a maximum match equaling 6% of the participants' eligible compensation contributed to the Plan. Effective June 1, 2022, the Plan amended the adoption agreement to remove employer matching contributions. The Plan could make an additional discretionary matching and profit sharing contribution. The Plan did not make any discretionary contributions for the period January 1, 2023 through June 30, 2023 and year ended December 31, 2022. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. Certain disbursement and participant note processing fees were also charged to the respective participants' account. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

A participant was 100% vested at all times in the participant's salary deferral account, rollover account, and the employer nonelective account regardless of the number of years of service. If participants ceased participation, other than by disability or death, the vested interest in the remainder of their accounts was dependent upon the years of credited service, as follows:

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years, unless the loan was to acquire the participant's principal residence, in which case, the loan could be for up to thirty years. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments under a systematic withdrawal plan.

Forfeited Accounts

At June 30, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0- and \$6,380, respectively. These accounts were first used to reduce employer contributions. Any remaining amounts were to be applied to administrative expenses. During 2023, \$7,054 of forfeited nonvested accounts were used to reduce administrative expenses. During 2022, \$13,751 of forfeited nonvested accounts were used to reduce employer contributions. A balance of \$5,955 of forfeited nonvested accounts was transferred out of the Plan as of June 30, 2023.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued, but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of June 30, 2023 and December 31, 2022.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Note 3 - Information Certified and Provided by Reliance Trust Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2023 through June 30, 2023 and year ended December 31, 2022, were obtained by management and agreed to, or derived from, information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and December 31, 2022.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interests in the collective trust funds are valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Company adopted a non-standardized pre-approved profit sharing/money purchase plan sponsored by ADP, LLC. The non-standardized plan has received an opinion letter from the IRS, dated October 6, 2020, stating that the non-standardized plan is qualified under the appropriate section of the Internal Revenue Code (IRC). The non-standardized plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, state, or local tax authorities for years before 2020.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
