Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Avast Software, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 6, 2023 (In Liquidation) and December 31, 2022 (In Liquidation), and the related statement of changes in net assets available for benefits for the period ended September 6, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Avast Software, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 6, 2023, and December 31, 2022, and for the period ended September 6, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

Basis for Opinion

Emphasis of Matter - Plan Termination

As disclosed in Note 1, Avast Software Inc., (the "Plan Sponsor"), has entered into a plan of merger with an acquiring company. As a result, the Board of Directors directed Fidelity Management Trust Company, the Plan's trustee, to terminate the Plan effective September 12, 2022. Such action included freezing the Plan to contributions and new participants, subject to the provisions of the Plan document and relevant regulations. All assets of the Plan were distributed as of September 06, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Avast Software, Inc. 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

1. DESCRIPTION OF THE PLAN

The following description of Avast Software, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by Avast Software, Inc. ("Avast") and its related employers (collectively the "Company" or the "Employer") was established January 1, 1998. Avast became a participating entity within ADP TotalSource Retirement Savings Plan ("ADP TotalSource"), a multiple-employer plan effective February 1, 2016. Effective July 14, 2017, the Plan was spun off from ADP TotalSource. The Plan includes participants from the following related employers:

- Remotium (acquired by the Company in July 2015),
- TACR Services, Inc. (formed by the Company in March 2013),
- Location Labs, Inc. (acquired in October 2014 by AVG Technologies USA, Inc., which, in turn, was acquired by the Company in July 2016, acquired by a new company on April 15, 2021), and
- AVG Technologies USA, Inc. (acquired by the Company in July 2016).

The Plan is designed to provide eligible participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, financial hardship or active duty military call-up. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security Cares (CARES) Act, related to participant loans and distributions. The Organization has until December 31, 2025, to amend the Plan for changes allowed by the CARES Act. The Plan has been formally amended to adopt these provisions as of October 27, 2023.

1. DESCRIPTION OF THE PLAN (continued)

General (continued)

During 2022, the Company entered into a Plan of Merger with an acquiring company. As a result, the Board of Directors of the Company directed Fidelity Management Trust Company (the "Trustee"), the Plan's asset custodian and trustee, to take action necessary to terminate the Plan effective September 12, 2022 (the "termination date"). Such action included freezing the Plan to contributions and new participants as soon as administratively feasible and making all participant accounts fully (100%) vested, subject to the provisions of the plan document and relevant regulations. Further, the Company authorized Fidelity to liquidate and distribute all Plan assets. The Plan Sponsor required all participants in the Plan to elect a lump sum distribution or direct rollover of his or her account balance to an eligible retirement plan or to an individual retirement account or annuity. If no direct rollover or distribution instructions were received from the participant within a reasonable time frame, as defined, the affected participant's account was automatically rolled over into a traditional or Roth individual retirement account based on the type of balance previously held in the participant's account. The Plan was fully liquidated on September 06, 2023.

Plan administration

The Company was the administrator of the Plan and, as such, carried out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Custody and Trustee services are provided by the Trustee, while record-keeping services are performed by Fidelity Workplace Services, LLC (the "Record-keeper"), an affiliate of the Trustee (collectively "Fidelity"). The Trustee manages the Plan's investments and makes investment transactions while the Record-keeper manages participant accounts and participant related transactions.

Eligibility

Before termination, all employees of the Company who attained the age of 21, except for leased employees, employees covered by a collective bargaining agreement, and non-resident aliens who do not receive earned income from the Employer representing United States source income, were eligible to immediately begin participating in the Plan.

Effective September 12, 2022, the Plan was terminated and no new employees were permitted to participate in the Plan after that date.

Participant accounts

Each participant's account was credited with the participant's contributions or rollovers and allocations of (a) the Company's contributions, and (b) Plan earnings and losses and an allocation of administrative expenses not paid directly by the Company. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchase. Other allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participant contributions

Before Plan termination, participants could elect to contribute through payroll deductions amounts up to 95% of their annual compensation, as defined by the Plan, on a pre-tax or after-tax (as Roth contributions) basis, up to a maximum amount allowed by the Internal Revenue Code (IRC). Participants who attained age 50 before the end of the Plan year were additionally eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

Employer contributions

Before Plan termination, the Company was authorized to make discretionary matching and discretionary non-elective contributions to the Plan. During 2022, the Company made discretionary matching contributions to the Plan equal to 50% of up to the first 8% of eligible compensation, as defined in the Plan, for all participants who were employed by the Company as of Plan termination. To be eligible to receive discretionary non-elective contributions, participants must be both credited with at least 501 hours of service during the Plan year and be employed by the Company as of the last day of the Plan's year. The Company did not make any discretionary matching and discretionary non-elective contributions for the period ended September 06, 2023.

Vesting

Participants were immediately 100% vested in Employee contributions, plus actual earnings thereon.

Participants vest into the Company's discretionary matching and discretionary non-elective contributions made on or after July 14, 2017, plus actual earnings thereon, after one year of credited service, as defined in the Plan.

Participants who terminated employment with the Company on or before July 14, 2017, were vested in the Company's matching contributions made prior to July 14, 2017, plus actual earnings thereon, ratably over a period of five years, as defined by the Plan.

Vesting (continued)

Notwithstanding the above provisions, all participants became fully vested upon Plan termination.

Forfeited non-vested accounts

Forfeited non-vested accounts may be used to either pay Plan expenses or reduce the Company's contributions to the Plan. As of September 06, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$44,687, respectively. In 2023, \$49,631 was used to pay Plan fees from forfeited nonvested accounts.

Notes receivable from participants

Before Plan termination, participants could borrow against their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms were generally five years or less, but could exceed five years if the purpose of the loan was to purchase a principal residence. The notes receivable were secured by the remaining balance in the participant's account and bear interest at the prime lending rate plus 1%. As of September 06, 2023 and December 31, 2022, the balance of notes receivable are \$0 and \$23,288, respectively.

Payment of benefits

Before Plan termination, distributions and withdrawals were payable upon retirement, attainment of age 59 1/2, termination, financial hardship, disability, or death. Upon termination, unless otherwise elected, if a participant's vested account balance was equal to or less than \$1,000, the balance was distributed as a lump-sum cash payment. Upon termination, if a participant's vested account balance was greater than \$1,000, participants could elect to receive a distribution of their vested account balance as a lump-sum distribution or postpone payment to a later date and remain in the Plan.

Hardship and qualified reservist distributions were permitted under limited circumstances if approved by the plan administrator.

Notwithstanding the above provisions, as of Plan termination, all participants can elect to distribute their account balance according to the participant's election.

Administrative expenses

Administrative expenses were generally paid by the Company, but may, at the discretion of the plan administrator, be paid by the Plan. Investment fees, which may vary according to the individual funds selected, are paid indirectly out of the assets of the Plan and impact Plan earnings. Transaction fees for certain participant-initiated activity are charged to the specific account of the participant initiating any such transaction. The Plan is not required to reimburse the Company for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared on the liquidation basis of accounting as of and for the period ending September 06, 2023, and as of December 31, 2022, in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits and changes therein.

Contributions and contribution receivables

Contributions from participants were recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date.

Contributions from the Company were recorded in the year earned to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants were recorded based on the date the contributions are received by the Trustee.

Investment valuation and income recognition

The Plan's investments were stated at fair value. Shares of registered investment companies ("mutual funds") were valued at quote market prices which represent the net asset value (NAV) of shares held by the Plan as of year-end. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded when it is earned. No allowance for credit losses has been recorded as of September 06, 2023 and December 31, 2022.

Payment of benefits

Benefits were recorded when paid.

Administrative expenses

Expenses were recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through April 9, 2024, the date the financial statements were available to be issued. No other subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of September 06, 2023 and December 31, 2022.

- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period ended September 06, 2023.

Accordingly, as requested by the Plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the financial statements.

4. FAIR VALUE MEASUREMENTS

Accounting standards define fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Fair value is based on current market quotes as available and is supplemented by modeling techniques and assumptions made by the Plan to the extent quoted market prices are not available.

The Plan determines the fair values of its investments based on the fair value hierarchy established by accounting standards, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

The three levels of fair value hierarchy are as follows:

Level 1: inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2: inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3: inputs are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at September 06, 2023 and December 31, 2022.

Mutual funds and money market fund: Valued at the daily closing price as reported on an open exchange. Mutual and money market funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All assets were liquidated as of September 06, 2023.

5. TAX STATUS

The Plan adopted Fidelity's Volume Submitter Defined Contribution Plan Basic Plan Document No. 17. The Internal Revenue Service informed Fidelity by a letter dated June 30, 2020, that its plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and has been operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to the definition of a related party in financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the period related to compensation arrangements, expense allowances, or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain fees and expenses of the Plan are paid by the Company. The Plan is not required to repay expenses paid by the Company on its behalf.

The Trustee retains, as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

The Plan has included in their investment fund options certain funds managed by the Trustee or one of their affiliates. As the Plan's Trustee, these transactions qualify as exempt party-in-interest transactions.
