Disclosure Plan Report

On April 29, 2022, California Hispanic Commission on Alcohol & Drug Abuse, Inc. (“Debtor”) the Plan’s nonprofit Debtor/Plan Sponsor filed bankruptcy in the Eastern District of California, under the provisions of Chapter 7 of the bankruptcy code and was assigned Case Number 22-21095-A7.

The Plan’s Administrator, Susan K. Smith, the Chapter 7 Trustee (“Trustee”), prepared this Disclosure Plan Report.

The Debtor ceased operation on April 22, 2022 and the Trustee has limited books and records of the Debtor/ Plan Sponsor. The Trustee has no access to any persons with knowledge about the books and records, or employee transactions.

The Debtor is insolvent and does not have any funds available to pay for a Plan audit. Because the Debtor/ Plan Sponsor does not have complete books and records a Plan audit would likely be impaired. In any case, a Plan audit, if funded from participants’ funds, will merely result in a reduction of distributions to the participants. For those reasons, no Plan audit has been performed.

Bankruptcy Code §704(a)(11) states that:

(a) The trustee shall—

II) if, at the time of the commencement of the case, the debtor (or any entity designated by the debtor) served as the administrator (as defined in section 3 of the Employee Retirement Income Security Act of 1974) of an employee benefit plan, continue to perform the obligations required of the administrator

Thus, the Trustee is charged with performing the obligations of the Plan Administrator of employee benefit plan.

IRS/DOL requires the Form 5500 to be electronically filed and signed by the Plan Administrator. In order to comply with the IRS/DOL, the Trustee signed the Form 5500 in the mandatory field, to perform the obligations required of the Plan Administrator, pursuant to Bankruptcy Code §704(a)(11). However, the Trustee is **NOT** the Plan Administrator, and is merely performing the obligations required to administer and wind down the plan in a timely manner.

The Trustee is filing the Form 5500 to comply with Section 704(a)(11) of the Bankruptcy Code and the filing deadline. The filing of this form is not an admission or determination of any contributions or excise taxes owing for the plan year, nor is this filing an admission of the character of any claim for contribution or excise penalty. Also, this filing is not to be relied upon for determination of any amount owing, nor treated as an admission of whether there exists any administrative, pre-petition priority or other claim in the Debtor’s bankruptcy case for employer contributions and related excise taxes.
