Opinion

We have audited the accompanying financial statements of Bowl America Incorporated 1987 Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the Statements of Net Assets Available for Benefits as of June 30, 2023 and 2022 (in Liquidation), and the related Statement of Changes in Net Assets Available for Benefits for the year ended June 30, 2023 (in Liquidation), and the related notes to the financial statements.

As a result, the financial statements are presented on the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


Auditor's Responsibilities for the Audit of the Financial Statements

Notes to Financial Statements

1. **Description of the Plan** The following description of the Bowl America Incorporated 1987 Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: Bowl America Incorporated (the "Company") established the Plan effective June 30, 1986. The Plan was a defined contribution plan covering substantially all employees of the Company who had completed one year of service of at least 1,000 hours, excluding leased employees and employees covered under collective bargaining agreements. Entry dates were June 30 or December 29 subsequent to satisfying the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On July 30, 2021, the Company's Board of Directors elected to terminate the Plan effective with the sale of the Company. In August 2021, the Company was acquired by Bowlero Corp and all shares of stock held by the Plan were purchased in connection with the acquisition. As a result of the sale of the Company, the Plan was terminated effective August 15, 2021. Effective with the Plan termination no new entrants were permitted to the Plan and all participants became fully vested in their accounts. Distributions will be paid to participants subsequent to receiving a favorable determination letter from the Internal Revenue Service ("IRS") approving the Plan termination. This favorable determination letter was received on June 27, 2022. Final payments to participants began in December 2022 and were completed in April 2023. The final expense related to the 2023 Plan year was paid in July 2023 and accrued on the Statement of Net Assets Available for Benefits (in Liquidation) as of June 30, 2023.

Contributions: Employer contributions to the Plan were determined annually by the Company's Board of Directors. Contributions to the Plan could be paid in cash or in shares of Company stock. Participants had to have completed 1,000 hours of service and be employed on the last day of the Plan year to be eligible to receive an allocation of the employer contribution. There were no such contributions for the Plan year ended June 30, 2023. Contributions were subject to certain limitations.

Notes to Financial Statements

Participant accounts: Each participant's account was credited with an allocation of Company contributions, if applicable, investment earnings and losses, forfeitures of terminated participants' non-vested accounts, and charged with an allocation of administrative expenses. Allocations of employer contributions and forfeitures were based on participant compensation, as defined by the Plan document. Allocations of investment earnings and losses and administrative expenses were based on the account balances, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Payment of benefits: Benefits were payable upon retirement at age 65, disability, death, or termination of employment. Withdrawals at age 65 were also permitted, regardless of whether or not participants were active employees. Benefits were payable in a lump sum, distribution in-kind or substantially equal installment payments not to exceed five years. The final distributions to participants were paid in lump sum payments.

Vesting: Vesting in the employer contributions was based on years of continuous service of at least 1,000 hours per year. A participant was 20 percent vested after two years of service was completed, and vested an additional 20 percent per year until full vesting after six years. Different vesting schedules could have applied to account balances of participants due to prior Plan provisions as described in the Plan document.

Effective August 15, 2021, upon Plan termination, all participants became fully vested.

Forfeitures: Forfeitures of terminated participants' non-vested accounts could be used to pay administrative expenses of the Plan. Any forfeited accounts not used for expenses were allocated to remaining participants on an annual basis as of the last day of the Plan year. Participants must have had completed 1,000 hours of service and had been employed on the last day of the Plan year to be eligible to receive an allocation of the forfeitures. For the year ended June 30, 2023 there were no forfeitures allocated to participants or used to pay Plan expenses.

Diversification: Diversification was offered to participants close to retirement so that they would have the opportunity to move part of the value of their investment in Company stock into investments that were more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan were able to elect to diversify a portion of their account. Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant could diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changed to 50%.

Voting rights: Each participant was entitled to exercise voting rights attributable to the shares allocated to his or her account and was notified by the Trustees prior to the time that such rights were to be exercised. The Trustees were not permitted to vote any allocated share for which instructions had not been given by a participant. The Trustees were required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as distribution administration fees are charged directly to the participant's account and are included in administrative expenses.

2. Significant accounting policies

Basis of accounting: As a result of the Plan's termination (see Note 1) the Plan's financial statements have been prepared on the liquidation basis of accounting.

Cash and cash equivalents: Cash and cash equivalents consisted of cash on hand and demand deposits in bank accounts with maturities of ninety days or less. The Plan maintained cash balances at two commercial banks, these balances could exceed the FDIC insured deposit limit of \$250,000 per financial institution. At June 30, 2023, the Company's cash balance held at commercial banks did not exceed the FDIC limit. At June 30, 2022, the Company's cash balance held at commercial banks exceeded the FDIC limit by approximately \$3 million. The Plan has not experienced any losses through the date when the financial statements were available to be issued.

Payment of benefits: Benefits were recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through April 10, 2024, which is the date the financial statements were available to be issued.

3. Tax status

The IRS has determined and informed the Plan administrator by letter dated July 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

On June 27, 2022, the Plan received a favorable determination letter with respect to the termination of the Plan effective August 15, 2021.

4. Plan termination

As described in Note 1, on July 30, 2021, the Company's Board of Directors elected to terminate the Plan effective August 15, 2021. Payments to participants commenced in December 2022 and were completed in April 2023.

5. Party-in-interest transactions

During the year ended June 30, 2023, approximately \$43,000 was paid to the Plan's recordkeeper and custodian for services provided to the Plan. At June 30, 2023, \$4,860 is due for these services and reported as accrued expenses on the Statement of Net Assets Available for Benefits (in Liquidation). There were no accrued expenses as of June 30, 2022. These transactions qualify as exempt party-in-interest transactions.
