## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants in the  
ILF - CPT 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of ILF - CPT 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of ILF - CPT 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

### FOR THE PERIOD NOVEMBER 15, 2021 (DATE OF INCEPTION) TO JUNE 30, 2023

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the ILF - CPT 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**—The Plan is a defined contribution plan covering employees of Interload Forwarding, LLC and Carmen Pacheco Transportation, LLC, collectively (the "Company"). The Plan requires employees to have six months of employment and be 21 years of age to be eligible to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Participant Accounts**—Each participant's account is credited with both the participant's contribution and the employer's matching contribution and allocations of (1) the participant's share of net earnings of the respective investment accounts of the Plan and (2) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant compensation and participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from that participant's vested account.

**Contributions**—Each year, participants may contribute to the Plan on a pretax basis up to the maximum percentage allowable, subject to certain Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company matches 100% of participant contributions up to 3% of their eligible compensation per pay period.

**Vesting**—Participants are immediately vested in their contributions plus actual earnings upon enrollment. Vesting in the Company's matching and elective contributions plus actual earnings thereon is according to years of service. Participants are fully vested in these contributions after three years of service.

**Payment of Benefits**—On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures**—Forfeitures of the employer's contributions and earnings thereon resulting from participants leaving the Company are retained in a forfeiture account. Forfeitures are allocated to all participants eligible to share in the matching allocations in proportion to each participant's compensation for the year. As of June 30, 2023, the forfeiture balance that may be used towards future employer contributions and plan expenses was \$2,341. There were no forfeitures for the period ended June 30, 2022.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**—Investments are valued at their fair value, based on quoted market prices. Net appreciation (depreciation) consists of the unrealized appreciation (depreciation) of the investment and the excess (deficiency) of net proceeds over market value of the related investment at the beginning of the year. Purchases and sales are recorded on a trade-date basis. Interest is recorded on an accrual basis and dividends are recorded on the ex-dividend date.

**Use of Estimates in the Preparation of Financial Statements**—The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**—Administrative expenses of the Plan are paid by the Plan or the Plan's sponsor as provided in the Plan document.

**Subsequent Events**—Subsequent events were evaluated through March 27, 2024, which is the date the financial statements were available to be issued.

## 3. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the unaudited information regarding the Plan as of June 30, 2023 and 2022, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Principal Life Insurance Company, Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustees of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustees that such information is complete and accurate.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023.

The unallocated investment options consist of guaranteed interest accounts under a guaranteed benefit policy, and separate accounts of Principal Life Insurance Company ("Principal Life"). The guaranteed interest accounts are reported at fair value while the separate accounts are reported at NAV as determined by Principal Life. These unallocated investment options are non-benefit-responsive.

##### *Guaranteed Interest Accounts*

The guaranteed interest accounts cannot be sold to a third party; thus, the only option to exit the guaranteed interest accounts is to withdraw or transfer the funds prior to maturity for an event other than death, disability, termination, or retirement. The fair value represents guaranteed interest account values adjusted to reflect current market interest rates only to the extent such market rates exceed contract crediting rates. This value represents contributions allocated to the guaranteed interest accounts, plus interest at the contractually guaranteed rate, less funds used to pay Plan benefits and Principal Life's administrative expenses. The fair value of the guaranteed interest accounts is reflected in Level 3.

## Separate Accounts

Separate accounts are designed to deliver safety and stability by preserving principal and accumulating earnings. The separate account assets include, but are not limited to, contributions invested in domestic and international common stocks, high-quality short-term debt securities, real estate, private market bonds and mortgages, and high-yield fixed income securities that are slightly below investment grade, all of which are valued at fair value. The NAV of each of the separate accounts is calculated in a manner consistent with GAAP for investment companies and is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. The fair value of the underlying funds and securities is used to determine the NAV of the separate account, which is not publicly quoted. The fair value of the underlying mutual funds and equity securities are based on quoted prices of identical assets. The fair value of the underlying fixed income securities are based on third-party pricing vendors that utilize observable market information. The fair value of all separate accounts is reflected in Level 2.

## Collective Investment Trusts

The Collective Investment Trusts ("CITs") invest in growth and value stocks of small, medium and large market capitalization companies, fixed-income securities, domestic and foreign securities, securities denominated in foreign currencies, investment companies (including index funds), securitized products, U.S. government and U.S. government-sponsored securities and derivatives. The NAV of the CITs is calculated in a manner consistent with GAAP for investment companies and is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. The fair value of the underlying funds and securities is used to determine the NAV of the CITs. The CITs are reflected in Level 2.

**5. TAX STATUS**

Although the Plan has not requested determination from the Internal Revenue Service as to the Plan's tax-exempt status, the prototype plan from which the Plan was drafted has received a favorable determination from the IRS. The trustees and the third-party administrator believe that the Plan is designed to operate in accordance with all applicable provisions of the Internal Revenue Code. Therefore, the trustees, as well as the third-party administrator, believe that the Plan is qualified and that the related trust is exempt from taxation under the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of June 30, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan by delivering to the trustee and Plan administrator written notice of such termination, subject to the provisions of ERISA. In the event of plan termination, interests not previously vested will become immediately, completely vested and nonforfeitable.

## 7. RELATED PARTY TRANSACTIONS

Certain Plan investments are invested in accounts held and managed by Principal Life Insurance Company. Principal Life Insurance Company is the Plan's trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

Administrative expenses not paid by the plan are paid by the plan sponsor, Interload Forwarding, LLC and Carmen Pacheco Transportation, LLC.

## 8. EXCESS CONTRIBUTIONS

As of June 30, 2023, excess contributions in the amount of \$22,957 were recorded. These amounts consist of employee contributions and earnings made by participants not eligible to participate in the plan.

## 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
