Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Purolite 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 22, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 to June 22, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 22, 2023 and December 31, 2022 and for the period January 1, 2023 to June 22, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

(1) Description of Plan

The following description of the Purolite 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on August 1, 1982 that covers all eligible employees of Purolite LLC (the Company). The Plan was amended and restated on December 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company entered into a stock and asset purchase agreement with Ecolab Inc. on October 28, 2021. As a result of this agreement, the Board resolved that the Company became a participating employer in the Ecolab Savings Plan and ESOP (Ecolab Plan) effective June 9, 2023. Effective June 22, 2023, the net assets of the Plan were merged into the Ecolab Plan.

Eligibility

The Plan covers all of the Company's employees except those employees who are members of a collective bargaining agreement and non-resident aliens. Employees who have completed three months of service and who are age 21 or older are eligible to immediately participate in the Plan. All eligible participants are automatically enrolled into the Plan at a deferral rate of 5% of compensation, as defined by the Plan, unless the participant makes a contrary election. Effective January 1, 2023, employees were no longer auto-enrolled at 5% after three months of service. Eligibility began immediately upon hire.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document. Effective January 1, 2023, participants are no longer allowed to make flat dollar deferral elections. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

In addition, the Company may make discretionary matching contributions equal to 50% of the employees' deferral amount or a discretionary amount determined each year by the Company. Effective January 1, 2023, the Company made a discretionary matching contribution equal to 100% of the first 4% of the employees' deferral amount and 50% of the next 4% of the employee deferral, for a maximum match of 8%. Employees no longer are allowed to make flat dollar deferrals as of January 1, 2023.

Contributions

Additional profit-sharing amounts may also be contributed at the option of the Company. In order to be eligible for the discretionary profit-sharing contribution, the employee must be employed by the Company on the last day of the plan year and have completed at least 1,000 hours of service during the plan year (with the exception of death or retirement on or after age 65). No profit-sharing contribution was declared by the Company for the period ended June 22, 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and an allocation of the Company profit-sharing contributions, as well as plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Effective December 1, 2021, participants are 100% vested in the Company's matching and discretionary contribution portion of their accounts. Prior to December 1, 2021 vesting in the Company's matching and discretionary contribution portion of their accounts were based on years of credited service. A participant becomes 20% vested after two years and 20% per each subsequent year of service up to 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon death, or upon reaching normal retirement age (age 65).

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at rate commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms shall not exceed five years.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or annual installments over a period of not more than the participant's assumed life expectancy, as determined at the time of distribution. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the plan administrator will authorize the transfer of the participant's balance to an individual retirement account established on behalf of the participant. If the balance of the terminated participant's account is below \$1,000, the participant's vested account balance shall be distributed in a lump sum.

Forfeited Accounts

At June 22, 2023, all forfeited nonvested accounts were transferred to the Ecolab Plan. At December 31, 2022, forfeited nonvested accounts totaled \$20,032. These accounts may be used to pay plan expenses and to then to reduce future employer contributions. During 2023, \$11,584 and \$241 were used to reduce plan expenses and employer contributions, respectively.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 22, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through April 10, 2024, the date the financial statements were available to be issued.

(3) Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 22, 2023 and December 31, 2022, and net appreciation in fair value of investments and interest income on notes receivable from participants for the period ending June 22, 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosure*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 22, 2023 and December 31, 2022. All Plan assets were transferred out of the plan effective June 22, 2023.

Pooled separate accounts: Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There were no significant transfers among investment levels during the period or year ended June 22, 2023 and December 31, 2022.

The Plan's pooled separate accounts are invested in a variety of funds designed to mirror the investment strategies of similar registered investment companies (mutual funds), including equity style funds, fixed income style funds, and blended funds. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account, the custodian reserves the right to temporary delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

(5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are pooled separate accounts managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contributions. All plan assets were transferred out of the Plan effective June 22, 2023.

(7) Tax Status

The Plan uses a prototype plan document sponsored by CCH Incorporated. The IRS has determined and informed CCH Incorporated, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Prohibited Transaction

During 2023 and 2022, the Company failed to remit to the Plan's custodian certain employee contributions amounting to \$650 and \$346, respectively, within the period prescribed by the DOL regulations. The Company intends to correct the affected participant's account balance and compensate the participant for the lost earnings as soon as administratively possible.
