INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Operating Engineers Local No. 825 Retiree Welfare Fund

Opinion

We have audited the accompanying financial statements of the Operating Engineers Local No. 825 Retiree Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Operating Engineers Local No. 825 Retiree Welfare Fund, as of June 30, 2023 and 2022, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Operating Engineers Local No. 825 Retiree Welfare Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED JUNE 30, 2023 AND 2022

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Operating Engineers Local No. 825 Retiree Fund (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a self-insured defined benefit health and welfare plan which was established in accordance with an agreement entered into by and among the International Union of Operating Engineers (IUOE) Local No. 825 and the Associated General Contractors of New Jersey and New York, Building Contractors Association of New Jersey, Structural and Ornamental Iron Association of New Jersey and other contractor associations and independents.

Members who retire under the Operating Engineers Local No. 825 Pension Plan are eligible to purchase health coverage under the Plan. The maximum amount of coverage allowable is determined in part due to years of credited service and varies from a half year of coverage to lifetime eligibility. Participants are covered for various types of medical expenses and benefits depending on the level within the benefit program into which they fall. Prior to July 1, 2013, these benefits were provided to members through the Operating Engineers Local No. 825 Welfare Fund (the Welfare Fund).

The Plan is administered by a Board of Trustees composed of employer and employee representatives. It is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 30, 2023, the Plan was terminated. The benefits will be provided to members through the Operating Engineers Local No. 825 Welfare Fund (the Welfare Fund) going forward.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Plan's financial statements are prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Contributions - Contributions reported on the financial statements include amounts allocated from employer contributions made to the Welfare Fund, sufficient to cover benefit and administrative expenses of the Plan. Accordingly, an allowance for doubtful accounts has not been established.

Benefits - Benefits are recorded when paid.

Administrative Expenses - Expenses of the Plan are paid by the Plan.

Tax Status - The Plan is administered under the same trust as the Welfare Fund. This trust is exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan accounts for income taxes in accordance with the Accounting Standards Codification (ASC) Topic *Income Taxes*. These provisions provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribed a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Plan performed an evaluation of uncertain tax positions for the years ended June 30, 2023 and 2022 and determined that there were no matters that would require recognition in the financial statements or that may have an effect on its tax-exempt status. As of June 30, 2023, the statute of limitations for the tax years 2019 through 2021 remain open with the U.S. Federal jurisdiction and the various states and local jurisdictions in which the Plan files returns.

Use of Estimates - The preparation of the financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual amounts could differ from those estimates.

NOTE 3. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan pays certain administrative, investment, and professional fees to various service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

The Plan is administered at some levels in common with the Welfare Fund. The Welfare Fund processes employer contributions and handles the collections with the Plan sharing in the costs by reimbursing for salary and benefits. Salaries and operating expenses including depreciation are allocated to the Plan from the Welfare Fund. Amounts allocated from the Welfare Fund were \$1,148,966 and \$977,753 for the years ended June 30, 2023 and 2022, respectively. Allocated depreciation expense was \$31,487 and \$28,485 for the years ended June 30, 2023 and 2022, respectively.



NOTE 4. BENEFIT OBLIGATIONS

Plan benefit obligations for health claims incurred by retired participants but not reported at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles.

Postretirement Benefits - The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to June 30. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employees' service in the industry rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and existing Plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money and the probability of payment between the valuation date and the expected date of payment.

The plan amendment represents the transfer of the post-retirement benefit obligation to the Operating Engineers Local No. 825 Welfare Fund.

The actuarial amounts were prepared by O'Sullivan Associates Inc., the Plan's consulting actuary, and are based upon their latest actuarial valuation as of June 30, 2023 and 2022.

The following were other significant assumptions used in the valuations as of June 30, 2023 and 2022:

Medical trend rates - 6.0% decreasing by 0.5% per year to 3.0% for 2023 and 2022.

Discount rates - 4.00% for 2023 and 2.75% for 2022.

Mortality rates - PRI-2012 Blue Collar (Sex Distinct) using Scale MP-2021 for 2023 and 2022.

NOTE 4. BENEFIT OBLIGATIONS (CONTINUED)

The medical trend rate assumption has a significant effect on the amounts reported. If the assumed rate was increased by one percentage point, in each year, it would increase the postretirement obligation as of June 30, 2023 and 2022 by \$23,212,797 and \$27,375,270, respectively.

From June 30, 2022 to June 30, 2023, total retiree postretirement benefit obligation decreased by \$18,297,403. This was due to a change in actuarial assumptions of \$16,783,426 and benefits paid during the year. This was partially offset by an experience loss of \$4,813,784 and an increase due to the passage of time.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The actuarial assumptions and techniques are related primarily to participants' data and to reasonable expectations, and represent an estimate of anticipated experience under the Plan. Actual results may differ from these assumptions.

NOTE 5. PLAN TERMINATION

In the event of termination of the Plan, the Trust funds are to be used to continue payment of the benefits provided for in the Plan to eligible employees, their dependents and beneficiaries or next of kin and to otherwise effectuate the purpose of the Plan.

NOTE 7. RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates and employee demographics, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 8. SUBSEQUENT EVENTS REVIEW

Subsequent events have been evaluated through April 9, 2024, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
