Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have audited of the financial statements of East Coast Mechanical, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"), which comprise the statements of net assets available for benefits as of June 30, 2023 (In Liquidation) and December 31, 2022 (Ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through June 30, 2023 (In Liquidation), and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2023 (In Liquidation) and December 30, 2022(Ongoing), and the changes in its net assets available for benefits for period from January 1, 2023 through June 30, 2023 (In Liquidation) and the year ended December 31, 2022 (Ongoing), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Notes 1 and 5 to the financial statements, the Plan's sponsor, approved a plan of liquidation on March 31, 2023, and management determined liquidation is imminent. As a result, East Coast Mechanical, Inc. changed its basis of accounting from the accrual basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note 1 - Description of Plan

The following description of the East Coast Mechanical, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all full-time employees of East Coast Mechanical, Inc. (the "Company") who had one year of service and are age 19 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator was responsible for oversight of the Plan. The Investment Committee determined the appropriateness of the Plan's investment offerings, monitors investment performance.

Plan termination

On December 1, 2022, East Coast Mechanical, Inc. announced the sale of the Company. Effective January 27, 2023, the Plan was amended to cease employee and discretionary employer contributions into the Plan. The amendment also initiated the termination process of the Plan effective March 31, 2023. Plan management has fully liquidated the Plan as of June 30, 2023.

As a result of the termination, in accordance with account principles generally accepted in the United States of America ("GAAP"), the financial statements are presented on the liquidation basis of accounting for periods after December 31, 2022 (see Note 2).

Contributions

Prior to the Plan termination, each year participants could contribute up to 80% of pre-tax annual compensation, as defined in the Plan agreement. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participant contributions were recorded in the period during which the Company made payroll deductions from the participant's earnings. Participants could have also made rollover contributions from other qualified plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company contributed 25% of the first 6% of base compensation that a participant contributed to the Plan for January 2023 payroll only. Participants must have been employed on the last day of the Plan year to receive these contributions. Employer contributions were invested directly in the Plan's pool of investments elected by participants. Contributions were subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts are based on years of continuous service. Vesting started after two years of service and vests ratably at 20% per year, becoming 100% vested after six years of credited service. If a participant terminated employment due to death, disability, or attainment of age 65, they became 100% vested in their unvested employer matching contributions. Following the decision to terminate the Plan, all participants became 100% vested in their account balances.

Notes receivable from participants

Prior to the Plan termination, participants could borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the loan must not exceed five (5) years, except for a home loan for which the term is for a period of no greater than 30 years. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 2% above the prime rate, as defined. Principal and interest was paid ratably through monthly payroll deductions. Following the decision to terminate the Plan, all participant loan balances were paid.

Forfeited accounts

Prior to the Plan termination, when a participant was terminated, nonvested contributions were forfeited. At June 30, 2023 (In Liquidation) and December 31, 2022 (Ongoing), there were no unused forfeited nonvested Company contributions. These accounts could have been used first to reduce the employer's nonelective contribution, then restore participant forfeitures and then offset Plan expenses. There were no forfeited amounts used to reduce employer contributions during the period from January 1, 2023 through June 30, 2023 (In Liquidation) and the year ended December 31, 2022(Ongoing).

Payment of benefits

On termination of service due to death, disability or retirement, a participant would have elected to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Prior to the Plan termination, terminated participants with amounts less than \$5,000 were automatically distributed to the participant.

Note 2 - Summary of accounting policies

Basis of accounting

In accordance with GAAP, due to the termination of the Plan on March 31, 2023 (see Notes 1 and 5), the financial statements for the period from January 1, 2023 through June 30, 2023 (in Liquidation) were prepared using the liquidation basis of accounting to determine the amounts at which Plan assets are stated. The financial statements as of and for the year ended December 31, 2022 (Ongoing) were prepared using the Accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance GAAP required management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses have been recorded as of December 31, 2022 (Ongoing).

Payment of benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through April 9, 2024, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 (Liquidation) and December 31, 2022 (Ongoing).

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Related party transactions and party-in-interest transactions

Prior to plan termination certain Plan investments were invested in funds managed by Reliance Trust Company. Reliance Trust Company was the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain participants of the Plan had outstanding loans (notes receivable from participants) with the Plan at December 31, 2022 (Ongoing) of \$41,397. These loans were considered party-in-interest transactions according to the Department of Labor ("DOL") guidelines.

Note 5 - Plan termination

As discussed in Note 1, the Plan was terminated effective March 31, 2023, subject to the provision of ERISA. The participant directed net assets were distributed to participants on June 21, 2023. Effective June 30, 2023, the Plan was completely liquidated and final distributions of nonparticipant-directed investments from the Plan were distributed to participants.

Note 6 - Tax status

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan was designed, and operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
