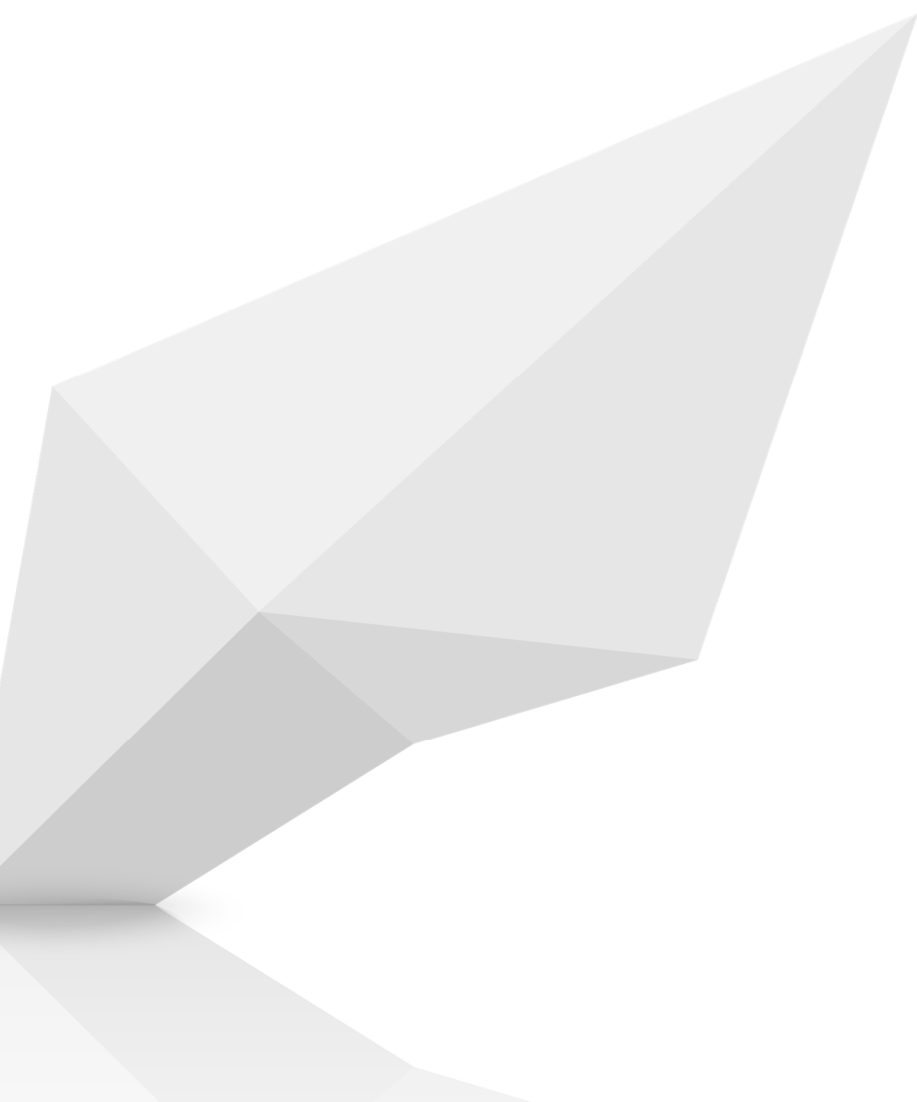

We have performed audits of the financial statements of Tri-County Memorial Hospital, Inc. Tax Deferred Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

---

### **Note 1: Description of Plan**

The following description of the Tri-County Memorial Hospital, Inc. Tax Deferred Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Tri-County Memorial Hospital, Inc. d/b/a Gundersen Tri-County Hospital and Clinics (the "Hospital") is the plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and therefore provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed. Participants are eligible to defer immediately upon hire. Participants who are age 21 and have one year of service are eligible for the Hospital's matching contributions.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the maximum allowable limits under the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Hospital contributes a discretionary matching contribution that is based on the participant's total eligible compensation. For the Plan years ended June 30, 2023 and 2022, the Hospital matched 100% of the first 3% of compensation, plus 50% of the next 4% of compensation contributed by the participant.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Hospital's matching contributions, and Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Hospital's contribution portion of a participant's account is based on years of service. Hospital contributions vest according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
1	25 %
2	50 %
3	75 %
4	100 %

Participants are considered to have completed one year of service for purposes of vesting upon completion of 1,000 hours of service at any time during the Plan year.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or an annuity. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. The Plan also allows for qualifying hardship distributions. Under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), the Plan allows individuals impacted by the coronavirus to withdraw up to \$100,000 from the Plan, with certain tax exceptions.

#### Forfeitures

At June 30, 2023 and 2022, forfeited nonvested accounts totaled \$61,340 and \$58,653, respectively. These accounts will be used to reduce future Hospital contributions or to pay administrative expenses of the Plan in accordance with the Plan document. During the year ended June 30, 2023, forfeitures in the amount of \$0 were used to pay administrative expenses, and \$0 in forfeitures were reallocated as an additional Hospital matching contribution.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for FBRICs, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully benefit-responsive investment contracts (FBRICs) are recorded at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in total investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through April 10, 2024, which is the date the financial statements were available to be issued. The Plan has determined there are no such events that require further disclosure.

### **Note 3: Information Prepared and Certified by the Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments held at June 30, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the year ended June 30, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., the Custodian of the Plan.

### **Note 4: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable for the asset or liability.

### Note 4: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2023 and 2022.

*Money market:* Valued using \$1 per share which approximates fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 5: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan invests in several FBRIC's with Lincoln Financial Group Trust Company, Inc. (Lincoln) in the form of a guaranteed investment contract (GIC) that invests in bonds. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **Note 5: Fully Benefit-Responsive Investment Contracts (FBRICs) (Continued)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The rate was 1.70% at June 30, 2023. Such interest rates are reviewed semiannually for resetting.

A Sponsor-level liquidation or Sponsor-initiated transfer of the Plan's interest in the GIC will be subject to either a two-month irrevocable advance notice or a 5% surrender charge, whichever the Sponsor chooses. Participant-initiated transfers from the GIC may also be subject to the 5% surrender charge when the transfers are requested in anticipation of the Sponsor-level liquidation of the Plan's interest in the contract. If this scenario occurs, the surrender charge will be billed to the Sponsor.

Other events may limit the Plan's ability to transact at contract value. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the participants or issuer are probable of occurring.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are managed by Lincoln Financial Group. Lincoln Financial Group is the custodian, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees for the investment management services during the Plan year ended June 30, 2023, were offset against earnings. Administration expense incurred and paid by the Plan was \$26,652 for the year ended June 30, 2023.

Certain plan expenses are for advisor fees to Global Retirement Partners. Global Retirement Partners is the advisor, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Administration expense incurred and paid by the Plan was \$17,918 for the year ended June 30, 2023.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Hospital contributions.

### **Note 8: Tax Status**

The Plan's terms have been drafted in reliance on the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for Plan participants. The Plan's management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

### Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 11: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Hospital is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Hospital's general assets, but no later than the fifteenth business day of the month following the date participant contributions are withheld by the Hospital. As reported on Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the Plan year ended June 30, 2023, totaling \$127,967, were remitted outside the requirement. These transactions constitute a prohibited transaction as defined by ERISA.
