The financial statements comprise the statements of net assets available for benefits as of September 12, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the eight and a half months then ended (in liquidation), and the statements of net assets available for benefits as of December 31, 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Southland Envelope Company, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 12, 2023 and December 31, 2022, and for the eight and a half months ended September 12, 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Southland Envelope Company, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Plan Termination and Basis of Accounting**

As discussed in Notes 1 and 5 to the financial statements, the governing body of Southland Envelope Company Inc. 401(k) Profit Sharing Plan approved a resolution to terminate the plan on January 5, 2023, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the accrual basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Southland Envelope Company, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Southland Envelope Company, Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Southland Envelope Company, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedule of assets held for investment purposes at end of year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1. Description of the Plan and Significant Accounting Policies**

**Description of the Plan**

The following brief description of the Southland Envelope Company, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. For additional information concerning the Plan's provisions, participants should refer to the Plan Agreement and Summary Plan Description.

**General** – The Plan is a defined contribution plan covering all full-time employees of Southland Envelope Company, Inc. (the Company or Plan Sponsor), and is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company has appointed Fidelity Management Trust Company as the custodian of the plan assets with authority over management and investment of plan assets.

As of January 5, 2023, the Company exercised its right under the Plan to discontinue its contributions and to terminate the Plan. All assets had been distributed to participants as of September 12, 2023.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon reaching age 20 and one half years or older and after completing six consecutive months of service.

**Contributions** – The Plan provides for three different types of contributions: automatic enrollment employee contributions, employer matching contributions, and employer discretionary contributions. Each year, participants may elect to contribute up to 60% of pre-tax annual compensation to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer matching contribution is limited to 50% of the first 6% of an employee's elective deferral up to a maximum of \$1,000 a year. The Plan Sponsor may make discretionary matching contributions to the Plan on behalf of each eligible participant. During the eight and a half months ended September 12, 2023, the Plan Sponsor made no discretionary contributions to the Plan.

**Participant Accounts** – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options** – Participants may direct their contributions, including the Company matching or discretionary contributions, and any related earnings into any or all of the multiple investment account options offered under the Plan.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants** – The Plan does not allow for participants to borrow from their accounts.

**Payment of Benefits** – On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period that does not exceed designated life expectancies. For termination due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may also elect to withdraw in cash certain vested amounts to the extent necessary to meet a financial hardship, in accordance with the regulations and rulings of the Internal Revenue Code. After a withdrawal, a stipulated period of time must lapse, as defined by the Plan, before a participant can make additional deferred contributions.

**Forfeitures** – Forfeitures are the non-vested portion of participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and may be applied to reduce future employer contributions or used to pay the Plan’s administrative expenses. During the eight and a half months ended September 12, 2023 the Plan applied a total of \$30,000 to pay administrative expenses and \$12,796 was allocated to remaining active participants of the plan.

**Significant Accounting Policies**

**Basis of Accounting** – The accounting records of the Plan are maintained using the liquidation basis of accounting for the eight and a half months ended September 12, 2023 and the accrual basis of accounting for the year ended December 31, 2022.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan’s assets are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Administrative Expenses** – Certain administrative expenses are paid by the Plan Sponsor and accordingly, are not reflected in the accompanying financial statements of the Plan. Certain transaction processing fees are charged to the participants and therefore, are reflected in the accompanying statement of changes in net assets for benefits as administrative expenses.

**Payment of Benefits** – Benefits are recorded when paid.

**Subsequent Events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at that date, including the estimates inherent in the process of preparing financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after that date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through April 3, 2024, which is the date the financial statements are available for issuance, and concluded that there were no events or transactions that needed to be disclosed.

**Note 2. Certified Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at September 12, 2023 and December 31, 2022, and net appreciation in fair value of investments for the eight and a half months ended September 12, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the custodian of the Plan). Investment information is summarized as follows:

### **Note 3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable substantially for the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 12, 2023 and December 31, 2022.

*Government money market:* These investments represent short-term interest bearing money market instruments valued at cost, which approximates fair value.

*Registered investment company shares (Mutual funds):* These investments represent mutual funds that are registered with the Securities and Exchange Commission. Mutual funds are valued at the daily closing price as reported by the fund, which represents the fund's net asset value (NAV). The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. These funds are required to publish their daily NAV and to transact at that price.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Tax Status**

The plan document is a prototype defined contribution plan that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the prototype Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Board of Directors approved termination of the plan on January 5, 2023. See Note 5.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**Note 5. Plan Termination**

As of January 5, 2023, the Company exercised its right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). The participants became 100% vested in their employer contributions on this date. All assets of the plan were distributed to the participants during the eight and a half months ended September 12, 2023.

**Note 6. Risks and Uncertainties**

Concentration of Credit Risk - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 7. Party-In-Interest Transactions**

Certain plan investments are shares in mutual funds managed by Fidelity Management Trust Company (Fidelity Investments). Fidelity Investments is the record keeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Fidelity Investments by the Plan for administrative services amounted to \$100 for the eight and a half months ended September 12, 2023. Strategic Advisors Inc. provided investment advisory services for the plan and therefore transactions with this entity are considered party-in-interest transactions. Indirect fees of \$327 were paid to Strategic Advisors Inc. for the eight and a half months ended September 12, 2023.

Certain plan administrative expenses have been paid from the plan forfeiture account to West Rhode & Roberts and, therefore, these transactions qualify as party-in-interest transactions. Direct fees of \$30,000 were paid to West Rhode & Roberts during the eight and a half months ended September 12, 2023 and are included in the administration expenses in the Statement of Net Assets Available for Benefits.

**Note 8. Reconciliation of Financial Statements to Form 5500**

There were no differences in amounts reported in the Plan's financial statements and the Form 5500 as of and for the eight and a half months ended September 12, 2023.
