We have performed the audits of the financial statements of Anholt Technologies, Inc. 401(k) Salary Reduction Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Emphasis of a Matter - Plan Merger

As discussed in Note 1 to the financial statements, the Board of Directors of Anholt Technologies, Inc., the Plan's sponsor, approved a resolution to merge the Plan into the Medtec LLC 401(k) Plan effective January 1, 2023. All plan assets were transferred to the Medtec LLC 401(k) Plan on February 28, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 - Description of Plan

The following description of Anholt Technologies, Inc. 401(k) Salary Reduction Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all full-time and part-time, benefits eligible employees of Anholt Technologies, Inc. dba Qfix (the Company). To be eligible to make salary deferrals and to receive employer contributions, employees must complete six months of service and be age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

The Board of Directors of the Company approved a resolution to merge the Plan into the Medtec LLC 401(k) Plan effective January 1, 2023. All plan assets were liquidated and transferred to the Medtec LLC 401(k) Plan on February 28, 2023. The net assets transferred on February 28, 2023 represent investments at fair value of \$9,481,812.

Contributions

Each year participants could contribute up to 100% of their pre-tax annual compensation, as defined in the Plan. Participants could also make after-tax (Roth) contributions. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of all contributions into various investment options offered by the Plan. The Plan also included an auto-enrollment provision, whereby all newly eligible employees, as well as all existing non-participating eligible employees, were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Annually, the deferral rate for the automatically enrolled participants increased 1% to a maximum deferral rate of 10% of eligible compensation. The Company made a safe harbor nonelective contribution of 3% of participant's compensation. The Company may also make a discretionary matching contribution or a nonelective contribution. There were no discretionary matching contributions or nonelective contributions for the period from January 1, 2023 through February 28, 2023, or the year ended December 31, 2022. Contributions were subject to certain IRS limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Note 3 - Information Certified and Provided by Ascensus LLC

Certain information related to investments disclosed in the accompanying financial statements, including investments held at February 28, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments and interest and dividends for the period January 1, 2023 through February 28, 2023 and for the year ended December 31, 2022, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Ascensus LLC, as agent for Ascensus Trust Company (the trustee of the Plan).

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of February 28, 2023 and December 31, 2022.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Note 5 - Tax Status

The Company adopted a non-standardized pre-approved profit sharing plan sponsored by Ascensus LLC. The non-standardized pre-approved profit sharing plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the non-standardized pre-approved profit sharing plan is qualified under the appropriate section of the Internal Revenue Code (IRC). The non-standardized pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. There were no discretionary matching contributions or nonelective contributions for the period from January 1, 2023 through February 28, 2023, or the year ended December 31, 2022. Contributions were subject to certain IRS limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions, rollover contributions, and safe harbor contributions, plus actual earnings thereon. Vesting in the discretionary matching and nonelective employer contributions portion of their account was based on the following schedule:

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant was eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited nonvested accounts, if any, were applied to reduce the employer contributions and pay administrative expenses for such plan year. Forfeited nonvested accounts as of February 28, 2023 and December 31, 2022 were not significant.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Note 3 - Information Certified and Provided by Ascensus LLC

Certain information related to investments disclosed in the accompanying financial statements, including investments held at February 28, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments and interest and dividends for the period January 1, 2023 through February 28, 2023 and for the year ended December 31, 2022, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Ascensus LLC, as agent for Ascensus Trust Company (the trustee of the Plan).

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of February 28, 2023 and December 31, 2022.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust fund is valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Company adopted a non-standardized pre-approved profit sharing plan sponsored by Ascensus LLC. The non-standardized pre-approved profit sharing plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the non-standardized pre-approved profit sharing plan is qualified under the appropriate section of the Internal Revenue Code (IRC). The non-standardized pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, state, or local tax authorities for years before 2020.

Note 6 - Related Party Transactions and Party-In-Interest Transactions

All transactions that may be considered party-in-interest transactions relate to normal plan management and administrative services, and the related payment of fees. Fees paid by the Plan for investment management, custodial services, and record keeping services amounted to \$19,738 and \$42,957 for the period January 1, 2023 through February 28, 2023 and for the year ended December 31, 2022, respectively. These transactions qualify as party-in-interest transactions.

Plan management has evaluated subsequent events through January 29, 2024. This date is the date the financial statements were available to be issued. No material events subsequent to February 28, 2023 were noted.
