## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator, Participants and Beneficiaries  
of US Well Services 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements***

We have performed an audit of the financial statements of US Wells Service 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of February 1, 2023, and the related statement of changes in net assets available for benefits for the final period ended February 1, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended January 31, 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### ***Opinion on the 2023 Financial Statements***

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2023 Financial Statements section:

- the amounts and disclosures in the accompanying 2023 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### ***Emphasis of Matter – Plan Merger***

As further discussed in Notes 1 and 8 in the financial statements, US Well Services, LLC, the Plan sponsor, elected to merge the Plan into PF Holdings Corp. Retirement Plan, effective February 1, 2023. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the 2023 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the 2023 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit of the 2023 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Their report dated September 25, 2023, indicated that (a) the amounts and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2022 supplemental schedule, other than the information in the 2022 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2022 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

#### **1. Description of Plan**

The following description of the US Well Services 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan was a defined contribution and profit-sharing plan covering all employees of US Well Services, LLC (the "Company") who completed one month of service. The Company was purchased by ProFrac Holdings Corp. in November 2022. Effective December 31, 2022, the Plan was frozen. Effective February 1, 2023, the Plan merged with and into PF Holdings Corp. Retirement Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### Contributions

Each year, participants could contribute a minimum of 1% of pretax annual compensation up to the maximum of 80% of total Plan year compensation or amount allowed by IRS limitations each Plan year. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan included an auto-enrollment known as the Qualified Automatic Contribution Arrangement ("QACA") provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmably elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain limitations. Pursuant to the Plan document, the Company made a matching contribution equal to 100% of an eligible participant's deferred compensation up to 6% of the eligible participant's annual compensation. The Company could also make additional discretionary matching contributions and nonelective contributions to the Plan for eligible participants. Company contributions ceased in March 2020 and were reinstated January 1, 2022. The Plan was frozen on December 31, 2022.

##### Participant Accounts

Each participant's account was credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Participants were charged with an allocation of administrative expenses that were charged to the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**1. Description of Plan (continued)**

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. If a participant terminated employment prior to normal retirement age for any reason, other than death or disability, the participant's interest in the Company's non-elective contributions to the Plan for their benefit vested as follows based on years of service:

If a participant terminated employment prior to normal retirement age for any reason, other than death or disability, the participant's interest in the Company's QACA matching contributions to the Plan for their benefit vested as follows based on years of service:

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants could borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years; however, terms could exceed five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on outstanding loan balances ranged from 4.25% to 8.00% for the year ending December 31, 2022. Outstanding loans were deemed distributed in conjunction with the Plan merger. There were no outstanding loan balances as of February 1, 2023. Principal and interest were paid ratably through payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document, Related fees were recorded as administrative expenses and were expensed when they were incurred.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or periodic installments over various periods stipulated in the Plan. For termination of service due to other reasons, a participant could receive the value of the vested interest in their account as a lump-sum distribution. The Plan allowed in-service distributions to participants who attained age 59 ½.

#### 2. Summary of Significant Accounting Policies

##### Forfeitures

Forfeited nonvested accounts could be used to reduce future employer contributions and pay Plan expenses. During the final period ended February 1, 2023, no amounts were used to reduce future employer contributions or pay Plan expenses. Forfeitures of approximately \$49,907 were transferred with Plan assets into the PF Holdings Corp. Retirement Plan. Forfeited nonvested accounts available at February 1, 2023 and December 31, 2022, were approximately \$-0- and \$41,718, respectively.

##### Basis of Accounting

The financial statements of the Plan were prepared on the accrual method of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments were reported at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payment of Benefits

Benefits were recorded when paid.

##### Plan Expenses

Certain expenses of maintaining the Plan were paid directly by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation of fair value of investments.

#### **2. Summary of Significant Accounting Policies**

##### Stable Value Fund

The Plan held an investment in a stable value fund. The fund had certain limitations as follows:

- Participant withdrawals made in order to accommodate distributions to participants or transfers to a non-competing investment could be made on any business day. Transferred amounts were held in a non-competing investment option for 90 days before subsequent transfers to a competing fund could occur.
- Withdrawals directed by a plan sponsor must be preceded by a twelve-month written notice to the issuer. The issuer, however, may, in its discretion, complete any such plan-level withdrawal before the expiration of such twelve-month period. In relation to the merger, the Plan's investment in the stable value fund was transferred to the PF Holdings Corp. Retirement Plan (see Note 8).

#### **3. Fair Value Measurements**

The FASB's Accounting Standard Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of February 1, 2023 and December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the mutual fund. Mutual funds held by the Plan were open-ended mutual funds that are registered with the SEC. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

#### 3. Fair Value Measurements (continued)

*Collective Investment Trust Funds:* Invests in collective trust funds as well as a variety of separate accounts and mutual funds. The value of the collective investment trust funds was determined using various inputs, such as the NAV of the shares of the underlying separate accounts and mutual funds held at year end adjusted for administrative expenses and other charges. As of February 1, 2023 and December 31, 2022, there were no unfunded commitments related to these investments, and the investor may redeem these assets daily.

*Stable value fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that was valued at the net asset value of units of the bank collective trust. The NAV was used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

Participant transactions (purchases and sales) could occur daily. As of February 1, 2023 and December 31, 2022, there were no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth, by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2022. The Plan did not hold any investments as of February 1, 2023.

#### 4. Tax Status

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA sponsored by Empower Retirement LLC. On November 14, 2022, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt.

#### **4. Tax Status (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 1, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **5. Investment Certification**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Empower Trust Company, LLC, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity as of January 31, 2023 and December 31, 2022 and for the period January 1, 2023 to January 31, 2023 in the accompanying statements of net assets available for benefits as of February 1, 2023 and December 31, 2022, and the statement of changes in net assets available for benefits for the final period ended February 1, 2023.

#### **6. Related Party Transactions and Party in Interest Transactions**

Certain investments were managed by an affiliate of Empower Trust Company, LLC (Empower). Empower was the Plan trustee and recordkeeper and, therefore, transactions related to these investments qualified as party-in-interest transactions. Fees paid by the Plan to affiliates of Empower were \$27,695 for the final period ended February 1, 2023. The Plan also paid investment advisory fees. As a service provider to the Plan, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for this service provider were \$6,750 for the final period ended February 1, 2023.

#### **7. Mutual Fund Fees**

Certain investments in mutual funds were subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees were used to pay for marketing and distribution costs of the funds. These fees were deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### **8. Plan Merger**

Effective as of February 1, 2023, the Plan merged with and into the PF Holdings Corp. Retirement Plan (the PFH Plan). Plan assets were transferred to the trustee of the PFH Plan on January 31, 2023.

#### **9. Subsequent Events**

The Plan has evaluated subsequent events through March 26, 2024, the date the financial statements were available to be issued. The Plan sponsor is delinquent in filing the 2023 Form 5500 and intends to file with the Department of Labor's Delinquent Filer Voluntary Correction Program.
