Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Oregon College of Oriental Medicine 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Oregon College of Oriental Medicine 401(k) Plan's financial statements in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oregon College of Oriental Medicine 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Oregon College of Oriental Medicine 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of Oregon College of Oriental Medicine 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective July 1, 2021.

General

The Plan was established February 1, 2010 as a defined-contribution plan covering all eligible employees of Oregon College of Oriental Medicine (the Employer). The Plan has monthly entry dates with a minimum age requirement of 21 years, but no service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute, on a pre-tax basis, up to 100 percent of their annual compensation, limited to the amounts provided by the Internal Revenue Code (IRC). Participants may also contribute rollover amounts, representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions.

The Employer may make a discretionary matching and/or profit sharing contribution. The amount of the contribution is determined by the Employer on a discretionary basis. Participants are eligible for matching and profit sharing beginning on the first day of the month after attaining age 21 and completing one year of service. The participant must be employed on the last day and have worked 1,000 hours in the Plan year unless they terminated due to death or disability, or have attained normal retirement age. The Plan did not have discretionary Employer matching or profit sharing contributions for the years ended June 30, 2023 and 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, in accordance with the Plan's provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their accounts into various investment options offered through Transamerica Life Insurance Company. All accounts are fully participant directed.

Vesting

Participants are fully vested in their accounts at all times.

Participant Loans

Participants are not permitted to borrow against their accounts.

1. Plan Description, continued

Payment of Benefits

Upon retirement, death, disability, or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts in a lump sum, in accordance with the appropriate provisions of the Internal Revenue Code (IRC) and applicable state laws. Also, hardship withdrawals of participants' contributions are allowed under certain circumstances, as described in the Plan document. In addition, participants may elect to receive withdrawals, at any time, of part or all of the interest in their accounts related to prior rollover contributions. In-service withdrawals are allowed at age 59½ from all accounts that are fully vested.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements. The Plan's insurance contract is carried at contract value and represents deposits, plus earnings, less expenses and withdrawals.

Interest and dividend income are recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

The Employer may absorb certain costs of administering the Plan; these expenses are excluded from these financial statements. Custodial and other administrative fees are paid from participant accounts. Investment related expenses are included in net change in fair value of investments.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information was certified by Transamerica Life Insurance Company, the custodian of the Plan, as complete and accurate as of and for the years ended June 30:

4. Insurance Contracts

The Plan has a fully benefit-responsive investment contract with Transamerica. Transamerica maintains the contributions in a pooled account (Stable Value Option), which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. All assets in the stable value fund are credited with interest using a declared monthly rate determined by Transamerica and stated in advance. The crediting rate was 1.95 percent and 1.45 percent at June 30, 2023 and 2022, respectively. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There is no specific portfolio of assets in which the stable value fund invests. The credited interest rate is backed by the income received from assets held in Transamerica's general account. There is no stated minimum or maximum interest rate for the Stable Value Option, and it is not considered a guaranteed interest contract or a common/collective trust. Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Transamerica. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable.

5. Plan Termination

Although the Employer has not expressed any intent to discontinue its contributions and terminate the Plan Agreement, it may do so at any time subject to the provisions set forth in ERISA.

6. Tax Status

The Internal Revenue Service issued an opinion letter dated November 30, 2020, stating that the Non standardized pre-approved Profit Sharing Plan with CODA sponsored by Professional Benefit Service, Inc. and adopted by the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the Plan is not subject to tax under present income tax law. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

6. Tax Status, continued

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Party in Interest Transactions

Certain Plan investments in the pooled separate accounts are shares of registered investment companies managed by the custodian or an affiliate of the custodian, Transamerica Life Insurance Company. Fees paid by the Plan to the custodian for recordkeeping services were \$10,163 and \$13,678 for the years ended June 30, 2023 and 2022, respectively. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Fair Value Measurements

Financial Accounting and Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

9. Fair Value Measurements, continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2023 and 2022.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of June 30, 2023 and 2022, there were no investments classified within the fair value hierarchy. There were pooled separate accounts that were measured at NAV and excluded from the fair value hierarchy in the amount of \$2,189,339 and \$1,879,693 as of June 30, 2023 and 2022, respectively.

10. Nonexempt Transactions

During the years ended June 30, 2023 and 2022, participant contributions totaling \$11,375 and \$20,834, respectively were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking the appropriate steps to correct the situation by calculating lost earnings and interest and further implementing procedures to ensure that all future remittances are made within the prescribed time period.

11. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
