## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees of  
National Women's Law Center 403(b) Tax-Deferred Annuity Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the National Women's Law Center 403(b) Tax-Deferred Annuity Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended June 30, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

***Opinion (continued)***

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Emphasis of Matter***

On July 1, 2022, the Plan was merged into the National Women's Law Center 403(b) Defined Contribution Plan. As discussed in Note 3 to the financial statements, all assets from the Plan were transferred to the National Women's Law Center 403(b) Defined Contribution Plan.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

*Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

**1. Plan Description**

The following description of the National Women’s Law Center 403(b) Tax-Deferred Annuity Plan (“the Plan”) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that operates under Section 403(b) of the Internal Revenue Code (IRC). National Women’s Law Center (NWLC) amended and restated the Plan, which was originally adopted on July 1, 1981. The effective date of this amended Plan was July 1, 2018. The Plan is subjected to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended.

Eligibility

The Plan is available to all employees of NWLC immediately following employment as there are no age or service requirements defined in the Plan. The entry date is the date of hire.

Contributions

Participants may elect to contribute a percentage of their compensation, not to exceed the statutory limit. Participants direct the investment of their funds into various investment options offered by the Plan. The Plan offers fixed and variable annuity funds, as well as a variety of mutual funds, sponsored by the Plan’s custodian. Participants may change their investment elections at any time.

Participant Accounts

Each participant’s account is credited with the allocations of the Plan’s earnings and losses, and any amounts rolled over from other qualified plans. Earnings and losses are allocated by fund based on the ratio of a participant’s account balance in a particular fund to all participants’ account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**1. Plan Description (continued)**

Vesting

Participants are fully and immediately vested in the benefits arising from contributions made under this Plan. Such amounts are non-forfeitable.

Notes Receivable from Participants

Participants may borrow from their fund accounts from a minimum of \$1,000 up to a maximum balance equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in a participant's account and bear interest at rates that commensurate with the types of investments in the participant's fund balance. Loan terms range from one to five years, unless for the purchase of a primary residence. Payments of principal and interest are due monthly.

Plan Loans

Plan loans are collateralized loans offered through Teachers Insurance and Annuity Association—College Retirement Equities Fund (TIAA-CREF), a Plan custodian. To secure the loan, participants are required to pledge as collateral TIAA Traditional Annuity value equal to 110% of the outstanding loan balance in the event of default. TIAA-CREF sets the interest rate quarterly, but it is generally close to the prime rate. For all Plan loans, interest is paid directly to TIAA-CREF. The minimum loan amount is \$1,000 while the maximum loan amount is either \$50,000 or 45% of a participant's balance in his or her TIAA and CREF Group Supplemental Retirement Annuity (GSRA) accumulation attributable to participation under this Plan, or 90% of a participant's TIAA Traditional Annuity accumulation attributable to participation under this Plan, whichever is less. As of June 30, 2023 and 2022, participants had \$0 and \$10,296, respectively, of loans outstanding for which they had pledged Plan assets as collateral. Plan management has concluded that these loans are not Plan assets and that such arrangements are exempt transactions.

In the event of default, such loans are reportable to the Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the participant or the participant becomes eligible to receive a distribution under the terms of the Plan. As of June 30, 2023 and 2022, there were no Plan loans in default.

**1. Plan Description (continued)**

Payment of Benefits

Upon retirement, disability, resignation, or termination, a participant, or his or her beneficiary in the event of the participant’s death, is entitled to receive, as of his or her determination date, an amount equal to the vested portion of the participant’s account, determined in either a lump-sum payment or under various installment payment arrangements.

Forfeitures

All contributions are immediately vested, so there are no forfeitures.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The Plan’s financial statements and supplementary schedule are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from estimated amounts.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the notes’ unpaid principal balance, plus any accrued unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans are those for which any scheduled repayment remains unpaid at the end of the period specified in the loan procedures, and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date. Notes receivable from participants totaled \$0 and \$31,466 at June 30, 2023 and 2022, respectively.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Except for certain investment management fees, all (or substantially all) expenses of maintaining the Plan are paid by NWLC.

Subsequent Events

In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through April 8, 2024, the date the financial statements were available to be issued.

**3. Plan Merger**

On July 1, 2022, the Plan was merged into the National Women’s Law Center 403(b) Defined Contribution Plan. Prior to the merger, the Plan covered eligible employees at NWLC. The transferred net assets have been recognized in the accounts of the National Women’s Law Center 403(b) Defined Contribution Plan as of July 1, 2022, at their balances as previously carried in the accounts of the Plan. A summary of the transferred net assets is as follows:

**4. Fair Value Measurements**

The Plan follows Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, for its financial assets. This standard establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value measurement standards require an entity to maximize the use of observable inputs (such as quoted prices in active markets) and minimize the use of unobservable inputs (such as appraisals or other valuation techniques) to determine fair value. The categorization of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to the entity’s perceived risk of that instrument. The inputs used in measuring fair value are categorized into three levels:

*Level 1:* Inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

*Level 2:* Inputs to this valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following section describes the valuation methodologies the Plan uses to measure its assets at fair value:

*Money market fund:* The money market fund is valued at the quoted market price of shares held by the Plan at year end.

*Mutual funds:* The mutual funds are within registered investment companies and valued at the quoted market price per shares held by the Plan at year end.

*Pooled separate account:* The pooled separate account consists of the TIAA Real Estate Fund, which is valued at net asset value (NAV) of shares held by the Plan at year end. The TIAA Real Estate Fund generally invests in real estate properties and real estate–related investments. The value is principally derived from the market value of the underlying real estate holdings or other real estate–related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional’s opinion. This account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated daily. Redemptions are limited to one per quarter.

Generally accepted accounting principles permit NAV per share to represent fair value for reporting purposes as a practical expedient when the fair value is not readily determinable, unless it is probable the investment will be sold at something other than NAV. Since the pooled separate accounts were measured using the NAV per share practical expedient, they have not been classified in the fair value hierarchy.

The preceding valuation methods could produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Investment Contract with Insurance Company**

TIAA-CREF Traditional Annuity

Each participant maintains an individual annuity contract with TIAA-CREF. As part of the contracts, TIAA-CREF maintains a portion of the contributions in a “guaranteed account,” which is called the Traditional Annuity. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA-CREF. The guaranteed minimum rate of interest is based on a formula established by TIAA-CREF and is between 1% and 3%. Any additional interest is not guaranteed. The Traditional Annuity does not permit TIAA-CREF to terminate the agreement prior to the scheduled maturity date.

Certain Traditional Annuity individual annuity contracts are considered to be non-benefit-responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering credit worthiness of the issuer. These contracts are subject to a 10-year withdrawal period.

Upon termination of the contracts, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Fixed Account accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account.

Certain Traditional Annuity individual annuity contracts meet the fully benefit-responsive criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Upon termination of the investment contract, the lump-sum liquidation value of the guaranteed account portion of the participant's accumulation value shall be equal to the product of (a) the participant's guaranteed account accumulation value of the liquidation date, reduced by the liquidation charge applicable on the liquidation date, and (b) a market value adjustment percentage. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer.

These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under IRC Section 403(b) or the failure of NWLC to be tax-exempt under IRC Section 501(c)(3)
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan’s investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation or amendment to the agreements without proper consent

**6. Party-in-Interest Transactions**

Certain investments of the Plan are shares of registered investment companies (mutual funds) and are managed by TIAA-CREF, the Plan’s custodian. Accordingly, these transactions qualify as party-in-interest transactions.

**7. Plan Termination**

Although it has not expressed any intent to do so, NWLC has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA.

**8. Information Certified by the Custodian**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for fiscal years 2023 and 2022. Accordingly, TIAA-CREF, the custodian of the Plan assets, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of June 30, 2023 and 2022, and the supplementary schedule as of June 30, 2023, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended June 30, 2023.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**10. Income Tax Status**

The Plan’s initial adopted plan document date was effective on July 1, 1981. The Plan has since adopted an amended and restated plan document effective July 1, 2018, and the Plan Administrator believes the Plan is designed to qualify under IRC Section 403(b). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the related custodial accounts are tax-exempt.

The Plan’s management has evaluated the Plan’s tax positions and concluded that there are no significant uncertain tax positions that qualify for either recognition or disclosure in the accompanying financial statements.
