We have performed audits of the financial statements of Embrey Management Services, Ltd. 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 21, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period January 1, 2023 through June 21, 2023, and the related notes to the financial statements.

## **Note 1. Description of the Plan**

### ***General***

The following description of Embrey Management Services, Ltd. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Embrey Management Services, Ltd. (Company and Plan Sponsor) for the benefit of its employees who have at least two months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company serves as the Plan trustee.

### ***Plan Transfers***

Effective June 21, 2023, the Plan merged into the Embrey Development Company 401(k) Plan. The provisions of the Embrey Development Company 401(k) Plan survived in regard to vesting and employer matching. Eligibility requirements were changed to start with the first day of employment.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Plan Sponsor make annual contributions of up to 100% of eligible compensation, not to exceed the maximum allowed under Internal Revenue Service rules and regulations. Participants who have reached age 50 by the end of the Plan year and who have already made the maximum elective deferral may make an additional pre-tax "catch-up" contribution. The Plan permits eligible employees to make Roth after-tax deferrals. The Plan Sponsor makes matching contributions of 50% of the employees' salary deferral amounts on the first 6% of employees' compensation. Employee rollover contributions are also permitted. The Plan Sponsor's matching contributions are an amount specified by the Plan Sponsor annually. Plan Sponsor's profit sharing contributions are discretionary as determined by the Plan Sponsor's management. No profit sharing contributions were made during the period January 1, 2023 through June 21, 2023. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant becomes fully vested after four years of continuous service.

### ***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

***Forfeited Accounts***

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures can be used to reduce the Plan Sponsor's contributions to the Plan. At December 31, 2022, forfeited nonvested accounts totaled approximately \$51,000. On June 21, 2023, approximately \$51,000 of forfeitures were transferred to the Embrey Development Company 401(k) Plan as part of the plan merger.

***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by the participant's highest outstanding loan balance in the previous 12 months and the existing loan balance, even if all or a portion of this amount has been repaid. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Notes receivable from participants are secured by the vested balances in the respective participants' accounts. Interest on the loans is based on local prevailing rates as determined by the plan administrator. Effective, June 21, 2023 approximately \$71,300 of notes receivable from participants were transferred to the Embrey Development Company 401(k) Plan as part of the plan merger.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumption that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Investments in registered investment companies are stated at fair value based on the quoted market price. The value of the common/collective trust is valued at estimated fair value as provided by Fidelity Management Trust Company. The fair value of this investment is based on the net asset value (NAV) of shares of the underlying mutual funds and common/collective trust held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Plan Sponsor or the Plan, at the Plan Sponsor's discretion.

**Note 3. Certification of Plan Administrator**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 21, 2023 and December 31, 2022.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period January 1, 2023 through June 21, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are shares of registered investment companies managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

The Plan Sponsor provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There were no significant changes in the valuation techniques through June 21, 2023, the date the Plan merged. The Plan has no liabilities measured at fair value on a recurring basis. In addition, the Plan has no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no securities classified within Level 2 or 3 of the hierarchy for the Plan.

**Investments Measured Using the Net Asset Value per Share Practical Expedient**

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be become 100% vested in their employer contributions.

As described in *Note 1*, effective June 21, 2023 the Plan merged into the Embrey Development Company 401(k) Plan. The plan merger does not constitute a plan termination and participants will continue to receive benefits in the merged plan.

**Note 7. Tax Status**

The Plan is operated under a pre-approved plan sponsored by FMR LLC. The Plan Document has been filed with the appropriate agency, and an opinion letter has been obtained. The Plan has not obtained or requested a determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.
