## Notes to Financial Statements

As of June 12, 2023 and December 31, 2022, and for the period ended June 12, 2023

(1) Description of the Plan

The BK Medical Holding Company, Inc. 401(k) Plan (the "Plan") is a defined contribution plan sponsored by BK Medical Holding Company, Inc (the "Company"), an affiliate of GE HealthCare Technologies, Inc. ("GEHC"). The Plan is subject to applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Company was spun out of Analogic Corporation as a standalone company and commenced the Plan on June 15, 2021. The Plan is generally available to all employees of the Company who are not covered by a collective bargaining agreement. Participants in the Analogic 401(k) Plan that were employees of the Company were merged into the Plan on June 15, 2021.

Effective January 1, 2023, the Plan was amended to freeze employer and employee contributions. The Plan was amended to merge into the GE HealthCare Retirement Savings Plan as of June 12, 2023. As a result, on June 12, 2023, the Plan was merged and assets of \$32,097,225 were transferred into the GE HealthCare Retirement Savings Plan. Certain plan provisions were preserved with respect to transferring participant account balances.

Fidelity Workplace Services LLC is the Plan's recordkeeper. The Plan Trustees have appointed Fidelity Management Trust Company ("FMTC") as the directed Trustee of the Trust.

The description of the Plan is provided for general information purposes only. The complete terms of the Plan are provided in the BK Medical Holding Company, Inc. 401(k) Plan document (the "Plan Document"). Information concerning the Plan, including benefits and vesting provisions is included in the Summary Plan Description ("SPD") and other material made available to participants.

Employee Contributions and Investment Options

Effective January 1, 2023, no participant contributions to the Plan are permitted.

Participants may invest their accounts in various investment options including registered investment companies and a common collective trust. Audited financial statements and prospectuses or other disclosure documents of the registered investment companies ("mutual funds") are made available to participants.

Prior to January 1, 2023, participants may elect to contribute up to 90% of their annual compensation, as defined by the Plan, subject to limitations imposed by law. Participants may also contribute amounts as "rollover" contributions representing distributions from other qualified defined benefit or defined contribution plans of a former employer, subject to certain requirements.

Prior to January 1, 2023, eligible employees were automatically enrolled at an employee pretax deferral rate of 4% of their eligible pay, unless they declined to participate within a prescribed time limit or they elected a different deferral rate. The Plan provided for automatic annual deferral rate increases until the participant's combined pretax and/or Roth deferral rate reached 10%.

Employer Contributions

Effective January 1, 2023, no employer contributions to the Plan are permitted.

Prior to January 1, 2023, participants were eligible to receive employer safe harbor matching contributions and employer discretionary contributions under the Plan. Employer safe harbor matching contributions were equal to 100% of the participant's eligible contributions up to 4%.

Vesting

Participants are immediately fully vested in their contributions and employer safe harbor matching contributions and related investment results.

## Notes to Financial Statements

As of June 12, 2023 and December 31, 2022, and for the period ended June 12, 2023

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of (a) employer safe harbor matching contributions and (b) investment results. The benefit to which a participant is entitled is the value of the participant's vested account.

Notes Receivable from Participants

The Plan permits participants, under certain circumstances, to borrow a minimum of \$1,000 from their participant accounts. Subject to certain IRC and Plan limits, a participant may not borrow more than the lesser of \$50,000 minus their highest outstanding balance of loans from all plans maintained by the Company and its affiliates, during the past 12 months or 50% of their vested account balance.

The term of any loan is up to 5 years from the effective date of the loan unless the loan is used to acquire a principal residence for which a term of up to 10 years may be permissible. Loans are secured by the remaining balance in the participant's account. The interest rate applicable to participant notes receivable is 1% above the prime interest rate in effect as of the last business day before the loan is requested. Loans are repaid with interest in equal payments over the term of the loan by payroll deductions or other such methods as may be required. Participants may repay the principal amount with written notice without penalty.

In the event of a loan default, the amount of the outstanding balance will be reported to the Internal Revenue Service ("IRS") in the year of the default as ordinary income.

Payment of Benefits

Participants' withdrawals are permitted under the Plan subject to certain restrictions. Participants are allowed to withdraw all or a portion of their after-tax contributions and rollovers. Participants who are at least age 59 ½ are allowed to withdraw their entire accounts. In the case of a hardship, a participant may elect to withdraw, as applicable, at least \$500 or the vested balance from his or her after-tax contributions account.

Upon termination of service or disability, a participant may elect to receive either a lump-sum or a direct rollover equal to the value of the participant's vested interest in his or her account, .

Plan Termination and Amendment

If the Plan is terminated, each participant's interest will be payable in full according to the Plan's provisions. Effective June 12, 2023, the Plan was merged into the GE HealthCare Retirement Savings Plan.

Administrative and Investment Advisory Costs

Expenses related to the administration of the Plan, including recordkeeping expenses and Trustee's fees, may be paid by the Plan. However, the Company may choose to pay these expenses (see note 2(f)). For the registered investment companies and common collective trust investment advisors are reimbursed for costs incurred or receive a management fee for providing investment advisory services. The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investments fees to Fidelity to offset the Plan's administrative expenses. Reimbursed costs and management fees are reflected in the investment income on the statements of changes in net assets available for plan benefits.

(2) Summary of Significant Accounting Policies(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

(b) Investments

Plan investments are reported at fair value. See notes 3 and 4 for additional information.

## Notes to Financial Statements

As of June 12, 2023 and December 31, 2022, and for the period ended June 12, 2023

Investment transactions are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation (depreciation) in the fair value of investments consists of the realized gains or losses on the sales of investments and the net unrealized appreciation (depreciation) of investments held at year end.

(c) Fair Value Measurements

Fair value of a financial instrument is the price the Plan would receive to sell an asset in an orderly transaction with a market participant at the measurement date. In the absence of active markets for the identical asset, such measurements involve developing assumptions based on market observable data and, in the absence of such data, internal information that is consistent with what market participants would use in a hypothetical transaction that occurs at the measurement date.

Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect our market assumptions. Preference is given to observable inputs. These two types of inputs create the following fair value hierarchy:

Level 1 - Quoted prices for identical investments in active markets.

Level 2 - Quoted prices for similar investments in active markets; quoted prices for identical or similar investments in markets that are not active; and model-derived valuations whose inputs are observable or whose significant value drivers are observable.

Level 3 - Significant inputs to the valuation model are unobservable.

When available, quoted market prices are used to determine the fair value of investment securities, and they are included in Level 1. Level 1 securities include registered investment companies and short-term investments.

See note 4 for additional information.

(d) Notes Receivable from Participants

Loans to participants are recorded at the outstanding principal balance plus accrued interest.

(e) Payment of Benefits

Benefit payments are recorded when paid to participants.

(f) Expenses

Certain expenses related to administration of the Plan are paid by the Company and in accordance with the provisions of the Plan, with the exception of certain participant directed activities, which are paid by the Plan's Trustee out of the respective participant's investment fund's assets.

(g) Management Estimates and Assumptions

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amount of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(4) Fair Value Measurements

The Plan's investments in the trust are measured at fair value on a recurring basis. The following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment companies* - Valued at the daily closing price as reported by the fund. The funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common collective trust* - Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The Plan had no investments at June 12, 2023, since the Plan was merged into another plan.

(a) The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for plan benefits. Investments in the common collective trust are valued based on the year-end unit net asset value ("NAV"). The NAV is used as a practical expedient to estimate fair value. These investments are priced daily and there are no unfunded commitments. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment advisor reserves the right to delay withdrawal up to 12 months in order to confirm that securities liquidations will be carried out in an orderly business manner.

(5) Risks and Uncertainties

The Plan offers a number of investment options including registered investment companies and a common collective trust. Certain funds invest in U.S. equities, international equities and fixed income securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk including risks related to pandemics and international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur (including in the near term) and that such changes could materially affect participant account balances and amounts reported in the statements of net assets available for plan benefits.

The Plan's exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

As of December 31, 2022, the following investments represent more than 10% of the fair value of the Plan's total investments.

(6) Parties-in-Interest Transactions

Certain investments of the Plan are shares of registered investment companies that are managed by Fidelity. Fidelity is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Registered investment companies and common collective trust operating expenses, which include expenses paid to Fidelity Workplace Services LLC, reduce the respective fund's assets and are reflected in the fund's share/unit price and dividends.

The recordkeeper and trustee of the Plan, which are mentioned in note 1, as well as the Company and Plan participants, are each a "party-in-interest" as defined by ERISA. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

(7) Nonexempt Party-in-Interest Transaction

During 2022, the Company failed to timely remit certain employee deferrals to the Plan aggregating \$133,001. The Company computed the lost earnings on these 2022 deposits and subsequently remitted the deposits and made contributions for lost earnings to the Plan. The Company has corrected the remittances as required. Accordingly, the Company believes that the Plan will retain its tax qualification status and, accordingly, no tax liability has been accrued. The Company filed Form 5330 with the IRS and paid the required excise tax on the transaction.

(8) Tax Status

The Internal Revenue Service ("IRS") has notified Fidelity, the prototype sponsor, by a letter dated June 30, 2020, that the basic plan document is qualified under the appropriate sections of the IRC. Effective June 15, 2021, the Plan adopted a Fidelity prototype document. The Plan has been administered in accordance with certain legislative and regulatory changes enacted since that letter was requested. The Plan administrator believes that the Plan's current design and operations comply in all material respects with the applicable requirements of the IRC, and that the letter remains valid. Therefore, no provision for income taxes has been included in Plan's financial statements.

(9) Subsequent Events

Subsequent events are evaluated through April 12, 2024, the date the financial statements are available to be issued. No events occurred that require additional disclosure or adjustments to the Plan's financial statements.

(10) Reconciliation of Financial Statements to Form 5500

Notes receivable from participants are classified as investments per Form 5500 instructions. In addition, any deemed distributions are not considered to be plan assets per Form 5500 and are excluded from notes receivable from participants. However, these distributions remain a plan asset for purposes of these financial statements until a distributable event occurs and they are offset against Plan assets.
