Basis for Opinion

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Northwest Community Credit Union Capital Accumulation Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of Northwest Community Credit Union Capital Accumulation Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The most recent restatement of the plan was effective January 20, 2022 and the most recent plan amendment was effective May 17, 2022.

General

The Plan was established on August 1, 1998, as a defined contribution plan covering all full-time employees of Northwest Community Credit Union (the Credit Union or Employer), other than specifically excluded classes of employees, who are less than 18 years of age.

Employees may enter the Plan on the first day of the month following or coincident with 60 days from their date of hire. Participants become eligible to receive match contributions after the completion of one year and 1,000 hours of service and having attained at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees the governance of the Plan. The Plan terminated as part of a merger with TwinStar Credit Union Profit Sharing and 401(k) Salary Reduction Plan effective June 30, 2023 (see Note 4).

Plan Year

For the year ended December 31, 2022, the plan year was a regular, full calendar plan year. The period ended June 30, 2023 was a six-month period then ended which covers January 1, 2023 through the merger date of June 30, 2023.

Contributions

Participants may contribute pre-tax deferrals of compensation and/or after-tax deferrals (Roth contributions), up to 99 percent of eligible compensation, limited to the amounts provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year may also make additional pre-tax and/or Roth "catch-up" contributions. The Credit Union will match 150 percent of the first 5 percent of compensation the participant contributes, up to a maximum contribution by the Credit Union of 7.5 percent of a participant's gross compensation. There are no annual allocation requirements to receive the match after reaching eligibility. Employees may also contribute amounts representing distributions from any eligible rollover source (rollovers).

The Plan has an Automatic Enrollment Contributions provision. Unless affirmatively elected otherwise, all new employees after August 1, 2016, and employees who have not selected a deferral will have their compensation reduced by a deferral percentage of 3 percent, increasing annually by 1 percent to a maximum deferral of 10 percent.

Participant Accounts

Each participant account is credited with the participant's and Employer's contributions and an allocation of Plan earnings (losses) and expenses. Participant account balances are updated daily based on account activity and price changes of the investment funds. Participants may direct contributions in whole percentage increments in any of the investment options offered for the Plan through Fidelity Management Trust Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are always 100 percent vested in their employee account containing rollovers and elective deferrals plus actual earnings thereon. Vesting in Employer matching contributions is based on a six-year vesting schedule increasing 20 percent per year after year one at zero percent. Employees transferring from other credit unions retain their years of service from the prior employer for vesting purposes.

Payment of Vested Benefits

The method of vested benefit payments depends upon the marital status of the participant, as well as the elections made by the participant and their spouse. Upon termination of employment, the participant is entitled to receive the vested portion of their account balance under one or more of the options shown below:

- Joint and 50 percent survivor
- Joint and 75 percent survivor
- Joint and 100 percent survivor
- Single life annuity
- Life annuity with 5-year certain period
- Life annuity with 10-year certain period
- Lump sum

Vested benefits that do not exceed \$1,000 will be distributed as a lump sum within a reasonable time after termination of employment. Vested benefits exceeding \$1,000 up to \$5,000 will be distributed as a lump sum to an individual retirement account (IRA) if no distribution election is selected by the participant within a reasonable time after termination of employment.

Withdrawals from the Plan may be made upon circumstances of financial hardship from participant deferrals and match contributions vested in accordance with provisions specified in the Plan. In-service distributions are permitted from all vested accounts other than frozen money purchase accounts upon attainment of age 59 $\frac{1}{2}$.

Unless otherwise elected, payment of benefits shall commence no later than the following:

- As soon as practicable following the participant's normal retirement age of 59 $\frac{1}{2}$.
- As soon as practicable following the participant's late retirement date, but in no event later than April 1 of the calendar year following the later of the year in which the participant reaches age 70 $\frac{1}{2}$ or 72, depending on the participant's birth date, or the year in which they retire.
- In the event of death, the "one-year rule" or "five-year rule" will apply depending upon chosen elections.
- In the event of disability, the retirement provisions will apply.
- Upon termination, the participant may elect to receive their benefits within a reasonable time following termination.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their fund accounts or up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and will bear a reasonable rate of interest. Principal and interest will be repaid ratably through payroll deductions over a reasonable period of time not to exceed five years. Loans for the purchase of a primary residence can be repaid over 15 years.

Forfeitures

Forfeitures are used to reduce the Employer's contributions and pay Plan expenses. For the period ended June 30, 2023 and the year ended December 31, 2022, there were forfeitures of \$46,718 and \$73,204, respectively. Forfeitures of \$14,498 and \$152,930, adjusted for earnings, were used to reduce Employer contributions and pay Plan expenses during the period ended June 30, 2023 and the year ended December 31, 2022, respectively. As of December 31, 2022, there were \$31,983 of unused forfeitures. \$64,203 in forfeitures remaining as of June 30, 2023 were transferred to the TwinStar Credit Union Profit Sharing and 401(k) Salary Reduction Plan as part of the plan merger.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

Cash and Cash Equivalents

Cash and cash equivalents include investments in money market funds and other highly liquid instruments that are both readily convertible to known amounts of cash and have original maturities of six months or less. They are recorded in the statements of net assets available for benefits at contract value, which is believed to approximate fair value.

2. Summary of Significant Accounting Policies, continued

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of June 30, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Revenue Sharing

Certain administrative expenses of maintaining the Plan are paid from the Plan assets. Certain other administrative expenses are paid directly by the Employer and are therefore excluded from these financial statements. Investment related expenses are included in net change in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

The Plan participates in a Revenue Credit Program (RCP) through Fidelity which provides a quarterly credit to participants to offset expenses of the Plan. Total RCP credits received by the Plan were \$35,935 and \$27,000 for the six month period ended June 30, 2023 and the year ended December 31, 2022, respectively.

3. Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, acting as the trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the period ended June 30, 2023 and as of and for the year ended December 31, 2022:

4. Plan Merger

In 2023, as part of a merger with TwinStar Credit Union, the Employer executed a Plan merger wherein all assets of the Plan were liquidated and merged into the TwinStar Credit Union Profit Sharing and 401(k) Salary Reduction Plan with an effective date of June 30, 2023. The transfer of assets in connection with the merger occurred on July 14, 2023; however, the accompanying statements of net assets available for benefits and changes in net assets available for benefits as of and for the period ended June 30, 2023, reflect the merger, transfer and final liquidation of the plan effective as of the executed merger date.

5. Income Tax Status

The Plan has adopted a non-standardized pre-approved Profit Sharing Plan with CODA sponsored by Fidelity Management & Research, LLC. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, and informed the sponsor that the volume submitter plan is designed in accordance with the applicable sections of the IRC. The Plan has been amended and restated since receiving the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Fair Value Measurements

U.S. GAAP established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and December 31, 2022.

Cash and cash equivalents: Valued at contract value of shares held, which approximates fair value.

Registered investment companies: The Plan's investments are units of mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All assets of the Plan were in transit as of June 30, 2023 and therefore there were no assets held at fair value as of June 30, 2023. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022:

8. Party in Interest Transactions

Fidelity Workplace Services, LLC (Fidelity) was the Plan Administrator for the period ended June 30, 2023 and the year ended December 31, 2022 and is a company related to Fidelity Management Trust Company, plan trustee and manager of Plan assets; therefore, these investment transactions and related fees qualify as party in interest transactions. During the period ended June 30, 2023 and the year ended December 31, 2022, \$1,543 and \$1,675 respectively, of participant related fees were paid directly to Fidelity from the Plan. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Nonexempt Transactions

During the period ended June 30, 2023, participant contributions totaling \$78,768 were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking appropriate steps to correct the situation by calculating lost earnings and interest and intends to further implement procedures to ensure that all future remittances are made within the prescribed time period.

10. Subsequent Events

Management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
