## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
LRES Corporation Employee 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of LRES Corporation Employee 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## **Basis for Opinion**

**1. DESCRIPTION OF PLAN**

The following description of the LRES Corporation Employee 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for more detailed information of the Plan’s provisions.

**General**

The Plan is a defined contribution plan. The Plan covers all employees of LRES Corporation (the “Company”) who are 19 years old or older and have three months of full-time service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Merger**

Effective June 30, 2023, the sole member of the Company, in conjunction with the acquisition of the Company, adopted a resolution to cease contributions and merge the Plan in the acquirer’s pooled employer plan with recordkeeping, trustee services, and investment options provided by the acquirer’s custodian. All net assets were transferred into the acquirer’s plan on June 30, 2023.

**Contributions**

Participants’ contributions are made to the Plan by means of salary deferral by which the participant is entitled to defer the lesser of 85% of their compensation or a fixed amount determined annually by the Internal Revenue Service. The Company made safe harbor contributions equal to 100% of the first 3.0% of each participant’s eligible wages, plus 50% of the next 2.0% of each participant’s eligible wages. For the six month period ended June 30, 2023 and the year ended December 31, 2022, safe harbor contributions of \$66,372 and \$251,220 were made to the Plan, respectively.

Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors and are considered discretionary. There were no additional profit-sharing contributions made to the Plan for the period ended June 30, 2023 and the year ended December 31, 2022. Furthermore, rollover contributions from other qualified plans are accepted by the Plan.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution; the Company’s matching contribution, and an allocation of Plan earnings. Allocations of Plan earnings are based on participant balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested interest in their account.

**Investments**

Each participant directs the allocation of his or her contribution and employer matching contributions to one or more of the investment options offered by the Plan.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loans to participants fund. Loans must be repaid within 5 years, except in limited circumstances, such as the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear a reasonable fixed rate of interest to be determined by the Plan Administrator. Interest rates on participant loans were 4.25% to 8% on December 31, 2022.

**Vesting**

Participants are immediately vested in their voluntary contributions and the Company's safe harbor contributions, plus actual earnings thereon. Vesting of any discretionary contributions in the participants' accounts is based on years of continuous service. A participant is 100% vested in discretionary contributions after five years of credited service.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or early retirement, as defined by the Plan document, a participant may elect to receive a distribution of his or her vested account balance as either a lump-sum amount or as installments.

The Plan allows participants to make early withdrawals for certain financial hardships. The Plan also allows in-service withdrawals by participants after they reach age 59½. Participants who have reached age 59½ taking in-service withdrawals will be required to pay all applicable taxes on the withdrawals but will not be subject to penalty taxes for early withdrawals.

**Forfeitures**

Forfeitures of terminated participants' non-vested accounts stay within the Plan and are used to offset the Company's matching contributions or administrative expenses. There were forfeiture amounts of \$2,284 and \$7,425 used to pay administrative expenses during the six month period ended June 30, 2023 and the year ended December 31, 2022, respectively. On June 30, 2023 and December 31, 2022, there were forfeited non-vested accounts available for future use of none and \$3,568, respectively.

**Administrative Expenses**

Administrative expenses to the extent that they are not paid by the Company may be paid by the assets of the Plan. For the period ended June 30, 2023 and the year ended December 31, 2022, administrative expenses of \$18,393 and \$38,753 were paid for by the Plan, respectively. In addition, certain investment related expenses have been offset with net investment income (loss) and are not readily determinable.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared under the accrual basis of accounting.

**Basis of Presentation**

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America and in compliance with the Department of Labor Rules and Regulations for reporting and disclosure under the ERISA.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are measured at quoted prices in an active market and have been certified complete and accurate by Fidelity Management Trust Company, the Plan's trustee (see Note 4). Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan evaluated subsequent events through April 9, 2024, the date the financial statements were available to be issued. Based on this evaluation, the Plan has determined that no material subsequent events have occurred which require recognition or disclosure in these financial statements.

**3. FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between Levels 1, 2, and 3 for the periods presented.

The following is a description of the valuation methodologies used in 2023 and 2022 for assets measured at fair value. There have been no changes in the methodologies used on June 30, 2023 and December 31, 2022.

*Interest-bearing cash*: Valued at market value of corresponding currency at year end.

*Registered Investment Companies (Mutual Funds)*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used for assets measured at net asset value ("NAV") as the practical expedient to estimate fair value:

*Common/Collective Trusts*: Common/collective trusts ("CCT") are valued at NAV, which is based on the fair value of the underlying investments of the CCT, less any liabilities. CCT are composed of a stable value fund that is composed primarily of investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

No auditing procedures were performed by the independent auditor as permitted by ERISA Section 103(a)(3)(C) with respect to information certified as complete and accurate by Fidelity Management Trust Company, (the "Trustee"), except for comparing such information with the information reported in the financial statements. Based on information provided and certified by the Trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA at June 30, 2023 and December 31, 2022 and 2021. Accordingly, the Trustee has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of June 30, 2023, December 31, 2022 and 2021, as well as the supplemental schedule of assets (held at year end) as of December 31, 2022.
- Net appreciation (depreciation) in fair value of investments, and dividend and interest income reflected on the accompanying Statements of Changes in Net Assets Available for Benefits for the period from January 1, 2023 through June 30, 2023 and the year ended December 31, 2022.

**5. TAX STATUS**

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designated and being operated in compliance with the applicable requirement of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2023 and December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity Advisor and Fidelity Investments. Fidelity Advisor, Fidelity Investments, and Fidelity Management Trust Company are related parties. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party in interest transactions for which a statutory exemption exists.
