INDEPENDENT AUDITORS' REPORT

To The Board of Directors
Lifestyles for the Disabled, Inc. Profit Sharing Plan
Staten Island, New York

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lifestyles for the Disabled, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lifestyles for the Disabled, Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Fidelity Management Trust Company as of October 14, 2022 and June 30, 2022 and for the period from July 1, 2022 to October 14, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lifestyles for the Disabled, Inc. Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lifestyles for the Disabled, Inc. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of Lifestyles for the Disabled, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan, which was established on July 1, 1999 and restated on April 30, 2021, is a defined contribution plan covering all eligible employees of Lifestyles for the Disabled, Inc. (the “Sponsor”). An employee is eligible to participate in the Plan and have salary reduction contributions made on their behalf after three months of service. Participants are required to have one year of service and 1,000 hours of eligible service to qualify for discretionary matching employer contributions and discretionary nonelective employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance. The trustee of the Plan is Fidelity Management Trust Company (the “Trustee”). The recordkeeper of the Plan is Fidelity Workplace Services LLC (“FWS”).

Effective February 1, 2019, the Plan was amended to remove the hardship distribution option from the Plan.

Effective June 1, 2022, the Plan merged into the Oasis Retirement Savings Plan, which is a defined contribution plan established by Oasis Outsourcing Holdings, Inc., a professional employer organization (“PEO”) and a subsidiary of Paychex, Inc. Assets of the Plan amounting to \$4,991,434 were transferred into the Oasis Retirement Savings Plan in October 2022.

Contributions

Prior to June 1, 2022, participants contributed up to 90% of eligible annual compensation, as defined in the Plan, provided that such contributions did not exceed the limitations under the Internal Revenue Code (the “Code”) of \$20,500 for 2022 plus a maximum of \$6,500 for 2022 in catch-up contributions for participants who attained age 50 before the end of the Plan year. Contributions could be made as a pre-tax deferral or after-tax (Roth) deferral. Highly compensated employees were subject to additional limits set forth in the Code. Participants could also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants could direct the investment of their contributions into various investment options offered by the Plan.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation. The Plan also had an automatic escalation provision that automatically increased participant deferral rates by 1% each year until contributions reached 10% of eligible compensation. These contributions were invested in a designated balanced fund until changed by the participant.

Contributions (cont'd.)

The Sponsor could make discretionary matching contributions and discretionary nonelective contributions to the Plan for all full-time participants who had completed a minimum of 1,000 hours of eligible service during the year and were still employed at the fiscal year-end. The discretionary matching contributions and discretionary nonelective contributions were invested as directed by participants. There were no discretionary nonelective or discretionary matching contributions approved during 2022.

The Plan erroneously recorded a \$150,000 employer contribution receivable in 2018. This error was repeated in subsequent years, with the \$150,000 receivable erroneously reported as remaining outstanding through the year ended June 30, 2022. To correct this, the receivable has been reversed for the year ended June 30, 2023.

Participant Accounts

Each participant's account was credited with the participant's contributions, rollover contributions and the Sponsor's discretionary matching and discretionary nonelective contributions, as well as allocations of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their voluntary and Sponsor's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. The loans were secured by the balance in the participant's account and bore interest at prevailing interest rates, as defined by the Plan. The interest rate was determined as of the date of origination and was fixed for the loan term. Principal and interest were paid ratably through payroll deductions over a period not to exceed five years.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant or beneficiary could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of not more than assumed life expectancy, or partial withdrawals.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determined the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of June 30, 2022. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan Document. Interest rates on loans outstanding at June 30, 2022 ranged from 4.25% to 6.5%.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation or depreciation in fair value of investments. Certain administrative functions were performed by officers or employees of the Sponsor. No such officer or employee received compensation from the Plan.

Note 4 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Note 4 - Fair Value Measurement (cont'd.)

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Stable value fund: Valued at the NAV of units of the bank collective trust and composed primarily of fully benefit-responsive investment contracts. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan had initiated a full redemption of the collective trust, the issuer reserved the right to require 12 months' notification in order to ensure that securities liquidations would be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value at June 30, 2023 and 2022. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the year ended June 30, 2023, there were no transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 5 - Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments were managed by FWS, which is an affiliate of Fidelity Management Trust Company, the trustee of the Plan. Therefore, the transactions related to these investments qualified as party-in-interest transactions. Fees paid by the Plan for investment management services were included in the net change in the fair value of investments.

FWS is the recordkeeper of the Plan; therefore, fees paid to this entity qualified as party-in-interest transactions.

Notes receivable from participants also qualified as party-in-interest transactions.

Note 6 - Tax Status

The Plan adopted the Fidelity Volume Submitter Profit Sharing Plan. Accordingly, the Plan was permitted to rely on Fidelity's opinion letters. The Internal Revenue Service has determined and informed Fidelity by a letter dated June 30, 2020, that the Volume Submitter Profit Sharing Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan had been amended since receiving the opinion letter, the Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Code and therefore believes that the Plan was qualified and the related trust was tax exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax benefit only if it is more likely than not that the tax position would be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at June 30, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

Note 7 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities occurred and that such changes could have materially affected the amounts reported in the statements of net assets available for benefits.

Note 8 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after June 30, 2023 through April 12, 2024, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
