## Independent Auditor's Report

To the Plan Administrator of the  
403(b) Thrift Plan for CW Resources, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C)*

We have performed audits of the financial statements of 403(b) Thrift Plan for CW Resources, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2023 and 2022, and for the year ended June 30, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### *Opinion*

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

#### Note 1 - Description of the Plan

The following description of the 403(b) Thrift Plan for CW Resources, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

#### General

The Plan is a 403(b) plan established effective July 1, 1993, and most recently amended with an effective date of April 1, 2022. Employees of CW Resources, Inc. (the "Company") immediately become eligible to participate in the Plan. Participants become eligible to receive the Company's matching and discretionary non-elective contributions upon attainment of age 21 and completion of one year of service, with a minimum of 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Investment Performance Advisory Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Participants may contribute to the Plan an amount of annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (the "IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans.

The Company makes matching contributions in an amount equal to 50% contributed by a participant, up to a maximum of 2% of the participant's Plan compensation. The Company may also make two discretionary contributions:

- An annual discretionary non-elective contribution to participants' accounts based upon a fixed contribution per participant. There was no contribution for the year ended June 30, 2023.
- Discretionary non-elective contributions equivalent to 2% of employees' gross wages were made for the year ended June 30, 2023.

Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and money market funds as investment options for participants. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions, Company matching and discretionary contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service, as defined. A participant becomes 20% vested after 2 years of service, 50% vested after 3 years of service, 75% vested after 4 years of service and 100% vested after 5 years of service. However, if an active

participant dies prior to the normal retirement age or becomes totally disabled, the participant's account becomes 100% vested.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, which is determined at the time of each individual loan application, was set at 2% above the prime rate, as defined. Principal and interest are paid ratably through weekly or bi-weekly payroll deductions.

#### **Payment of benefits**

Participants are entitled to receive the vested balance of their account if they retire, become fully disabled, die or terminate employment. A participant with a vested account balance may elect to receive either a lump-sum distribution equal to the value of the vested portion of their account or, if they are subject to lifetime required minimum distributions, a distribution in the form of an annuity. In the event that the vested balance of a terminated participant is less than \$5,000, the account balance will be transferred to an Individual Retirement Account on behalf of a participant who fails to elect a direct rollover or cash payment. Distributions are subject to the applicable provisions of the Plan agreement. A participant may also request a hardship or in-service withdrawal as provided for in the Plan document.

#### **Forfeited accounts**

Forfeitures result from non-vested Company contributions remaining in the Plan for terminated employees and may be used to reduce the cash contributions required from the Company or to pay Plan expenses. However, if a terminated participant becomes reemployed by the Company before incurring a five-year break in service, amounts will be restored to the participant's account. As of June 30, 2023 and 2022, forfeited non-vested accounts totaled \$139,496 and \$274,306, respectively. These accounts will be used to offset future employer contributions or to pay Plan expenses. Forfeitures in the amount of \$246,541 were used to offset employer contributions in fiscal year 2023.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The Plan's financial statements have been prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Performance Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2023 and 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants on March 7, 2024.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The remaining costs are paid by the Plan. For the year ended June 30, 2023, the Plan paid total costs of \$123,781. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses for certain funds are included in net appreciation in fair value of investments.

#### **Subsequent events**

The Plan has evaluated subsequent events through April 10, 2024, the date the financial statements were available to be issued.

### **Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and 2022.

#### Mutual funds and money market funds

Valued at the daily closing price as reported by the fund. The mutual funds and money market funds held by the Plan are open-end mutual funds and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of June 30, 2023 and 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### Note 4 - Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by Newport Trust Company. Newport Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### **Note 5 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions, if any, at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Company contribution portion of their account.

#### **Note 6 - Tax status**

The Plan has adopted a prototype plan document designed to qualify under Section 403(b) of the Internal Revenue Code ("IRC") via a non-standardized adoption agreement. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71 (or the draft Listing of Required Modifications issued April 4, 2009). The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

Effective October 1, 2021, the 403(b) volume submitter plan designed by Newport Group, Inc. was in place for the Plan. Newport Group, Inc. received an advisory letter from the IRS dated March 31, 2017 indicating that the 403(b) volume submitter plan satisfies the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2023 and 2022, and investment income for the year ended June 30, 2023 that are disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Newport Trust Company, the custodian of the Plan.

#### **Note 9 - Nonexempt transactions**

The Company had determined that nonexempt transactions occurred during the 2022 and 2023 plan years. The violations involved the submission of employee contributions and loan repayments to the Plan later than the earliest day on which such contributions could reasonably be segregated from the employer's general assets. The Company has taken corrective action for the nonexempt transactions during the 2022 Plan year on April 11, 2023. The Company is in the process of taking corrective actions for the nonexempt transactions during the 2023 plan year. Management believes that these transactions should not affect the tax-qualified status of the Plan; therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 10 - Subsequent events**

Effective January 1, 2024, the Plan was amended to allow CW Group, Inc. to take over as the Plan Sponsor and allowing CW Resources, Inc. (formerly, the Plan Sponsor) to continue participating in the Plan as a participating employer, to change the employer's taxpayer identification number, change the Plan name to 403(b) Thrift Plan for CW Group, Inc., and allow RW Solutions, Inc. to become a participating employer in the Plan.

Effective February 1, 2024, the Plan was amended to remove a participating employer. Accordingly, employees of CW Solutions, LLC, are no longer eligible to participate in the Plan.
