Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of HFRI, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following brief description of the HFRI, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan covering eligible employees (as defined in the plan agreement) of HFRI, LLC and its affiliate, Recovery Resources, LLC (together the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 3, 2023, the CorroHealth, Inc. 401(k) Profit Sharing Plan was amended and the Plan merged into the CorroHealth, Inc. 401(k) Profit Sharing Plan. Assets of the Plan were liquidated on Friday, June 30, 2023, and transferred to the CorroHealth, Inc. 401(k) Profit Sharing Plan on Monday, July 3, 2023.

Eligibility: Employees who attained the age of 21 and completed 3 months of service were eligible to participate in the Plan. An employee was credited for each month during which he or she performed at least 1 hour of service. Eligible employees entered the Plan on the first day of the month coinciding or immediately following meeting eligibility requirements. Employees who were nonresident aliens and residents of Puerto Rico were not eligible to participate in the Plan.

Contributions: Participants may have contributed up to 90 percent of annual compensation, as defined by the Plan, up to limits set by the Internal Revenue Code. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company provided a safe harbor matching contribution equal to 100 percent of participant's salary deferrals up to 3 percent of compensation, and then 50 percent of participant deferrals from 3 to 5 percent.

The Company may have made a discretionary profit-sharing employer contribution on behalf of eligible participants. Employees must have completed 500 hours of service and be employed on the last day of the Plan year in order to have participated in an allocation of the profit-sharing contribution. No profit-sharing contribution was made to the Plan during the period from January 1, 2023 through July 3, 2023. Contributions were subject to certain limitations.

Investment options: Upon enrollment in the Plan, a participant could direct contributions in a variety of investment choices as more fully described in the Plan's literature. Participants could change their investment options at any time.

Participant accounts: Each participant's account was credited with the participant's contribution, Company safe harbor matching contribution, Company profit-sharing contribution, if any, and Plan earnings/losses. Participant accounts were charged with an allocation of administrative expenses. Allocations were based on participants' earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting: Participants were immediately vested in their contributions, Company safe harbor matching contribution, plus actual earnings or losses thereon. Vesting in the Company's profit-sharing contribution portion of their accounts was based on years of continuous service. A participant was 100 percent vested after 6 years of credited services. Upon reaching normal retirement age, as defined by the Plan or if the participants terminated employment due to death or disability, they were 100 percent vested in their account balances.

Notes to Financial Statements

Note 1. Plan Description (continued)

Payments of benefits: On termination of service due to death, disability, or retirement, a participant could elect to receive a lump sum, installments over a period certain or partial withdrawal in an amount equal to the value of the participant's vested interest in his or her account. In addition, in-service and hardship withdrawals were permitted in certain situations as described in the plan agreement.

Forfeited accounts: At July 3, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$13, respectively. These accounts, if applicable, were permitted to be used to reduce Company contributions or to pay Plan expenses. During 2023, no amounts were used to reduce Company contributions or to pay Plan expenses.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) in fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through April 15, 2024, the date these financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including investments held at June 30, 2023 and December 31, 2022, and net appreciation/(depreciation) in fair value of investments and interest and dividends for the period from January 1, 2023 through June 30, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance) (the trustee of the Plan). There were no material changes between the certification date of Friday, June 30, 2023 and the financial statement date of Monday, July 3, 2023.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 3, 2023 and December 31, 2022.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Value based on the net asset value (NAV) of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 5. Related-Party and Party-in-Interest Transactions

Reliance Trust Company was the Trustee of the Plan, as defined by the Plan, and therefore transactions with Reliance Trust Company qualify as party-in-interest.

ADP Retirement Services (ADP) provided certain administrative services to the Plan. Transactions with ADP qualify as party-in-interest transactions.

ADP Strategic Plan Services, Inc. provided investment management services to the Plan. Transactions with ADP Strategic Plan Services, Inc. qualify as party-in-interest transactions.

Certain employees of the Company provided administrative services for the Plan and were not reimbursed for their services from the Plan.

Certain other administrative expenses were paid by the Company on behalf of the Plan. These amounts are not material to the financial statements.

Note 6. Tax Status

The Plan had adopted a pre-approved plan sponsored by ADP, LLC. The pre-approved plan had received a letter from the Internal Revenue Service, dated October 6, 2020, stating that the pre-approved plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan Administrator believes the Plan was designed and was operating in compliance with applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
