Part III – line 8(b)

In conjunction with the termination of the Inman Mills Pension Plan, the plan sponsor entered into an agreement with Mutual of Omaha for the purchase of a group annuity contract to settle liabilities owed to current retirees and plan participants who elected annuity payments in lieu of lump sum distributions. The original estimated cost of the annuity purchase was \$1,913,832.

Mutual of Omaha subsequently refined their annuity purchase price to \$1,841,113 in order to reflect demographic changes that were discovered when they received the data file. As a result, Mutual of Omaha issued a reimbursement to the trust for \$72,719 which was treated as a negative benefit payment on the 2022 Form 5500.

Subsequent to the annuity purchase, additional interest income came into the trust. However, since all benefit liabilities had been settled at that point, the employer withdrew the remaining funds in two transactions; one on 7/17/2023 for \$90,944.55 and another on 7/17/2023 for \$1,777.96.

Since there is no specific line item on the Form 5500-SF for reporting these withdrawal transactions, they have been included as negative amounts in the other income total on line 8(b).

Part VII – line 13(a)

Since the withdrawals described above arose from contributions made to the plan in order to fund the plan termination and from unanticipated receivable interest earnings, these amounts were returned to the employer, but they have been deemed to not be reversions and not subject to excise tax.
