Independent Auditor's Report

To the Board of Trustees
Hawai'i Pacific University:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Retirement Plan for the Faculty and Employees of Hawai'i Pacific University (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 15, 2023 and June 30, 2022 (liquidation basis), the related statement of changes in net assets available for benefits from the period July 1, 2022 to May 15, 2023 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 15, 2023 and June 30, 2022, and from the period July 1, 2022 to May 15, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter- Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of Hawaii Pacific University, the Plan's sponsor, voted on December 7, 2021 to terminate the Plan, and management determined liquidation was imminent. As a result, the liquidation basis of accounting was used in presenting the 2023 and 2022 financial statements and all the assets were liquidated as of May 15, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

May 15, 2023 and June 30, 2022 (Liquidation Basis)

1. Description of Plan

The following description of the Retirement Plan for the Faculty and Employees of Hawaii Pacific University (the Plan) provides only general information. Participants should refer to the Summary Plan Description and Plan Document for a more complete description of the Plan's provisions.

a. General

Effective July 1, 2019, the Plan was a non-contributory profit sharing defined contribution plan covering substantially all employees of Hawai'i Pacific University (the University) who have at least one year of service and are age twenty-one or older. Prior to July 1, 2019 the Plan was structured as a money purchase defined contribution plan.

The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 7, 2021, the Board of Directors of the University adopted a resolution to terminate the Plan effective June 30, 2022 (the Termination Date). Participants in the Plan as of June 30, 2022 shall be 100% vested in their accrued benefits earned to date. In accordance with the notice of termination sent to all participants dated April 27, 2022, the accrued benefits of each participant shall be distributed in a lump sum payment in cash or in kind to the participant or lump sum direct rollover to an eligible retirement plan on behalf of the participant. Liquidation of the Plan assets was completed as of May 15, 2023 (see Note 5 regarding Plan Termination).

b. Contributions

Effective July 1, 2019, the University made discretionary contributions as determined annually by the Board of Directors. Prior to July 1, 2019, the University contributed to the Plan an amount equal to 6% of the compensation paid to eligible employees paid on a quarterly basis. Contributions were made annually and met funding requirements under ERISA. No discretionary contributions were made from the period July 1, 2022 to May 15, 2023 and for the year ended June 30, 2022.

b. Contributions (continued)

Participants could allocate the University's contributions in whole or in part towards the purchase of fixed annuity contracts, variable annuity and mutual fund accounts. The accounts of participants who do not make such an allocation were automatically invested in the College Retirement Equities Fund (CREF) Institutional Lifecycle Funds until allocation instructions were received. Participants had the opportunity to change allocations at any time.

c. Participants' Accounts

Each participant's account was credited with contributions and Plan earnings. The amount of the University's contribution credited to the account was based on the participant's compensation and increased the number of accumulation units within the participant's account. Capital appreciation (depreciation) and net investment income reflected in the value of an accumulation unit were allocated to each account based on the number of accumulation units in the account. Forfeited balances of terminated participants' non-vested accounts were used to reduce future University contributions. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

d. Vesting

As a result of the decision to terminate the Plan during the year ended June 30, 2022, all participants as of June 30, 2022 became fully vested in their account balances.

e. Payment of Benefits

Upon separation of service, a vested participant whose vested account balance is \$1,000 or less may automatically receive a lump sum amount equal to the value of his or her account, unless a direct rollover is elected. A participant whose vested account balance exceeds \$1,000 but is less than \$5,000, may elect to receive a distribution or a direct rollover. If neither is elected by the participant, the account balance will automatically be transferred to an IRA in the participant's name that is held by an IRA custodian selected by the University. IRA custodian fees will be charged directly to the IRA account. A participant whose vested account balance exceeds \$5,000, the participant will begin receiving payment of their benefit as of the date elected by the participant. However, if no date is elected, the participant is required per the IRS to begin payments from their account no later than the first day of April of the calendar year following the later of (i) the calendar year in which you reach age 72 or (ii) the calendar year in which you retire.

e. Payment of Benefits (continued)

Distributions pursuant to the Plan termination will be paid at the participants' election by (a) cash distribution of the present value of the participant's accrued benefit or (b) rollover distribution to an eligible retirement plan (including the Hawaii Pacific University 403(b) Retirement Plan).

f. Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the University, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular fund to which the expenses relate. All other administrative expenses are paid by the University.

The 2022 financial statements include approximately \$68,000 of accrued administrative costs related to expenses the Plan expects to incur through the final liquidation.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

Due to the decision to terminate the Plan during the year ended June 30, 2022, management determined that liquidation of the Plan was imminent and the financial statements for 2023 and 2022 have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). This includes the accrual of estimated expenses expected to be incurred through the date of liquidation.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully-benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

b. Investment Valuation and Income Recognition

There were no investments remaining at May 15, 2023.

Investments at June 30, 2022, are reported at liquidation value due to the Plan termination discussed in Note 1. For all investments, fair value approximates the amount the Plan expects to collect at liquidation.

Investments at June 30, 2022, are reported at fair value except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest and dividend income are recorded on a cash basis. Net appreciation or depreciation in fair value of investments includes the gains and losses on investments purchased and sold as well as held during the period.

c. Payment of Benefits

Benefits are recorded when paid.

d. Concentrations of Market and Credit Risk

The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments. The Plan's concentrations of credit risk and market risk are dictated by the Plan's provisions as well as those of ERISA and the participants' investment preference. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in risks in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

e. Subsequent Events

Subsequent events have been evaluated through April 12, 2024, the date these financial statements were available to be issued.

f. Use of Estimates

The preparation of financial statements in conformity with the liquidation basis of accounting requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. These estimates include the accrual of estimated expenses expected to be incurred through the date of liquidation. Actual results could differ from those estimates.

g. Forfeiture Account

The Plan's trustee holds a forfeiture account on behalf of the Plan Sponsor for contributions made for terminated non-vested employees. These amounts are used to pay Plan administrative expenses. As of June 30, 2022, the forfeiture balance was approximately \$123,000, and is included in the Teachers Insurance and Annuity Association – benefit responsive annuity contracts on the accompanying statements of net assets available for benefits.

In connection with the final liquidation of Plan assets, approximately \$126,000 of remaining forfeitures were reverted back to the University and shown as reversion of forfeitures back to Plan Sponsor in the accompanying statement of changes in net assets available for benefits from the period July 1, 2022 to May 15, 2023.

3. Investments

TIAA, FSB (TIAA), a federal savings association, the trustee of the Plan, held the Plan's investments and executed all investment transactions. All investment information disclosed in the accompanying financial statements, including investments held at May 15, 2023 and June 30, 2022 and net appreciation or depreciation in fair value of investments and interest and dividend income from the period July 1, 2022 to May 15, 2023, was obtained from TIAA-CREF, as agent for TIAA, and was certified by the agent as complete and accurate. There were no investments in the Plan as of May 15, 2023. Investments at June 30, 2022, are reported at liquidation value due to the Plan termination discussed in Note 1 and 5.

4. Fair Value Measurements

Fair value is defined as an exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement that should be determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, a three-tier fair value hierarchy was established, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets for identical assets or liabilities;
- Level 2 – Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term for the assets or liabilities; and
- Level 3 – Unobservable inputs in which there are little or no market data and are significant to the fair value of the assets or liabilities.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In accordance with ASC Topic 820-10, certain investments that are measured at net asset value and contract value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in the previous tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

The Plan has classified its mutual fund investments as Level 1 within the fair value hierarchy. These securities are valued using observable inputs in active markets for identical securities.

The Plan has classified its variable annuities as Level 2 within the fair value hierarchy. Variable annuities are valued using the market approach based on inputs observable in active markets for similar assets.

The Plan has classified its non-benefit responsive annuity contracts as Level 3. Non-benefit responsive annuity contracts are reported at fair value based on the income approach using crediting rates that represent a rate of return that compensates plan participants for bearing the risks inherent in the contracts, including liquidity risk.

4. Fair Value Measurements (continued)

The real estate account is a pooled separate account that invests primarily in income-producing real estate. There are currently no redemption restrictions or unfunded commitments on the real estate account investment. The fair value of the real estate account has been estimated using the net asset value per share as a practical expedient.

The Teachers Insurance and Annuity Retirement Annuity (TIAA RA) is a portfolio of traditional investment contracts in mortgages, publicly traded bonds, direct loans to business and industry, and real estate. Certain contracts within the TIAA RA portfolio have no liquidity restrictions and therefore meet the fully-benefit responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The liquidation value and fair value of the TIAA RA approximates contract value as determined by TIAA.

TIAA guarantees the monies invested in the TIAA RA contracts as to principal and interest. Benefit payments to participants or their beneficiaries are made directly by TIAA. The interest rate is guaranteed and is subject to change by TIAA upon three months notice to participants. When changed, the new rate applies only to contributions received from the date of change. In addition to the guaranteed interest rate, the TIAA Board of Trustees may declare dividends which can vary from year to year. The guaranteed interest rate for premiums applied in 2022 was 3%.

The Plan's ability to receive amounts due in accordance with fully-benefit responsive investment contracts is dependent on TIAA's ability to meet its financial obligations. Certain events might limit the ability of the Plan to transact at contract value with TIAA, including the Plan's failure to qualify under Section 401 of the Code; premature termination of contracts; plan termination; or other Plan Sponsor events. Contracts within the TIAA RA portfolio which have liquidity restrictions are considered non-benefit responsive and are valued at fair value, which approximates contract value.

5. Plan Termination

As discussed in Note 1, the Board of Directors of the University at their December 7, 2021 meeting resolved that the Plan be terminated effective June 30, 2022. A notice of termination was sent to participants on April 27, 2022. As a result of the Plan termination, participants as of June 30, 2022 became 100% vested in their accrued benefits earned to date. The accrued benefits of each participant were distributed in a lump sum payment in cash or in kind to the participant or lump sum direct rollover to an eligible retirement plan on behalf of the participant following the required notifications to and consent of the participant. As of May 15, 2023, all assets were distributed out of the Plan and the liquidation has been completed.

6. Income Tax Status

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2014, stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code (Code), and therefore, the related trust is tax exempt. In accordance with Revenue Procedures 2012-6 and 2011-49, the Plan Sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator has indicated that the Plan will take whatever actions necessary, if any, to maintain the Plan's operations in compliance with the Code.

The liquidation basis of accounting require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 15, 2023 and June 30, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any tax periods.

7. Exempt Party-in-Interest Transactions

Fees paid by the University for recordkeeping and other administrative services rendered by TIAA-CREF were based on customary and reasonable rates for such services, and as such are considered exempt party-in-interest transactions.

8. Operational Failure in Processing Required Minimum Distributions

The University was notified by TIAA that certain participant required minimum distributions were not processed in accordance with the Plan Document for the Plan year's 2016 through 2019. In May 2020, TIAA submitted an application under the Voluntary Compliance Program, a component program of the IRS' Employee Plans Compliance Resolution System, to correct Plan failures related to the required minimum distribution requirements of the Internal Revenue Code. TIAA and the IRS reached an agreement on August 3, 2021. The University decided not to opt out of the program. Management does not believe this will have a material financial impact to the Plan.
