## Independent Auditors' Report

### The Plan Administrator Dimex, LLC Retirement Savings Plan

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements*

We have performed audits of the accompanying financial statements of Dimex, LLC Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of April 11, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to April 11, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 11, 2023 and December 31, 2022 and for the period from January 1, 2023 to April 11, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Transfer of Assets**

As stated in Note 1 to the financial statements, in April of 2023, the Plan transferred all of its assets into the Westlake Savings Plan. As a result of this transfer, the Plan ceased to exist.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **1. Plan Description**

The following description of the Dimex, LLC Retirement Savings Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan was a defined contribution plan covering substantially all employees (as defined in the Plan document) of Dimex, LLC (the “Company”). The Plan was administered by a third party and qualified under section 401(k) of the Internal Revenue Code (“IRC”) and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In 2021, the Company was sold to Westlake Management Services, Inc. The Plan ceased to exist after April 11, 2023. Effective January 10, 2023, substantially all of the Plan’s assets were merged into the Westlake Savings Plan and any remaining assets merged on April 11, 2023 into the Westlake Savings Plan.

#### ***Eligibility***

An employee of the Company automatically became an eligible participant in the Plan upon attainment of age 18 and completion of 6 months or 1,000 hours of service. Participants entered the Plan the first day of the payroll period coinciding with or next following the date on which an employee met the eligibility requirements, or as soon as administratively feasible thereafter.

#### ***Contributions***

Participants were automatically enrolled into the Plan at a contribution rate of 3%. An employee participating in the Plan could annually contribute through payroll deductions, up to the amount provided annually by the Internal Revenue Service (“IRS”) and could contribute amounts representing distributions from other qualified plans. Any participant, age 50 or over, could make an additional “catch-up” contribution. For 2023, there were no participant contributions made to the Plan.

Safe harbor matching contributions were made on behalf of participants in an amount equal to 100% of the amount of the eligible participant’s elective deferrals (including catch-up contributions) that did not exceed 3% of the participant’s compensation and 50% of the amount of the participant’s elective deferrals that exceeded 3% of the participant’s compensation but that did not exceed 5% of the participant’s compensation. In no event could the matching contribution exceed 4% of the participant’s compensation. For 2023, there were no safe harbor matching contributions made to the Plan.

### **1. Plan Description (*continued*)**

#### ***Participant Accounts***

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's matching contribution, (b) Plan earnings and (losses) and (c) account maintenance and service fees. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### ***Vesting***

Participants were 100% vested in their contributions, rollover contributions, the Company's safe harbor matching contributions made to the Plan and any earnings thereon.

#### ***Investment Options***

Upon enrollment in the Plan, participants could direct their elective contribution and Company contribution into the various investment options offered by the Plan. Participants could change their investment options at any time.

#### ***Notes Receivable from Participants***

Participants could borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Only one loan per participant was able to be outstanding at any given time. Principal and interest was paid ratably through payroll deductions.

If a participant failed to make a payment when a loan was due under the terms of the loan, that participant would be in default. The participant would have the opportunity to repay the loan, resume current status of the loan by paying any missed payment plus interest or, if distribution was available under the Plan, request distribution of the note. If the loan remained in default, the plan administrator had the option of foreclosing on any other security it holds or, to the extent a distribution to the participant was permissible under the Plan, to offset the participant's account balance by the outstanding balance of the loan.

#### ***Payment of Benefits***

Distributions payable as a result of termination for reasons other than death, disability or retirement were paid as soon as administratively feasible following the date on which a distribution was requested. Payments were in the form of a lump sum or installment payments, which could not be less than \$100. Hardship distributions were permitted under the Plan.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which required management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan followed U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based on the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2022, all of the Plan’s investments were valued using Level 1 inputs and were comprised of registered investment companies.

#### ***Investment Valuation and Income Recognition***

Investments in registered investment companies held by the Plan were valued at fair value based on the daily closing price as reported by the funds. All of the investments in registered investment companies were open-ended and registered with the Securities and Exchange Commission. These funds were required to publish their daily Net Asset Value and to transact at that price. The investments in registered investment companies held by the Plan were deemed to be actively traded.

Purchases and sales of investments were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan’s gains and losses on investments bought and sold during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

#### ***Payment of Benefits***

Benefits were recorded when paid.

### **2. Summary of Significant Accounting Policies *(continued)***

#### ***Administrative Expenses***

Certain administrative expenses of the Plan were paid by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 2, 2024.

### **3. Information Certified *(Unaudited)***

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at April 11, 2023 and December 31, 2022, and net appreciation in fair value of investments, and interest and dividends for the period from January 1, 2023 to April 11, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by American Trust Company, the trustee of the Plan, a qualified institution.

### **4. Party-In-Interest Transactions**

American Trust Company was the trustee and record-keeper for the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who were active employees of the Plan could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants on the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, performed administrative services to the Plan at no cost to the Plan.

### **5. Tax Status**

The Company had adopted a volume submitter prototype plan document which received an IRS opinion letter dated June 30, 2020, which indicated that the Plan was designed in accordance with applicable sections of the IRC. The Plan had been amended since receiving the letter; however, the plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan was subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
